After consideration on the merits, the Committee recommends the following:

SB09-108 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 14, line 24, strike "SUBPARAGRAPH (IV)" and  
2 substitute "SUBPARAGRAPHS (IV) AND (V)".

3 Page 16, after line 8, insert the following:

4 "(V) THE AMOUNT OF THE ROAD SAFETY SURCHARGE IMPOSED  
5 PURSUANT TO THIS PARAGRAPH (a) SHALL BE ONE-HALF OF THE AMOUNT  
6 SPECIFIED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH (a) FOR ANY VEHICLE  
7 THAT IS A TRUCK OR TRUCK TRACTOR THAT IS OWNED BY A FARMER OR  
8 RANCHER AND IS USED COMMERCIALY ONLY:

9 (A) TO TRANSPORT TO MARKET OR PLACE OF STORAGE RAW  
10 AGRICULTURAL PRODUCTS ACTUALLY PRODUCED OR LIVESTOCK  
11 ACTUALLY RAISED BY THE FARMER OR RANCHER IN FARMING OR  
12 RANCHING OPERATIONS; OR

13 (B) TO TRANSPORT COMMODITIES OR LIVESTOCK PURCHASED BY  
14 THE FARMER OR RANCHER FOR PERSONAL USE IN THE FARMER'S OR  
15 RANCHER'S FARMING OR RANCHING OPERATIONS."

16 Renumber succeeding subparagraph accordingly.

17 Page 27, line 8, strike "AND (VI)" and substitute "(VI), AND (VII)".

1 Page 29, after line 6, insert the following:

2 "(VII) THE AMOUNT OF ANY BRIDGE SAFETY SURCHARGE IMPOSED  
3 PURSUANT TO THIS PARAGRAPH (g) SHALL BE ONE-HALF OF THE AMOUNT  
4 OF THE SURCHARGE IMPOSED PURSUANT TO SUBPARAGRAPH (I) OF THIS  
5 PARAGRAPH (g) FOR ANY VEHICLE THAT IS A TRUCK OR TRUCK TRACTOR  
6 THAT IS OWNED BY A FARMER OR RANCHER AND IS USED COMMERCIALY  
7 ONLY:

8 (A) TO TRANSPORT TO MARKET OR PLACE OF STORAGE RAW  
9 AGRICULTURAL PRODUCTS ACTUALLY PRODUCED OR LIVESTOCK  
10 ACTUALLY RAISED BY THE FARMER OR RANCHER IN FARMING OR  
11 RANCHING OPERATIONS; OR

12 (B) TO TRANSPORT COMMODITIES OR LIVESTOCK PURCHASED BY  
13 THE FARMER OR RANCHER FOR PERSONAL USE IN THE FARMER'S OR  
14 RANCHER'S FARMING OR RANCHING OPERATIONS."

15 Renumber succeeding subparagraph accordingly.
