**A BILL FOR AN ACT**

101     **CONCERNING THE ADDITION OF THE DIVISION OF WATER RESOURCES**  
102             **IN THE DEPARTMENT OF NATURAL RESOURCES TO THE LIST OF**  
103             **ENTITIES ELIGIBLE TO RECEIVE FIRST TIER FUNDING FROM THE**  
104             **OPERATIONAL ACCOUNT OF THE SEVERANCE TAX TRUST FUND,**  
105             **AND, IN CONNECTION THEREWITH, MODIFYING APPROPRIATIONS**  
106             **MADE TO THE DIVISION OF WATER RESOURCES IN THE GENERAL**  
107             **APPROPRIATION ACTS FOR THE 2008-09 AND 2009-10 FISCAL**  
108             **YEARS.**

Adds the division of water resources in the department of natural resources to the list of entities eligible to receive first tier funding from the operational account of the severance tax trust fund by reducing the maximum percentage that may be allocated to the division of reclamation, mining, and safety.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** 39-29-109.3 (1), Colorado Revised Statutes, is  
3 amended to read:

4           **39-29-109.3. Operational account of the severance tax trust**  
5 **fund - repeal.** (1) For fiscal years commencing on and after July 1,  
6 1997, the executive director of the department of natural resources shall  
7 submit with the department's budget request for each fiscal year a list and  
8 description of the programs the executive director recommends to be  
9 funded from the operational account of the severance tax trust fund  
10 created in section 39-29-109 (2) (b), referred to in this section as the  
11 "operational account". The minerals, energy, and geology policy advisory  
12 board established pursuant to section 34-20-104, C.R.S., shall review the  
13 executive director's recommendation before submittal. The general  
14 assembly may appropriate moneys from the total moneys available in the  
15 operational account to fund recommended programs as follows:

16           (a) (I) For programs or projects within the Colorado oil and gas  
17 conservation commission, ~~up to forty-five percent of the moneys in the~~  
18 ~~operational account for fiscal years commencing before July 1, 2008, and~~  
19 up to forty percent of the moneys in the operational account. ~~for fiscal~~  
20 ~~years commencing on or after July 1, 2008.~~

21           (II) Moneys appropriated for programs or projects pursuant to  
22 subparagraph (I) of this paragraph (a) shall be used by the Colorado oil

1 and gas conservation commission for plugging and abandonment projects,  
2 for well-site location reclamation projects, or for regulatory and  
3 environmental programs or projects as specifically appropriated by the  
4 general assembly for use on such programs or projects; except that, if the  
5 commission determines that an emergency exists, the commission may  
6 expend any moneys received for the emergency without any further  
7 appropriation. In determining the uses of these moneys, the commission  
8 shall give priority to uses that reduce industry fees and mill levies.

9 (b) For programs within the Colorado geological survey, up to  
10 twenty percent of the moneys in the operational account;

11 (c) For programs within the division of reclamation, mining, and  
12 safety, ~~up to thirty percent of the moneys in the operational account for~~  
13 ~~fiscal years commencing before July 1, 2008, and up to twenty-five~~  
14 ~~TWENTY~~ percent of the moneys in the operational account. ~~for fiscal years~~  
15 ~~commencing on or after July 1, 2008.~~ As part of any appropriation made,  
16 five hundred thousand dollars, or so much as may be available, shall be  
17 transferred to the abandoned mine reclamation fund created in section  
18 34-34-102 (1), C.R.S.

19 (d) For programs within the Colorado water conservation board  
20 and for purposes authorized by article 75 of title 37, C.R.S., up to five  
21 percent of the moneys in the operational account;

22 (e) ~~For fiscal years commencing on or after July 1, 2008, only,~~ For  
23 programs within the division of wildlife that monitor, manage, or mitigate  
24 the impacts of mineral or mineral fuel production activities on wildlife in  
25 any region of the state in which production activity is occurring or, from  
26 any location in the state, research such impacts, up to five percent of the  
27 moneys in the operational account, which moneys shall not supplant

1 moneys that would otherwise be made available for such programs;  
2 (f) ~~For fiscal years commencing on or after July 1, 2008, only,~~ For  
3 programs within the division of parks and outdoor recreation that operate,  
4 maintain, or improve state parks in any region of the state in which  
5 production activity is occurring, up to five percent of the moneys in the  
6 operational account, which moneys shall not supplant moneys that would  
7 otherwise be made available for such programs;

8 (g) FOR PROGRAMS WITHIN THE DIVISION OF WATER RESOURCES,  
9 UP TO FIVE PERCENT OF THE MONEYS IN THE OPERATIONAL ACCOUNT.

10 **SECTION 2.** Part XIV (8) and the affected totals of section 2 of  
11 chapter 474, Session Laws of Colorado 2008, are amended to read:

1                   **SECTION 3. Appropriation - adjustments in 2009 long bill.**

2           (1) (a) In addition to any other appropriation, there is hereby  
3 appropriated, to the department of natural resources, executive director's  
4 office, for personal services, for the fiscal year beginning July 1, 2009,  
5 one hundred twenty-six thousand five hundred sixty-six dollars  
6 (\$126,566) reappropriated funds. Said sum shall be from statewide and  
7 departmental indirect cost recoveries.

8           (b) In addition to any other appropriation, there is hereby  
9 appropriated, to the department of natural resources, water resources  
10 division, for personal services, for the fiscal year beginning July 1, 2009,  
11 two million seventy-four thousand eight hundred forty-five dollars  
12 (\$2,074,845) cash funds. Said sum shall be from the operational account  
13 of the severance tax trust fund established pursuant to section 39-29-109  
14 (2) (b), Colorado Revised Statutes.

15           (c) In addition to any other appropriation, there is hereby  
16 appropriated, to the department of natural resources, water resources  
17 division, for operating expenses, for the fiscal year beginning July 1,  
18 2009, two hundred ninety-two thousand three hundred nineteen dollars  
19 (\$292,319) cash funds. Said sum shall be from the operational account  
20 of the severance tax trust fund established pursuant to section 39-29-109  
21 (2) (b), Colorado Revised Statutes.

22           (d) In addition to any other appropriation, there is hereby  
23 appropriated, to the department of natural resources, water resources  
24 division, for indirect cost assessment, for the fiscal year beginning July  
25 1, 2009, one hundred twenty-six thousand five hundred sixty-six dollars  
26 (\$126,566) cash funds. Said sum shall be from the operational account

1 of the severance tax trust fund established pursuant to section 39-29-109  
2 (2) (b), Colorado Revised Statutes.

3 (2) For the implementation of this act, appropriations made in the  
4 annual general appropriation act for the fiscal year beginning July 1,  
5 2009, shall be adjusted as follows:

6 (a) The appropriation to the department of natural resources,  
7 executive director's office, for personal services, is decreased by one  
8 hundred twenty-six thousand five hundred sixty-six dollars (\$126,566).  
9 Said sum shall be from the general fund.

10 (b) The appropriation to the department of natural resources,  
11 water resources division, for personal services, is decreased by one  
12 million nine hundred fifty-six thousand two hundred ninety dollars  
13 (\$1,956,290). Said sum shall be from the general fund.

14 (c) The appropriation to the department of natural resources, water  
15 resources division, for operating expenses, is decreased by two hundred  
16 ninety-two thousand three hundred nineteen dollars (\$292,319). Said sum  
17 shall be from the general fund.

18 **SECTION 4. Safety clause.** The general assembly hereby finds,  
19 determines, and declares that this act is necessary for the immediate  
20 preservation of the public peace, health, and safety.
