After consideration on the merits, the Committee recommends the following:

SB09-226 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 6, strike "2007," and substitute "2002,".

2 Page 4, after line 17, insert the following:

3           "(2) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE  
4 REQUIRES, "APPROPRIATE STAFF" MEANS EMPLOYEES OF A SCHOOL WHOM  
5 THE PRINCIPAL OR EQUIVALENT EXECUTIVE IN CONSULTATION WITH THE  
6 SCHOOL NURSE OF THE SCHOOL DETERMINES TO BE APPROPRIATE  
7 RECIPIENTS OF EMERGENCY ANAPHYLAXIS TREATMENT TRAINING, WHICH  
8 EMPLOYEES SHALL INCLUDE, BUT NEED NOT BE LIMITED TO, THE  
9 FOLLOWING:

10           (a) EMPLOYEES WHO ARE MEMBERS OF A SCHOOL EMERGENCY  
11 MEDICAL RESPONSE TEAM;

12           (b) EMPLOYEES WHO ARE CHARGED WITH THE SUPERVISION OF A  
13 CAFETERIA OR OTHER COMMON AREA THAT IS ROUTINELY USED BY  
14 STUDENTS FOR DINING DURING MEAL TIMES; AND

15           (c) TEACHERS WHO TEACH AT LEAST ONE COURSE IN WHICH A  
16 STUDENT WHO IS KNOWN TO HAVE A FOOD ALLERGY IS ENROLLED."

17 Renumber succeeding subsection accordingly.

1 Page 6, strike lines 4 through 12 and substitute the following:

2 "(F) THE NAMES AND TELEPHONE NUMBERS OF PERSONS WHOM  
3 THE SCHOOL SHOULD CONTACT IN ADDITION TO EMERGENCY MEDICAL  
4 PERSONNEL IN THE EVENT THAT THE STUDENT SUFFERS AN ALLERGIC  
5 REACTION TO FOOD; AND

6 (G) AN ASSESSMENT OF THE STUDENT'S READINESS TO CARRY AND  
7 POTENTIALLY SELF-ADMINISTER SELF-INJECTABLE EPINEPHRINE OR OTHER  
8 MEDICATION PRESCRIBED FOR THE STUDENT IN THE EVENT THAT THE  
9 STUDENT SUFFERS AN ALLERGIC REACTION TO FOOD, WHICH ASSESSMENT  
10 SHALL BE SIGNED BY A PHYSICIAN AND THE STUDENT'S PARENT OR LEGAL  
11 GUARDIAN. A WRITTEN MEDICAL AUTHORIZATION SUBMITTED TO THE  
12 SCHOOL'S ADMINISTRATION BY THE STUDENT'S PARENT OR LEGAL  
13 GUARDIAN PURSUANT TO SECTION 22-1-119.5 (2) (b) (IV) (A) SHALL  
14 SUFFICE FOR THE PURPOSES OF THIS SUB-SUBPARAGRAPH (G).";

15 line 23, strike "ALL FACULTY AND ADMINISTRATIVE" and substitute  
16 "APPROPRIATE".

17 Page 7, line 16, strike "(1)";

18 strike lines 26 and 27.

19 Page 8, strike lines 1 through 11;

20 line 15, strike "(1)";

21 strike lines 25 through 27.

22 Page 9, strike lines 1 through 9.

23 Page 10, line 1, strike "22-2-135 (2)" and substitute "22-2-135 (3) (a)  
24 (III), C.R.S.";

25 strike line 2.
