HB14-1159 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend the Agriculture, Livestock, & Natural Resources Committee
- 2 Report, dated January 27, 2014, page 1, before line 1 insert:
- 3 "Amend printed bill, page 2, line 5, strike "**definitions.** (1) (c)" and
- 4 substitute "**definitions - repeal.** (1) (c) (I)".
- 5 Page 2, after line 10 insert:
- 6 "(II) THIS PARAGRAPH (c) IS REPEALED, EFFECTIVE JULY 1, 2019.".
- 7 Page 2, line 12, after "(a)" insert "(I)".
- 8 Page 3, line 4, strike "(I)" and substitute "(A)".
- 9 Page 3, line 10, strike "(II)" and substitute "(B)".
- 10 Page 3, line 16, strike "(III)" and substitute "(C)".
- 11 Page 3, after line 20 insert:
- 12 "(II) THIS PARAGRAPH (a) IS REPEALED, EFFECTIVE JULY 1, 2019.".
- 13 Page 4, line 14, strike "**proposals.**" and substitute "**proposals - repeal.**".".

- 1 Page 1 of the report, line 1, strike "Amend printed bill, page" and
2 substitute "Page".
- 3 Page 1 of the report, strike line 2 and substitute "'C.R.S. THIS
4 SUB-SUBPARAGRAPH (M) IS REPEALED, EFFECTIVE JULY 1, 2019.'".
- 5 Page 1 of the report, after line 3 insert:
- 6 "Page 5, lines 10 and 11, strike "**amend** (1) introductory portion" and
7 substitute "**add** (1.5)".
- 8 Page 5, line 12, strike "**proposals.**" and substitute "**proposals - repeal.**".
- 9 Page 5, strike lines 13 through 27.
- 10 Page 6, strike lines 1 through 11 and substitute:
- 11 "(1.5) (a) THE USE TAX ORDINANCE, RESOLUTION, OR PROPOSAL OF
12 ANY TOWN, CITY, OR COUNTY ADOPTED PURSUANT TO THIS ARTICLE MAY
13 RECITE THAT THE USE TAX DOES NOT APPLY TO THE STORAGE AND USE OF
14 COMPONENTS USED IN BIOGAS PRODUCTION SYSTEMS, AS EXEMPTED FROM
15 THE STATE USE TAX PURSUANT TO SECTION 39-26-724 (1) (c), C.R.S.
16 (b) THIS SUBSECTION (1.5) IS REPEALED, EFFECTIVE JULY 1,
17 2019.'".
