Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB07-001 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend Health and Human Services Committee Report, dated January 17,
- 2 2007, page 1, strike lines 5 through 7.

- 3 line 8, strike "(2)" and substitute ""(1)".

- 4 Page 2, strike lines 11 through 14 and substitute the following:

- 5 ""BENOT MORE THAN THE LOWEST PRICE THAT THE MANUFACTURER SELLS
- 6 THE DRUG FOR DISTRIBUTION IN COLORADO, LESS ANY SUPPLEMENTAL
- 7 REBATES OR DISCOUNTS, PLUS A";".

- 8 Page 3, line 12, strike "COLORADO" and substitute ""COLORADO" and
- 9 strike "ACT" and substitute "ACT"";

- 10 line 15, strike "Section";

- 11 strike lines 17 through 19 and substitute the following:

- 12 **"24-34-104. General assembly review of regulatory agencies**
- 13 **and functions for termination, continuation, or reestablishment.**
- 14 (43.5) THE FOLLOWING AGENCIES, FUNCTIONS, OR BOTH, SHALL
- 15 TERMINATE ON JUNE 30, 2013: THE "COLORADO CARES RX ACT",
- 16 CREATED BY ARTICLE 2.5 OF TITLE 25.5, C.R.S.

1 **SECTION 2. Appropriation.** (1) In addition to any other
2 appropriation, there is hereby appropriated, out of any moneys in the
3 general fund not otherwise appropriated, to the department of health care
4 policy and financing, for allocation to the executive director's office, for
5 the fiscal year beginning July 1, 2006, the sum of one hundred forty-five
6 thousand nine hundred twenty-seven dollars (\$145,927), or so much
7 thereof as may be necessary, for the implementation of this act.

8 (2) In addition to any other appropriation, there is hereby
9 appropriated, out of any moneys in the Colorado cares RX program cash
10 fund created in section 25.5-2.5-105 (1), Colorado Revised Statutes, not
11 otherwise appropriated, to the department of health care policy and
12 financing, for allocation to the executive director's office, for the fiscal
13 year beginning July 1, 2007, the sum of two million two hundred fifty-
14 three thousand nine hundred fifty-three dollars (\$2,253,953) and 2.5 FTE,
15 or so much thereof as may be necessary, for the implementation of this
16 act."

17 Page 3, after line 20, insert the following:

18 "Page 1, line 102, strike "**PROGRAM.**" and substitute "**PROGRAM, AND**
19 **MAKING AN APPROPRIATION THEREFOR.**".".
