Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB07-1094 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, strike lines 2 through 18.
- 2 Renumber succeeding sections accordingly.
- 3 Page 3, strike lines 17 through 27.
- 4 Strike pages 4 through 17.
- 5 Page 18, strike lines 1 and 2.
- 6 Renumber succeeding sections accordingly.
- 7 Page 18, line 3, strike "In" and substitute "(1) In";
- 8 line 8, strike "of ____ dollars (\$) and ____ FTE," and substitute "of one
- 9 hundred seven thousand three hundred six dollars (\$107,306) and 2.0
- 10 FTE,";
- 11 after line 9, insert the following:
- 12 "(2) In addition to any other appropriation, there is hereby
- 13 appropriated, out of any moneys in the general fund not otherwise
- 14 appropriated, to the department of public safety, Colorado bureau of
- 15 investigation, for the fiscal year beginning July 1, 2007, the sum of

1 sixty-seven thousand eight hundred twenty-two dollars (\$67,822) and 1.0
2 FTE, or so much thereof as may be necessary, for the implementation of
3 H.B. 07-1272.

4 (3) In addition to any other appropriation, there is hereby
5 appropriated, out of any moneys in the general fund not otherwise
6 appropriated, to the department of public safety, for allocation to forensic
7 and chemical labs in the Colorado bureau of investigation, for the fiscal
8 year beginning July 1, 2007, the sum of one hundred seventy-five
9 thousand one hundred twenty-eight dollars and fifty cents (\$175,128) and
10 2.0 FTE, or so much thereof as may be necessary, for the implementation
11 of this act.

12 **SECTION 3. Adjustment to the 2007 long bill.** For the
13 implementation of this act, the appropriation made in the annual
14 appropriation act for the fiscal year beginning in July 1, 2007, to the
15 department of law, criminal justice and appellate section, capital crimes
16 prosecution unit, from the general fund, is decreased by one hundred
17 seventy-five thousand one hundred twenty-eight dollars (\$175,128) and
18 2.0 FTE.

19 **SECTION 4. Effective date.** (1) Except as otherwise provided
20 in subsections (2) and (3) of this section, this act shall take effect upon
21 passage.

22 (2) Subsections (1) and (2) of section 2 of this act shall only take
23 effect if HB07-1272 is enacted at the first regular session of the
24 sixty-sixth general assembly and becomes law.

25 (3) Subsection (3) of section 2 of this act shall only take effect if
26 HB07-1272 is not enacted at the first regular session of the sixty-sixth
27 general assembly."
