Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB07-203 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 18, line 2, strike "part 9." and substitute "part 9
2 AND SECTION 38-40-105, C.R.S.";

3 line 7, after "part 9", insert "AND SECTION 38-40-105, C.R.S.",.

4 Page 22, before line 7, insert the following:

5 **"SECTION 16. Appropriation.** In addition to any other
6 appropriation, there is hereby appropriated, out of any moneys in the
7 mortgage broker registration cash fund created in Section 12-61-908 (2),
8 Colorado Revised Statutes, not otherwise appropriated, to the department
9 of regulatory agencies, for the fiscal year beginning July 1, 2007, the sum
10 of four hundred twenty-two thousand four hundred sixty-three dollars
11 (\$422,463), cash funds, and 1.8 FTE, or so much thereof as may be
12 necessary, for the implementation of this act. Of said sum, fifty-nine
13 thousand two hundred ninety-nine dollars (\$59,299) shall be allocated to
14 the executive director's office for the purchase of legal services from the
15 department of law and three hundred sixty-three thousand one hundred
16 sixty-four dollars (\$363,164) and 1.8 FTE shall be allocated to the
17 division of real estate.

18 **SECTION 17. Appropriation.** (1) (a) In addition to any other
19 appropriation, there is hereby appropriated, to the department of law, for
20 the fiscal year beginning July 1, 2007, the sum of fifty-nine thousand two

1 hundred ninety-nine dollars (\$59,299) and 0.5 FTE, or so much thereof
2 as may be necessary, for the provision of legal services to the department
3 of regulatory agencies related to the implementation of this act. Said sum
4 shall be from cash funds exempt received from the department of
5 regulatory agencies, executive director's office out of the appropriation
6 for legal services in section 16 of this act.

7 (b) In addition to any other appropriation, there is hereby
8 appropriated, to the department of law, for the fiscal year beginning July
9 1, 2007, to the department of law, for allocation to the consumer
10 protection section, for the fiscal year beginning July 1, 2007, the sum of
11 one hundred eighty-six thousand three hundred forty-nine dollars
12 (\$186,349) and 2.3 FTE, or so much thereof as may be necessary, for the
13 implementation of this act. Said sum shall be from cash funds exempt
14 received from the department of regulatory agencies, executive director's
15 office out of the appropriation for to the division of real estate in section
16 of this act.

17 (2) In addition to any other appropriation, there is hereby
18 appropriated, to the department of public safety, Colorado bureau of
19 investigation, for the fiscal year beginning July 1, 2007, the sum of two
20 hundred ninety-seven thousand two hundred eighty-eight dollars
21 (\$297,288), or so much thereof as may be necessary, for fingerprint
22 processing services related to the implementation of this act. Of this sum,
23 eighty-six thousand eighty-eight dollars (\$86,088) shall be cash funds
24 from fingerprint and name check processing fees collected by the
25 department, and two hundred eleven thousand two hundred dollars
26 (\$211,200) shall be cash funds exempt from fingerprint and name check
27 processing fees collected by the department for transmittal to the federal
28 bureau of investigation."
