**A BILL FOR AN ACT**

101     **CONCERNING INCREASED EFFORTS TO ADDRESS WILDFIRE RISK, AND,**  
102             **IN CONNECTION THEREWITH, PROVIDING RESOURCES TO THE**  
103             **COLORADO STATE FOREST SERVICE TO AUGMENT ITS**  
104             **TECHNICAL OUTREACH CAPABILITIES AND PROVIDE LOANS AND**  
105             **GRANTS FOR MARKET-BASED AND FOREST TREATMENT**  
106             **SOLUTIONS TO REDUCE WILDFIRE RISK, AND MAKING AN**

Enacts the "Colorado Healthy Forests and Vibrant Communities Act of 2009" (act). Directs the Colorado state forest service (forest service) to:

- ! Adopt standards for community wildfire protection plans (CWPPs) adopted by local communities pursuant to the federal "Healthy Forests Restoration Act of 2003" to promote greater consistency among CWPPs and facilitate the adoption of CWPPS by local communities, and to provide technical assistance to such local communities;
- ! Reduce wildfire risks by supporting the implementation of risk mitigation treatments that focus on protecting lives, homes, and essential community infrastructure and by improving inventory and monitoring of forest conditions, including by implementing a cost-share grant program and by hiring additional temporary field capacity;
- ! Support communities and land managers in moving from wildfire risk reduction to long-term ecological restoration;
- ! Support local business development and job creation through the implementation of forest treatments, including by administering a revolving loan fund to support woody biomass utilization, marketing timber products, and supporting the increased use of woody biomass in bio-heating;
- ! Issue a statewide request for proposals for loans to businesses to provide start-up capital for new facilities or equipment to harvest, remove, use, and market beetle-killed or other timber taken from private, federal, state, county, or municipal forest lands as part of a wildfire risk reduction or fuels mitigation treatment; and
- ! Improve outreach and technical assistance by adding full-time temporary staff and GIS capacity to assist with risk assessments and planning and by developing a web-based clearinghouse for technical assistance and funding resources.

Creates the healthy forests and vibrant communities fund (fund). Transfers \$2,950,000 from the operational account of the severance tax trust fund (account) to the fund for purposes of the act. Transfers \$50,000 each year from the account to the wildland-urban interface training fund for training for directors of fire protection districts.

Directs the air quality control commission to work with key regulatory and management entities, including the forest service and representatives of local health departments to identify barriers to the increased use of prescribed fire and recommend solutions to address those barriers.

2           **SECTION 1.** Part 3 of article 31 of title 23, Colorado Revised  
3 Statutes, is amended BY THE ADDITION OF A NEW SECTION to  
4 read:

5           **23-31-312. Healthy forests - vibrant communities - funds**  
6 **created.** (1) **Short title.** THIS SECTION SHALL BE KNOWN AND MAY BE  
7 CITED AS THE "COLORADO HEALTHY FORESTS AND VIBRANT  
8 COMMUNITIES ACT OF 2009".

9           (2) **Legislative declaration.** THE GENERAL ASSEMBLY HEREBY  
10 DECLARES THAT ADDRESSING THE WILDFIRE RISK IN COLORADO AND THE  
11 DEVELOPMENT OF COMMUNITY WILDFIRE PROTECTION PLANS TO BRING  
12 TOGETHER FEDERAL, STATE, AND LOCAL INTERESTS, INCLUDING  
13 NONGOVERNMENTAL ENTITIES SUCH AS ELECTRIC, GAS, AND WATER  
14 UTILITIES, TO ADDRESS WILDFIRE RISK TO LIFE, PROPERTY, AND  
15 INFRASTRUCTURE IN COLORADO IS A MATTER OF STATEWIDE CONCERN.

16           (3) **Definitions.** AS USED IN THIS SECTION, UNLESS THE CONTEXT  
17 OTHERWISE REQUIRES:

18           (a) "COMMUNITY-BASED COLLABORATIVE PROCESS" MEANS A  
19 PROCESS IN WHICH A DIVERSE RANGE OF GOVERNMENTAL AND  
20 NONGOVERNMENTAL STAKEHOLDERS, REPRESENTING A WIDE VARIETY OF  
21 PERSPECTIVES, ARE MEANINGFULLY ENGAGED IN ANALYZING AND  
22 IDENTIFYING FOREST MANAGEMENT NEEDS FOR THEIR COMMUNITY.

23           (b) "COMMUNITY WILDFIRE PROTECTION PLAN" OR "CWPP"  
24 MEANS A PLAN THAT MEETS THE DEFINITION OF A COMMUNITY WILDFIRE  
25 PROTECTION PLAN IN THE FEDERAL "HEALTHY FORESTS RESTORATION  
26 ACT OF 2003", 16 U.S.C. SEC. 6511, INCLUDING THE MINIMUM

1 REQUIREMENTS FOR COLLABORATION WITH LOCAL AND STATE  
2 GOVERNMENT REPRESENTATIVES, INCLUDING CONSERVATION DISTRICTS  
3 CREATED PURSUANT TO ARTICLE 70 OF TITLE 35, C.R.S., AND COUNTY  
4 NOXIOUS WEED PROGRAM ADMINISTRATORS AND CONSULTATION WITH  
5 FEDERAL AGENCIES AND OTHER INTERESTED NONGOVERNMENTAL  
6 PARTIES, INCLUDING ANY ELECTRIC, GAS, AND WATER UTILITIES IN THE  
7 AFFECTED AREA, AND THE MINIMUM REQUIREMENTS FOR APPROVAL BY  
8 REPRESENTATIVES OF LOCAL GOVERNMENT, LOCAL FIRE AUTHORITIES,  
9 AND THE FOREST SERVICE.

10 (c) "FOREST SERVICE" MEANS THE COLORADO STATE FOREST  
11 SERVICE IDENTIFIED IN SECTION 23-31-302.

12 (d) "GIS" MEANS A GEOGRAPHICAL INFORMATION SYSTEM, A  
13 SYSTEMATIC INTEGRATION OF COMPUTER HARDWARE, SOFTWARE, AND  
14 SPATIAL DATA, FOR CAPTURING, STORING, DISPLAYING, UPDATING,  
15 MANIPULATING, AND ANALYZING GEOGRAPHICAL INFORMATION IN ORDER  
16 TO SOLVE COMPLEX MANAGEMENT PROBLEMS.

17 (e) "GOOD NEIGHBOR AUTHORITY" MEANS THE AUTHORITY OF THE  
18 STATE OF COLORADO PURSUANT TO SECTION 331 OF THE FEDERAL  
19 "DEPARTMENT OF INTERIOR AND RELATED AGENCIES APPROPRIATION  
20 ACT OF 2001", PUB.L. 106-291, 114 STAT. 922, OR ANY ANALOGOUS  
21 SUCCESSOR AUTHORITY.

22 (f) "TEMPORARY FIELD CAPACITY" MEANS FULL-TIME, TEMPORARY  
23 FIELD SUPPORT HIRED BY THE FOREST SERVICE TO IMPLEMENT PROJECTS  
24 UNTIL SUCH TIME THAT PROGRAM FUNDING IS NO LONGER AVAILABLE.

25 (g) "WILDFIRE RISK MITIGATION" OR "FUEL MITIGATION  
26 TREATMENTS" MEANS PREVENTIVE FOREST MANAGEMENT PROJECTS OR  
27 ACTIONS, WHICH MEET OR EXCEED FOREST SERVICE STANDARDS OR ANY

1 OTHER APPLICABLE STATE RULES, THAT ARE DESIGNED TO REDUCE THE  
2 POTENTIAL FOR UNWANTED IMPACTS CAUSED BY WILDFIRES, INCLUDING:

3 (I) THE CREATION OF A DEFENSIBLE SPACE AROUND STRUCTURES;

4 (II) THE ESTABLISHMENT OF FUEL BREAKS;

5 (III) THE THINNING OF WOODY VEGETATION FOR THE PRIMARY  
6 PURPOSE OF REDUCING RISK TO STRUCTURES FROM WILDLAND FIRE;

7 (IV) THE SECONDARY TREATMENT OF WOODY FUELS BY LOPPING  
8 AND SCATTERING, PILING, CHIPPING, REMOVING FROM THE SITE, OR  
9 PRESCRIBED BURNING; AND

10 (V) OTHER NONEMERGENCY PREVENTIVE ACTIVITIES DESIGNED TO  
11 REDUCE THE UNWANTED IMPACTS CAUSED BY WILDFIRES THAT THE  
12 FOREST SERVICE MAY DEEM TO BE RISK REDUCTION OR FUEL MITIGATION  
13 TREATMENTS.

14 **(4) Community and firefighter planning and preparedness.**

15 TO HELP ENSURE THAT COMMUNITIES AND FIREFIGHTERS HAVE SUFFICIENT  
16 RESOURCES, TECHNICAL SUPPORT, AND TRAINING TO ADEQUATELY ASSESS  
17 WILDFIRE RISKS, THE FOREST SERVICE SHALL:

18 (a) FACILITATE THE CWPP PROCESS WITH COMMUNITIES AND  
19 OTHER ENTITIES SEEKING TO PREPARE A CWPP TO ENSURE THAT STATE  
20 AND FEDERAL CWPP STANDARDS ARE MET;

21 (b) WORK WITH CONSERVATION DISTRICTS CREATED PURSUANT TO  
22 ARTICLE 70 OF TITLE 35, C.R.S., COUNTY NOXIOUS WEED PROGRAM  
23 ADMINISTRATORS AND OTHER STATE, LOCAL, FEDERAL, AND  
24 NONGOVERNMENTAL PARTNERS, INCLUDING ANY ELECTRIC, GAS, AND  
25 WATER UTILITIES IN THE AFFECTED AREA, TO PROVIDE CWPP STANDARDS  
26 FOR COLORADO THAT PROMOTE GREATER CONSISTENCY AMONG CWPPS  
27 IN THE STATE AND ENSURE THAT COMMUNITIES ADDRESS COMMUNITY

1 RISKS AND VALUES, IDENTIFY PROTECTION PRIORITIES, ASSESS THEIR  
2 ABILITY TO RESPOND TO WILDLAND FIRE, ESTABLISH FUELS TREATMENT  
3 PROJECTS, AND IDENTIFY WAYS TO MINIMIZE WILDLAND-URBAN INTERFACE  
4 RISK IN THE FUTURE;

5 (c) PROVIDE TECHNICAL ASSISTANCE TO COMMUNITIES SEEKING TO  
6 PREPARE, UPDATE, OR IMPLEMENT A CWPP AND TRACK THE PROGRESS OF  
7 CWPPS AND IMPLEMENTATION PRACTICES THROUGH GIS WEB-BASED  
8 APPLICATIONS;

9 (d) PROVIDE TECHNICAL ASSISTANCE TO THE BOARD OF COUNTY  
10 COMMISSIONERS OF EACH COUNTY TO DETERMINE WHETHER THERE ARE  
11 FIRE HAZARD AREAS WITHIN THE UNINCORPORATED AREAS OF THE COUNTY  
12 AND TO ASSIST THE BOARD OF COUNTY COMMISSIONERS OF EACH COUNTY  
13 WITH DEVELOPING CWPPS FOR THOSE AREAS; AND

14 (e) INCREASE UPGRADES ON FEDERAL EXCESS PROPERTY FIRE  
15 ENGINES ON LOAN TO LOCAL FIRE DEPARTMENTS; INCREASE TECHNICAL  
16 ASSISTANCE IN WILDLAND FIRE PREPAREDNESS TO COUNTIES AND FIRE  
17 PROTECTION DISTRICTS; AND, IN CONJUNCTION WITH THE WILDFIRE  
18 PREPAREDNESS PLAN CREATED PURSUANT TO SECTION 23-31-309 (3) (a),  
19 ENSURE THAT STATE FIRE-FIGHTING EQUIPMENT SUCH AS FIRE ENGINES  
20 AND AIR TANKERS, IS FULLY OPERATIONAL AND AVAILABLE TO AND  
21 COORDINATED WITH THE EQUIPMENT CAPACITIES OF LOCAL FIRE  
22 PROTECTION DISTRICTS, AND THAT PERSONNEL ARE FULLY TRAINED IN ITS  
23 USE.

24 (5) **Community wildfire risk mitigation.** TO HELP COMMUNITIES  
25 ADDRESS THE URGENT NEED TO REDUCE WILDFIRE RISKS BY SUPPORTING  
26 IMPLEMENTATION OF RISK MITIGATION TREATMENTS THAT FOCUS ON  
27 PROTECTING LIVES, HOMES, AND ESSENTIAL COMMUNITY

1 INFRASTRUCTURE, AND BY IMPROVING INVENTORY AND MONITORING OF  
2 FOREST CONDITIONS, THE FOREST SERVICE SHALL:

3 (a) EXPAND ITS FUELS MITIGATION PROGRAM THROUGH SIXTY  
4 PERCENT COST-SHARE GRANTS TO ADDRESS NEEDS EXPRESSED BY  
5 LANDOWNERS OR UTILITY EASEMENT OWNERS IN THE WILDLAND-URBAN  
6 INTERFACE. IN ORDER TO QUALIFY FOR THESE FUNDS, PROJECTS SHALL BE  
7 INCLUDED IN OR PROVIDE FOR IMPLEMENTATION OF AN APPROVED CWPP  
8 THAT MEETS THE STANDARDS ESTABLISHED PURSUANT TO PARAGRAPH (b)  
9 OF SUBSECTION (4) OF THIS SECTION. IN AWARDING THESE GRANTS, THE  
10 FOREST SERVICE SHALL ESTABLISH EVALUATION CRITERIA THAT  
11 EMPHASIZES PROJECTS THAT REDUCE RISKS TO THE PUBLIC, FIREFIGHTERS,  
12 AND COMMUNITY INFRASTRUCTURE; THAT IMPROVE FOREST HEALTH; AND  
13 THAT SUBSTANTIALLY LEVERAGE ADDITIONAL FINANCIAL RESOURCES. IN  
14 MAKING GRANT AWARDS, THE FOREST SERVICE SHALL ALSO PRIORITIZE  
15 PROJECTS THAT PROVIDE AN OPPORTUNITY TO IMPLEMENT COLORADO'S  
16 GOOD NEIGHBOR AUTHORITY OR THAT HAVE BEEN IDENTIFIED THROUGH  
17 A COMMUNITY-BASED COLLABORATIVE PROCESS.

18 (b) HIRE ADDITIONAL TEMPORARY FIELD CAPACITY TO SUPPORT  
19 THE IMPLEMENTATION AND MONITORING OF FUELS MITIGATION GRANT  
20 AWARDS;

21 (c) PROVIDE SUFFICIENT RESOURCES TO CONDUCT ENHANCED  
22 AERIAL SURVEYS TO ANNUALLY ASSESS FOREST CONDITIONS, IDENTIFY  
23 EMERGING AND EXISTING INSECT AND DISEASE EPIDEMICS, AND MAKE  
24 TIMELY MANAGEMENT DECISIONS; AND

25 (d) PROVIDE SUFFICIENT RESOURCES TO ASSESS AND INCORPORATE  
26 FOREST PATHOLOGY INFORMATION INTO ANALYSIS OF FOREST CONDITIONS  
27 AND TRENDS.

1           **(6) Community watershed restoration.** **(a)** IN ORDER TO  
2 SUPPORT COMMUNITIES AND LAND MANAGERS IN MOVING FROM RISK  
3 REDUCTION TO LONG-TERM ECOLOGICAL RESTORATION SO THAT THE  
4 UNDERLYING CONDITION OF COLORADO'S FORESTS SUPPORTS A VARIETY  
5 OF VALUES, PARTICULARLY PUBLIC WATER SUPPLY AND HIGH-QUALITY  
6 WILDLIFE HABITAT, THE FOREST SERVICE SHALL:

7           **(I) (A)** HIRE ADDITIONAL TEMPORARY FIELD CAPACITY TO  
8 SUPPORT THE IMPLEMENTATION AND MONITORING OF FOREST  
9 RESTORATION PILOT PROGRAM GRANTS AWARDED PURSUANT TO SECTION  
10 23-31-310;

11           **(B)** IN AWARDING GRANTS PURSUANT TO SECTION 23-31-310, THE  
12 FOREST SERVICE SHALL GIVE ADDITIONAL EMPHASIS TO PROJECTS THAT  
13 SUBSTANTIALLY LEVERAGE ADDITIONAL FINANCIAL RESOURCES, THAT  
14 PROVIDE AN OPPORTUNITY TO IMPLEMENT COLORADO'S GOOD NEIGHBOR  
15 AUTHORITY, OR THAT HAVE BEEN IDENTIFIED THROUGH A  
16 COMMUNITY-BASED COLLABORATIVE PROCESS.

17           **(II)** FACILITATE AND WORK COLLABORATIVELY WITH  
18 LANDOWNERS, LOCAL GOVERNMENTS, INCLUDING CONSERVATION  
19 DISTRICTS CREATED PURSUANT TO ARTICLE 70 OF TITLE 35, C.R.S., AND  
20 COUNTY NOXIOUS WEED PROGRAM ADMINISTRATORS AND OTHER  
21 APPROPRIATE PARTIES, INCLUDING ANY ELECTRIC, GAS, AND WATER  
22 UTILITIES IN THE AFFECTED AREA, TO DESIGN AND SAFELY IMPLEMENT  
23 PRESCRIBED FIRE PROJECTS AND TO ENCOURAGE INCREASED RESPONSIBLE  
24 USE OF PRESCRIBED FIRE AS A TOOL FOR RESTORING HEALTHY FOREST  
25 CONDITIONS CONSISTENT WITH PROGRAMS ESTABLISHED PURSUANT TO  
26 SECTION 25-7-106 (7) AND (8), C.R.S. THE FOREST SERVICE SHALL  
27 EMPHASIZE PROVIDING TRAINING AND TECHNICAL ASSISTANCE FOR

1 LANDOWNERS, LOCAL COMMUNITIES, AND STATE AGENCIES.

2 (b) THE FOREST SERVICE MAY USE UP TO ONE MILLION DOLLARS  
3 ANNUALLY UNTIL JULY 1, 2012, FROM THE FOREST RESTORATION PILOT  
4 PROGRAM CASH FUND CREATED IN SECTION 23-31-310 (8.5) FOR THE  
5 PURPOSE OF COMPLYING WITH THIS SUBSECTION (5).

6 (7) **Enhanced economic opportunities.** IN ORDER TO SUPPORT  
7 LOCAL BUSINESS DEVELOPMENT AND JOB CREATION THROUGH THE  
8 IMPLEMENTATION OF FOREST TREATMENTS, THE FOREST SERVICE SHALL:

9 (a) ADMINISTER A REVOLVING LOAN FUND TO SUPPORT WOODY  
10 BIOMASS UTILIZATION AND THE DEVELOPMENT AND MARKETING OF  
11 TRADITIONAL AND NONTRADITIONAL TIMBER PRODUCTS AS SPECIFIED IN  
12 SUBSECTION (8) OF THIS SECTION;

13 (b) WORK WITH THE GOVERNOR'S ENERGY OFFICE CREATED IN  
14 SECTION 24-38.5-101, C.R.S., AND THE AIR QUALITY CONTROL  
15 COMMISSION CREATED IN SECTION 25-7-104, C.R.S., TO SUPPORT THE  
16 APPROPRIATELY INCREASED USE OF WOODY BIOMASS IN BIO-HEATING.

17 (8) **Wildfire risk mitigation loan program.** (a) THE FOREST  
18 SERVICE SHALL ISSUE A STATEWIDE REQUEST FOR PROPOSALS FOR LOANS  
19 TO BUSINESSES TO PROVIDE START-UP CAPITAL FOR NEW FACILITIES OR  
20 EQUIPMENT TO HARVEST, REMOVE, USE, AND MARKET BEETLE-KILLED AND  
21 OTHER TIMBER TAKEN FROM PRIVATE, FEDERAL, STATE, COUNTY, OR  
22 MUNICIPAL FOREST LANDS AS PART OF A WILDFIRE RISK REDUCTION OR  
23 FUELS MITIGATION TREATMENT.

24 (b) **Eligibility requirements - applications.** THE FOREST  
25 SERVICE SHALL SOLICIT APPLICATIONS FOR AND MAKE LOANS UNDER THIS  
26 SECTION. IN DECIDING WHETHER TO MAKE A LOAN, THE FOREST SERVICE  
27 SHALL CONSIDER THE EXTENT TO WHICH THE APPLICANT:

- 1 (I) HELPS RETAIN OR EXPAND OTHER LOCAL BUSINESSES;
- 2 (II) HELPS MAINTAIN OR INCREASE THE NUMBER OF JOBS IN THE
- 3 AREA;
- 4 (III) CONTRIBUTES TO THE STABILITY OF RURAL COMMUNITIES;
- 5 (IV) DEMONSTRATES OPERATIONAL EXPERIENCE AND A GOOD
- 6 REPUTATION;
- 7 (V) PROMOTES AND PUBLICIZES THE EFFORTS UNDERTAKEN
- 8 PURSUANT TO THIS SECTION; AND
- 9 (VI) HELPS RECRUIT NEW BUSINESS ACTIVITY IN THE AREA.

10 (c) **Report.** NO LATER THAN JULY 1, 2010, THE STATE FORESTER  
11 SHALL SUBMIT A REPORT TO THE GOVERNOR THAT SHALL INCLUDE AN  
12 ASSESSMENT OF WHETHER, AND TO WHAT EXTENT, PROJECTS FUNDED BY  
13 LOANS UNDER THIS SUBSECTION (8) HAVE ACHIEVED THE PURPOSES  
14 IDENTIFIED IN THIS SUBSECTION (8).

15 (d) **Wildfire risk mitigation revolving fund.** THERE IS HEREBY  
16 CREATED IN THE STATE TREASURY THE WILDFIRE RISK MITIGATION  
17 REVOLVING FUND, WHICH SHALL BE ADMINISTERED BY THE FOREST  
18 SERVICE. ALL MONEYS IN THE FUND ARE CONTINUOUSLY APPROPRIATED  
19 TO THE DEPARTMENT OF HIGHER EDUCATION FOR ALLOCATION TO THE  
20 BOARD OF GOVERNORS OF THE COLORADO STATE UNIVERSITY SYSTEM FOR  
21 LOANS SPECIFIED IN THIS SUBSECTION (8). ALL MONEYS IN THE FUND AT  
22 THE END OF EACH FISCAL YEAR SHALL BE RETAINED IN THE FUND AND  
23 SHALL NOT REVERT TO THE GENERAL FUND OR ANY OTHER FUND.

24 (9) **Improved outreach and technical assistance.** IN ORDER TO  
25 ENSURE THAT THE FOREST SERVICE HAS THE CAPACITY TO DELIVER KEY  
26 FUNDING AND TECHNICAL ASSISTANCE THAT WILL BE NEEDED TO GUIDE  
27 AND SUPPORT IMPLEMENTATION OF WILDFIRE PREPAREDNESS, RISK

1 MITIGATION, WATERSHED RESTORATION, AND ECONOMIC DEVELOPMENT  
2 INITIATIVES IN A WAY THAT ADDS VALUE TO THESE EFFORTS AT THE STATE  
3 LEVEL AND ACROSS COMMUNITY BOUNDARIES, THE FOREST SERVICE  
4 SHALL:

5 (a) SECURE FULL-TIME TEMPORARY STAFF FOR DEVELOPING,  
6 REVISING, AND IMPLEMENTING CWPPs; DEVELOPING AND IMPLEMENTING  
7 RISK MITIGATION AND WATERSHED RESTORATION PLANS; STRENGTHENING  
8 THE RESPONSIBLE USE OF PRESCRIBED FIRE; AND SUPPORTING

**SECTION 6.
