SB15-014 be amended as follows:

1 Amend reengrossed bill, page 14, after line 10, insert:

2 "SECTION 7. In Colorado Revised Statutes, 25-1.5-106, amend
3 (12) (b) (IV) as follows:

4 **25-1.5-106. Medical marijuana program - powers and duties**
5 **of state health agency - rules - medical review board - medical**
6 **marijuana program cash fund - subaccount - created - repeal.**
7 (12) Use of medical marijuana.(b) A patient or primary caregiver shall
8 not:

9 (IV) Possess medical marijuana or otherwise engage in the use of
10 medical marijuana in or on the grounds of a school or in a school bus;
11 EXCEPT WHEN THE POSSESSION OR USE OCCURS IN ACCORDANCE WITH A
12 SCHOOL DISTRICT BOARD POLICY ESTABLISHED PURSUANT TO 22-1-119.3,
13 C.R.S.;

14 **SECTION 8. In Colorado Revised Statutes, 22-1-119.3, amend**
15 **(3) (c) as follows:**

16 **22-1-119.3. Policy for student possession and administration**
17 **of prescription medication - rules. (3) (c) A student shall not possess**
18 **or self-administer medical marijuana on school grounds, upon a school**
19 **bus, or at any school-sponsored event; EXCEPT THAT A SCHOOL DISTRICT**
20 **MAY ADOPT A POLICY, IN ACCORDANCE WITH THE REQUIREMENTS OF THIS**
21 **SECTION, THAT AUTHORIZES A STUDENT'S PARENT OR A MEDICAL**
22 **PROFESSIONAL WHO ACCOMPANIES A STUDENT TO SCHOOL, ON THE**
23 **SCHOOL BUS, OR TO ANY SCHOOL-SPONSORED EVENT AND ASSISTS THE**
24 **STUDENT WITH THE ADMINISTRATION OF MEDICAL MARIJUANA TO POSSESS**
25 **AND ADMINISTER MEDICAL MARIJUANA TO THE STUDENT IN AN**
26 **APPROPRIATE LOCATION ON SCHOOL GROUNDS, UPON A SCHOOL BUS, OR**
27 **AT ANY SCHOOL-SPONSORED EVENT. A POLICY PERMITTING A PARENT OR**
28 **MEDICAL PROFESSIONAL TO ADMINISTER MEDICAL MARIJUANA TO A**
29 **STUDENT MUST REQUIRE THAT THE STUDENT HOLD A VALID**
30 **RECOMMENDATION FOR MEDICAL MARIJUANA, THAT THE ADMINISTERING**
31 **PARENT BE THE STUDENT'S PRIMARY CAREGIVER OR THAT THE**
32 **ADMINISTERING MEDICAL PROFESSIONAL BE EMPLOYED SPECIFICALLY TO**
33 **ASSIST THE STUDENT IN ADMINISTERING MEDICAL MARIJUANA, AND THAT**
34 **THE LOCATION AND METHOD OF ADMINISTRATION OF MEDICAL MARIJUANA**
35 **DOES NOT CREATE SIGNIFICANT RISK TO OTHER STUDENTS."**
