- 4 TEACHING SKILL, AND BASED ON THE POLICIES ESTABLISHED PURSUANT TO
- 5 SUBSECTION (3) OF THIS SECTION.".
- 6 Page 4, strike lines 13 through 23 and substitute:
- "(II) REGARDING COMPENSATION AND BENEFITS FOR EMPLOYEES
 WITH TEACHING RESPONSIBILITIES WHO WERE CLASSIFIED AS ADJUNCT
 INSTRUCTORS PRIOR TO JUNE 30, 2016, POLICIES ESTABLISHED PURSUANT
 TO PARAGRAPH (a) OF SUBSECTION (3) OF THIS SECTION MUST BE
 DEVELOPED AND IMPLEMENTED OVER A MULTI-YEAR PERIOD IN A FISCALLY
 RESPONSIBLE AND SUSTAINABLE MANNER, WITH THE FIRST INCREMENTAL
 INCREASE TO OCCUR IN THE 2016-2017 ACADEMIC YEAR AS
- 13 INCREASE TO OCCUR IN THE 2016-2017 ACADEMIC YEAR AS 14 RECOMMENDED BY THE BOARD. THE COMPENSATION AND BENEFIT 15 POLICIES MUST NOT DIRECTLY CAUSE AN INCREASE IN STUDENT TUITION.
- (III) POLICIES ESTABLISHED PURSUANT TO PARAGRAPH (b) OF
 SUBSECTION (3) OF THIS SECTION MUST ADDRESS RESPONSIBILITIES,
 BENEFITS AND FREEDOMS, SUCH AS NON-TEACHING ACTIVITIES AND
 APPROPRIATE COMPENSATION CRITERIA FOR EACH TYPE OF ACTIVITY,
 CAREER PATHS AND APPROPRIATE COMPENSATION FOR COURSE
- 21 CANCELLATIONS, AND ACADEMIC FREEDOM AND INTELLECTUAL INQUIRY.".
- Page 4, line 24, strike "(II)" and substitute "(IV)".
- Page 4, line 26, strike "(I)" and substitute "(III)".
