## State trustees to pay fine for violation of ethics law

DENVER — The Public Trustees Association of Colorado agreed to pay \$2,944 in fines Monday and get training on just what they can accept in gifts under the state's ethics laws.

The fine was the result of a complaint filed with the Colorado Independent Ethics Commission in November after 32 trustees, including Mesa County Trustee Paul Brown, allowed attorneys they do business with to pay part of their hotel costs at an annual conference in Black Hawk.

The complaint said the trustees accepted \$13,500 in donations from the Denver-based law firm Castle & Meinhold, and the Golden-based company Government Technology Systems, all in violation of Amendment 41.

The law firm does extensive work in foreclosures and works closely with trustees. GTS sells computer software often used by them.

Last fall, Brown told The Daily Sentinel he and other trustees knew the association had covered their one-night hotel stay, but they didn't know the money came from the companies.

Brown also said he doesn't use the software sold by GTS. He said the law firm handles up to 45 percent of all foreclosures in the state.

The complaint was filed by Colorado Ethics Watch, a left-leaning group that worked to get the ethics laws into the Constitution.

"We're pleased to have been able to bring these matters to the IEC's attention," said Luis Toro, the group's director. "As a result of the IEC's actions ... county officials throughout Colorado know that they are being watched and must adhere to the same high standards we expect of statewide elected officials."

Three counties where public trustees — the overseers of the state's foreclosure process — are appointed by the governor would have the position filled instead by their elected treasurers, under a bill proposed to the Colorado legislature.

Rep. Ray Scott, R-Grand Junction, said his bill, [HB 1329](#), looks to change how trustees are selected in Mesa, Weld and El Paso counties. The list could be expanded to include any of the other seven counties where the public trustee is a political appointee of the governor.

The idea, Scott said, is primarily intended to save counties money.

"When I looked into the statute, I was really shocked it was that old," Scott said. "And we're the only state in the country that does this. Either we're really, really smart, or really, really stupid."

The bill was introduced late Wednesday and assigned Thursday to the House local government committee for a hearing, which has not been scheduled.

Except for Denver and Broomfield, Colorado's other large counties — Adams, Arapahoe, Boulder, Douglas, El Paso, Jefferson, Larimer, Mesa, Pueblo and Weld — have trustees appointed by the governor and serve renewable four-year terms, a law that dates to the state's silver-mining days.

By law, elected treasurers in the other 52 counties are also the public trustee. In Denver, the post is held by the elected clerk and recorder, who in turn appoints a deputy to run the trustee office.

Broomfield's trustee is appointed by the City Council.

"I don't understand why the governor would ever want this baggage," Scott said.

Gov. John Hickenlooper's spokesman, Eric Brown, said: "We will monitor the bill as it moves through the legislative process."

Patty Bartlett, Logan County's treasurer and public trustee, and president of the Colorado Public Trustee Association, said she had "heard rumors the bill was coming" but hadn't seen it.

"I'd have to first question if the supporters think it's going to save money or what exactly is behind it," Bartlett said. "What's the driving force? Is it fiscal, political or something else?"

Appointed trustees are paid \$72,000, a salary established by the legislature and increased in 2010 from \$48,500.

Some treasurers have said they've had to forgo the additional compensation because no money was left, while the salaries of the appointed trustees are guaranteed.

"It hardly seems fair," said one trustee who refused to have her name used because she feared backlash from the trustees association. "We do the work just like the big counties. But the appointed trustees are just treated differently."

The public trustee system has generated huge profits by charging the public more than what's needed to actually run its offices, [The Denver Post reported in December](#). What's more, each trustee office has generated so much money that it has a bank account set aside with enough funds to maintain the office for a whole year — salaries included — in the unlikely event that not a single foreclosure gets filed.

Trustees who are the elected treasurer operate differently, serving at the pleasure of voters, but they are required to follow county hiring, budget and bid procedures. Outside audits look at their finances, not their performance.

Appointed trustees are required only to file an annual report of transactions to the governor.

Though employees of appointed trustee offices are technically considered county employees, they work in separate offices, trustees maintain their own budgets — which are not subject to county approval — and can even maintain their own work spaces.
