HOUSE COMMITTEE OF REFERENCE AMENDMENT Committee on <u>Economic and Business Development</u>. HB12-1116 be amended as follows:

- Amend printed bill, page 9, line 5, after "(f)" insert "(I)".
- 2 Page 9, strike line 9 and substitute "OWNER OF THE RESALE TIME SHARE A
- 3 COPY OF THE RECORDED DEED OR OTHER EQUIVALENT WRITTEN EVIDENCE
- 4 CLEARLY DEMONSTRATING THAT THE RESALE TIME SHARE HAS BEEN
- 5 TRANSFERRED TO A SUBSEQUENT TRANSFEREE IN ACCORDANCE WITH THE
- 6 TIME SHARE RESALE TRANSFER AGREEMENT AND APPLICABLE LAW AND:".
- 7 Page 9, line 10, strike "(I)" and substitute "(A)".
- 8 Page 9, line 16, strike "AND" and substitute "OR".
- 9 Page 9, strike lines 17 through 21 and substitute:
- 10 "(B) IF, AFTER RECEIVING WRITTEN REQUEST FROM THE TIME 11 SHARE RESALE ENTITY, THE ASSOCIATION OF TIME SHARE OWNERS OR 12 OTHER RESPONSIBLE PERSON FAILS TO PROVIDE A WRITTEN 13 ACKNOWLEDGMENT AS DESCRIBED IN SUB-SUBPARAGRAPH (A) OF THIS 14 SUBPARAGRAPH (I) WITHIN THIRTY DAYS AFTER RECEIPT OF THE REQUEST, 15 A WRITTEN STATEMENT TO THAT EFFECT, SPECIFYING THE DATE ON WHICH 16 THE WRITTEN REQUEST WAS SUBMITTED AND INCLUDING A COPY OF THE 17 REQUEST FOR THE ACKNOWLEDGMENT SUBMITTED TO THE ASSOCIATION 18 OR RESPONSIBLE PERSON.
 - (II) (A) If the association of time share owners or other responsible person determines that a time share resale entity has not complied with the association's policies governing the transfer of a resale time share by a time share owner, the association or responsible person shall provide to the resale time share entity the basis for the determination and a copy of the association's policies governing the transfer of a resale time share so as to allow the time share resale entity the opportunity to comply with the association's policies and obtain the written acknowledgment described in sub-subparagraph (A) of subparagraph (I) of this paragraph (f).
 - (B) A DETERMINATION PURSUANT TO SUB-SUBPARAGRAPH (A) OF THIS SUBPARAGRAPH (II) IS NOT A FAILURE TO RESPOND TO A WRITTEN REQUEST SUBMITTED BY A TIME SHARE RESALE ENTITY PURSUANT TO SUB-SUBPARAGRAPH (B) OF SUBPARAGRAPH (I) OF THIS PARAGRAPH (f);".
