

# Care of Livestock Animals

Be it enacted by the People of the State of Colorado:

**SECTION 1.** Title 18, Article 9 of the Colorado Revised Statutes is amended as follows:

## **§ 18-9-201.5. Scope of part 2**

**§ 18-9-201.5(1).** NOTHING IN THIS PART 2 SHALL AFFECT ACCEPTED ANIMAL HUSBANDRY PRACTICES UTILIZED BY ANY PERSON IN THE CARE OF COMPANION ~~OR LIVESTOCK~~ ANIMALS OR IN THE EXTERMINATION OF UNDESIRABLE PESTS AS DEFINED IN ARTICLES 7, 10, AND 43 OF TITLE 35, C.R.S.

**§ 18-9-201.5(2).** IN CASE OF ANY CONFLICT BETWEEN THIS PART 2 OR SECTION 35-43-126, C.R.S., AND THE WILDLIFE STATUTES OF THE STATE, SAID WILDLIFE STATUTES SHALL CONTROL.

**§ 18-9-201.5(3).** NOTHING IN THIS PART 2 SHALL AFFECT ANIMAL CARE OTHERWISE AUTHORIZED BY LAW.

**§ 18-9-201.5(4).** NOTHING IN THIS PART 2 SHALL AFFECT FACILITIES LICENSED UNDER THE PROVISIONS OF THE FEDERAL "ANIMAL WELFARE ACT OF 1970", 7 U.S.C. SEC. 2131 ET SEQ., AS AMENDED.

**SECTION 2. EFFECTIVE DATE** – THIS INITIATED STATUTE SHALL BECOME EFFECTIVE UPON OFFICIAL DECLARATION OF THE VOTE HEREON BY PROCLAMATION OF THE GOVERNOR, PURSUANT TO SECTION 1(4) OF ARTICLE V OF THE CONSTITUTION OF THE STATE OF COLORADO.
