Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB07-1349 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Strike the Appropriations Committee Report, dated April 9, 2007, and  
2 substitute the following:

3 "Amend printed bill, page 26, after line 5, insert the following:

4           **"SECTION 19. Appropriation.** (1) In addition to any other  
5 appropriation, there is hereby appropriated, out of any moneys in the  
6 general fund not otherwise appropriated, to the department of human  
7 services, office of self sufficiency, child support enforcement, automated  
8 child support enforcement system, for the fiscal year beginning July 1,  
9 2007, the sum of forty thousand four hundred forty dollars (\$40,440), or  
10 so much thereof as may be necessary, for the implementation of this act.  
11 Said amount is exempt from the statutory limit on state general fund  
12 appropriations pursuant to section 24-75-201.1 (1) (a) (III) (A), Colorado  
13 Revised Statutes. The general assembly anticipates that, for the fiscal  
14 year beginning July 1, 2007, the department of human services will  
15 receive the sum of seventy-eight thousand five hundred three dollars  
16 (\$78,503) in federal funds for the implementation of this act. Although  
17 these funds are not appropriated in this act, they are noted for the purpose  
18 of indicating the assumptions used relative to these funds.

19           (2) In addition to any other appropriation, there is hereby  
20 appropriated, out of any moneys in the general fund not otherwise  
21 appropriated, to the department of revenue, for allocation to the taxpayer

1 service division, for the fiscal year beginning July 1, 2007, the sum of two  
2 thousand five hundred seventy-five dollars (\$2,575), or so much thereof  
3 as may be necessary, for the implementation of this act.

4 (3) For the implementation of this act, the appropriation made in  
5 section 21 of the annual general appropriation act for the fiscal year  
6 beginning July 1, 2007, shall be adjusted as follows: The general fund  
7 appropriation to the controlled maintenance trust fund is decreased by two  
8 thousand five hundred seventy-five dollars (\$2,575).".

9 Renumber succeeding sections accordingly.

10 Page 1, line 101, strike "**OBLIGATIONS.**" and substitute "**OBLIGATIONS,**  
11 **AND MAKING AN APPROPRIATION IN CONNECTION THEREWITH.**".".
