Bill Summary

Creates the southern Colorado council for excellence in health careers education ("council") to facilitate collaboration between public and private health education providers and health care providers for

improving health careers education and, ultimately, to improve health care in southern Colorado. Specifies the membership of the council and the council's purposes. Authorizes the council to establish task forces to assist it in accomplishing its purposes. Requires the council to report annually to the education committees of the general assembly and to the Colorado commission on higher education. Authorizes Adams state college and Trinidad state junior college to accept and expend gifts, grants, and donations on behalf of the council, and requires an annual accounting of the moneys received. Repeals the council, effective July 1, 2012. Specifies that the act can be implemented without general fund appropriations.

2 **SECTION 1.** Title 23, Colorado Revised Statutes, is amended BY

7 **23-74-101. Short title.** THIS ARTICLE SHALL BE KNOWN AND MAY
8 BE CITED AS THE "SOUTHERN COLORADO COUNCIL FOR EXCELLENCE IN
9 HEALTH CAREERS EDUCATION ACT".

10 **23-74-102. Legislative declaration.** (1) THE GENERAL
11 ASSEMBLY HEREBY FINDS THAT:

12 (a) RURAL HEALTH EDUCATION IN SOUTHERN COLORADO IS
13 CURRENTLY A PRODUCT OF SEVERAL DISTINCT ENTITIES, INCLUDING
14 ADAMS STATE COLLEGE, TRINIDAD STATE JUNIOR COLLEGE, AND SEVERAL
15 PRIVATE HEALTH CARE PROVIDERS; AND

16 (b) ESTABLISHING A COUNCIL THAT INCLUDES REPRESENTATION
17 FROM HEALTH EDUCATION PROVIDERS AND HEALTH CARE PROVIDERS TO
18 EXERCISE COLLABORATIVE LEADERSHIP IN HEALTH CARE EDUCATION AND
19 HEALTH CARE WORKFORCE DEVELOPMENT WILL BENEFIT SOUTHERN

1 COLORADO THROUGH INCREASED AVAILABILITY OF ENHANCED AND
2 EXPANDED HEALTH CARE PROGRAMS, IMPROVED FINANCIAL VIABILITY OF
3 EXISTING HEALTH CARE PROGRAMS, AND INCREASED OPPORTUNITIES FOR
4 PERSONS WHO RESIDE IN THE REGION AND ARE INTERESTED IN ENTERING
5 HEALTH CARE CAREERS.

6 (2) THE GENERAL ASSEMBLY THEREFORE DECLARES THAT IT IS IN
7 THE BEST INTERESTS OF THE PEOPLE OF THE STATE OF COLORADO TO
8 CREATE A COUNCIL FOR EXCELLENCE IN HEALTH CAREERS EDUCATION IN
9 SOUTHERN COLORADO TO COLLABORATE IN CREATING EXCELLENCE IN
10 HEALTH-RELATED EDUCATIONAL AND CAREER OPPORTUNITIES AND IN THE
11 PROVISION OF HEALTH CARE FOR THE BENEFIT OF STUDENTS, RESIDENTS,
12 AND PROFESSIONALS IN SOUTHERN COLORADO.

13 **23-74-103. Definitions.** AS USED IN THIS ARTICLE, UNLESS THE
14 CONTEXT OTHERWISE REQUIRES:

15 (1) "COUNCIL" MEANS THE SOUTHERN COLORADO COUNCIL FOR
16 EXCELLENCE IN HEALTH CAREERS EDUCATION CREATED IN SECTION
17 23-74-104.

18 (2) "HEALTH EDUCATION PROGRAM" MEANS A VOCATIONAL OR
19 POSTSECONDARY PROGRAM THAT FOCUSES ON AN ASPECT OF PROVIDING
20 HEALTH CARE, INCLUDING BUT NOT LIMITED TO NURSING, HEALTH CARE
21 ADMINISTRATION, DENTAL PROFESSIONALS, AND MEDICAL PROFESSIONALS.

22 (3) "SOUTHERN COLORADO" MEANS THE AREA COMPRISED OF
23 ALAMOSA, CONEJOS, COSTILLA, MINERAL, RIO GRANDE, AND SAGUACHE
24 COUNTIES.

25 **23-74-104. Council for excellence in health careers education**
26 **- creation - membership.** (1) THERE IS HEREBY CREATED THE
27 SOUTHERN COLORADO COUNCIL FOR EXCELLENCE IN HEALTH CAREERS

1 EDUCATION TO BRING TOGETHER PUBLIC EDUCATIONAL INSTITUTIONS AND
2 HEALTH CARE PROVIDERS TO COLLABORATE AND PROVIDE LEADERSHIP IN
3 BUILDING EXCELLENCE IN HEALTH CARE FOR SOUTHERN COLORADO.

4 (2) THE COUNCIL SHALL CONSIST OF NO MORE THAN FIFTEEN
5 MEMBERS AS FOLLOWS:

6 (a) THE STATE SENATOR REPRESENTING SENATE DISTRICT FIVE;

7 (b) THE STATE REPRESENTATIVE REPRESENTING HOUSE DISTRICT
8 SIXTY-TWO;

9 (c) TWO REPRESENTATIVES FROM ADAMS STATE COLLEGE, WHO
10 SHALL BE APPOINTED INITIALLY BY THE PRESIDENT OF THE COLLEGE;

11 (d) TWO REPRESENTATIVES FROM TRINIDAD STATE JUNIOR
12 COLLEGE, WHO SHALL BE APPOINTED INITIALLY BY THE PRESIDENT OF THE
13 COLLEGE;

14 (e) THE FOLLOWING MEMBERS INITIALLY APPOINTED JOINTLY BY
15 THE SENATOR AND REPRESENTATIVE SERVING ON THE COUNCIL:

16 (I) ONE REPRESENTATIVE FROM THE SAN LUIS VALLEY AREA
17 HEALTH EDUCATION CENTER LOCATED IN SOUTHERN COLORADO;

18 (II) TWO REPRESENTATIVES FROM SCHOOL DISTRICTS LOCATED IN
19 SOUTHERN COLORADO; AND

20 (III) NO MORE THAN SIX REPRESENTATIVES FROM DIFFERENT
21 HEALTH CARE PROVIDERS IN SOUTHERN COLORADO.

22 (3) COUNCIL MEMBERS SHALL SERVE FOR THE DURATION OF THE
23 COUNCIL; HOWEVER, IF A VACANCY IN A COUNCIL POSITION OCCURS, IT
24 SHALL BE FILLED BY A VOTE OF THE COUNCIL, SO LONG AS THE INITIAL
25 REPRESENTATION IS MAINTAINED.

26 (4) ON OR AFTER JULY 1, 2007, BUT NO LATER THAN AUGUST 1,
27 2007, THE COUNCIL SHALL MEET AT LEAST ONCE. THE COUNCIL SHALL

1 MEET QUARTERLY THEREAFTER, OR AS FREQUENTLY AS THE COUNCIL
2 DEEMS NECESSARY TO ACCOMPLISH ITS PURPOSES. ON OR BEFORE
3 AUGUST 1, 2007, AND ON OR BEFORE AUGUST 1 EACH YEAR THEREAFTER,
4 THE COUNCIL SHALL SELECT A CHAIRPERSON AND A VICE-CHAIRPERSON
5 FROM AMONG ITS MEMBERS.

6 (5) NOTWITHSTANDING SECTION 2-2-307, C.R.S., THE COUNCIL
7 MEMBERS SHALL SERVE WITHOUT COMPENSATION AND WITHOUT
8 REIMBURSEMENT FOR EXPENSES. THE COUNCIL MAY REQUEST STAFF
9 ASSISTANCE FROM ADAMS STATE COLLEGE AND FROM TRINIDAD STATE
10 JUNIOR COLLEGE IN MEETING ITS PURPOSES.

11 **23-74-105. Council for excellence in health careers education**
12 **- duties - task forces.** (1) THE COUNCIL SHALL HAVE THE FOLLOWING
13 PURPOSES:

14 (a) TO IDENTIFY, RECOMMEND, AND ASSIST IN DEVELOPING NEW
15 HEALTH EDUCATION PROGRAMS TO BE OFFERED BY THE PUBLIC
16 EDUCATIONAL INSTITUTIONS IN SOUTHERN COLORADO;

17 (b) TO COLLABORATE ON STRATEGIES FOR INCREASING THE
18 NUMBER OF PERSONS WHO ENROLL IN HEALTH EDUCATION PROGRAMS IN
19 THE PUBLIC EDUCATIONAL INSTITUTIONS IN SOUTHERN COLORADO;

20 (c) TO INCREASE THE COLLABORATION AMONG THE PUBLIC
21 EDUCATIONAL INSTITUTIONS AND HEALTH CARE EMPLOYERS IN SOUTHERN
22 COLORADO IN ORDER TO ENRICH THE COURSE WORK AVAILABLE IN
23 HEALTH EDUCATION PROGRAMS BY DEVELOPING INTERNSHIP
24 OPPORTUNITIES AND DEVELOPING OTHER COURSE WORK THAT INCLUDES
25 HANDS-ON EXPERIENCE WITH HEALTH CARE PROVIDERS;

26 (d) TO EXPLORE OPPORTUNITIES FOR DEVELOPING SHARED
27 FACILITIES, INCLUDING CLASSROOMS, CLINICAL LABORATORIES, LECTURE

1 HALLS, COMPUTER TRAINING ROOMS, AND OTHER EDUCATIONAL
2 FACILITIES;

3 (e) TO EXPLORE OPPORTUNITIES FOR PUBLIC-PRIVATE
4 PARTNERSHIPS FOR THE CREATION OF NEW FUNDING SOURCES AND
5 OPPORTUNITIES AND TO MAKE THE MOST EFFECTIVE USE OF SCARCE
6 RESOURCES TO CREATE OUTSTANDING PROGRAMS AND FACILITIES FOR
7 STUDENTS IN HEALTH EDUCATION PROGRAMS;

8 (f) TO DEVELOP PROGRAMS THAT FACILITATE STUDENTS'
9 TRANSITION FROM SCHOOL TO WORK IN HEALTH CARE CAREERS AND
10 ENABLE STUDENTS WHO GRADUATE FROM HEALTH EDUCATION PROGRAMS
11 TO FIND REWARDING EMPLOYMENT IN SOUTHERN COLORADO;

12 (g) TO IMPROVE THE OVERALL QUALITY OF THE HEALTH
13 EDUCATION PROGRAMS OFFERED BY THE PUBLIC EDUCATIONAL
14 INSTITUTIONS IN SOUTHERN COLORADO TO BETTER PREPARE STUDENTS TO
15 MEET THE CHALLENGING NEEDS OF THE HEALTH CARE INDUSTRY AND
16 THEREBY ENHANCE THE QUALITY AND AVAILABILITY OF HEALTH CARE FOR
17 PERSONS LIVING IN SOUTHERN COLORADO;

18 (h) TO PROMOTE COMMUNITY EDUCATION PROGRAMS CONCERNING
19 HEALTH CARE ISSUES FOR PERSONS LIVING IN SOUTHERN COLORADO;

20 (i) TO RECOMMEND TO THE GENERAL ASSEMBLY LEGISLATION
21 THAT WILL PROMOTE EXCELLENCE IN HEALTH EDUCATION PROGRAMS FOR
22 STUDENTS, RESIDENTS, AND PROFESSIONALS IN SOUTHERN COLORADO;

23 AND

24 (j) TO PROVIDE TO THE GENERAL ASSEMBLY AND THE COLORADO
25 COMMISSION ON HIGHER EDUCATION INFORMATION CONCERNING RURAL
26 HEALTH EDUCATION PROGRAM ISSUES AND OPPORTUNITIES.

27 (2) THE COUNCIL MAY FORM TASK FORCES, WHICH MAY INCLUDE

1 PERSONS WHO ARE NOT MEMBERS OF THE COUNCIL, FOR ASSISTANCE AS
2 NEEDED IN MEETING ITS PURPOSES. THE TASK FORCES SHALL WORK UNDER
3 THE DIRECTION OF THE COUNCIL AND MAY INCLUDE, BUT NEED NOT BE
4 LIMITED TO, TASK FORCES TO ADDRESS THE FOLLOWING ISSUES:

5 (a) NURSING EDUCATION AND INTEGRATION WITH THE HEALTH
6 CARE PROVIDER COMMUNITY TO ASSIST IN TRANSITIONS TO EMPLOYMENT
7 FOLLOWING GRADUATION;

8 (b) NEW DEGREE PROGRAMS FOR HEALTH CARE PROFESSIONALS;

9 (c) PROFESSIONAL DEVELOPMENT PROGRAMS FOR HEALTH CARE
10 PROFESSIONALS IN SOUTHERN COLORADO;

11 (d) COMMUNITY EDUCATION PROGRAMS CONCERNING HEALTH
12 CARE ISSUES; AND

13 (e) STRATEGIES FOR SHARING FACILITIES FOR HEALTH EDUCATION
14 PROGRAMS.

15 **23-74-106. Council for excellence in health careers education**
16 **- reporting requirements.** ON OR BEFORE MARCH 1, 2008, AND ON OR
17 BEFORE MARCH 1 EACH YEAR THEREAFTER, THE COUNCIL SHALL SUBMIT
18 TO THE EDUCATION COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND
19 THE SENATE, OR ANY SUCCESSOR COMMITTEES, AND TO THE COLORADO
20 COMMISSION ON HIGHER EDUCATION A REPORT EXPLAINING THE
21 ACTIVITIES OF THE COUNCIL AND ITS PROGRESS IN MEETING THE PURPOSES
22 AND ADDRESSING THE ISSUES SPECIFIED IN THIS ARTICLE. THE COUNCIL
23 SHALL ALSO MAKE THE REPORTS AVAILABLE PUBLICLY THROUGH THE
24 WEBSITES FOR ADAMS STATE COLLEGE AND TRINIDAD STATE JUNIOR
25 COLLEGE.

26 **23-74-107. Council for excellence in health careers education**
27 **- funding.** ADAMS STATE COLLEGE AND TRINIDAD STATE JUNIOR

1 COLLEGE ARE AUTHORIZED TO SEEK AND ACCEPT ON BEHALF OF THE
2 COUNCIL GIFTS, GRANTS, AND DONATIONS FROM PRIVATE OR PUBLIC
3 SOURCES FOR THE PURPOSES OF THIS ARTICLE, INCLUDING GIFTS, GRANTS,
4 OR DONATIONS THAT INCLUDE STATED CONDITIONS OF USE; EXCEPT THAT
5 A GIFT, GRANT, OR DONATION SHALL NOT BE ACCEPTED IF THE CONDITIONS
6 ATTACHED TO THE GIFT, GRANT, OR DONATION REQUIRE ITS EXPENDITURE
7 IN A MANNER CONTRARY TO LAW. SUBJECT TO APPROVAL OF THE
8 COUNCIL, ADAMS STATE COLLEGE AND TRINIDAD STATE JUNIOR COLLEGE
9 ARE FURTHER AUTHORIZED TO EXPEND ANY GIFTS, GRANTS, OR
10 DONATIONS ACCEPTED PURSUANT TO THIS SECTION. THE COUNCIL SHALL
11 INCLUDE IN THE ANNUAL REPORT REQUIRED IN SECTION 23-74-106 AN
12 ACCOUNTING OF ANY MONEYS RECEIVED PURSUANT TO THIS SECTION AND
13 HOW THEY WERE USED.

14 **23-74-108. Repeal of article.** THIS ARTICLE IS REPEALED,
15 EFFECTIVE JULY 1, 2012.

16 **SECTION 2. No appropriation.** The general assembly has
17 determined that this act can be implemented within existing
18 appropriations, and therefore no separate appropriation of state moneys
19 is necessary to carry out the purposes of this act.

20 **SECTION 3. Effective date.** This act shall take effect upon
21 passage.

22 **SECTION 4. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, and safety.
