**Bill Summary**

Changes the sunset review dates for the state board of nursing and the Colorado state board of chiropractic examiners from 2010 to 2009.

2           **SECTION 1.** 12-33-103 (3) (b), Colorado Revised Statutes, is  
3 amended to read:

4           **12-33-103. State board of chiropractic examiners - subject to**  
5 **termination - repeal of article.** (3) (b) This article is repealed, effective  
6 July 1, ~~2010~~ 2009.

7           **SECTION 2.** 12-38-133 (1), Colorado Revised Statutes, is  
8 amended to read:

9           **12-38-133. Repeal of article - review of functions.** (1) This  
10 article is repealed, effective July 1, ~~2010~~ 2009.

11           **SECTION 3.** 24-34-104 (40), Colorado Revised Statutes, is  
12 amended BY THE ADDITION OF THE FOLLOWING NEW  
13 PARAGRAPHS to read:

14           **24-34-104. General assembly review of regulatory agencies**  
15 **and functions for termination, continuation, or reestablishment.**

8 **SECTION 5. Effective date.** This act shall take effect at 12:01  
9 a.m. on the day following the expiration of the ninety-day period after  
10 final adjournment of the general assembly that is allowed for submitting  
11 a referendum petition pursuant to article V, section 1 (3) of the state  
12 constitution, (August 8, 2007, if adjournment sine die is on May 9, 2007);  
13 except that, if a referendum petition is filed against this act or an item,  
14 section, or part of this act within such period, then the act, item, section,  
15 or part, if approved by the people, shall take effect on the date of the  
16 official declaration of the vote thereon by proclamation of the governor.
