**A BILL FOR AN ACT**

101 **CONCERNING POSTING SEX OFFENDER REGISTRATION INFORMATION**  
102 **ON A LOCAL LAW ENFORCEMENT AGENCY WEBSITE.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)*

Requires a local law enforcement agency that chooses to post sex offender registration information on its website also to post educational information concerning protection from sex offenders or provide a link to the educational information included on the Colorado bureau of investigation website. Directs the local law enforcement agency to work with the sex offender management board and sexual assault victims' advocacy groups in preparing the educational information.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 16-22-112 (3) (b) and (3) (e), Colorado Revised  
3 Statutes, are amended, and the said 16-22-112 is further amended BY  
4 THE ADDITION OF A NEW SUBSECTION, to read:

5 **16-22-112. Release of information - law enforcement agencies.**

6 (3) (b) At its discretion, a local law enforcement agency may release  
7 information regarding any person registered with the local law  
8 enforcement agency pursuant to this article to any person who does not  
9 reside within the local law enforcement agency's jurisdiction or may post  
10 the information specified in ~~paragraph (e) of this subsection (3)~~  
11 PARAGRAPH (b) OF SUBSECTION (2) OF THIS SECTION on the law  
12 enforcement agency's website. If a local law enforcement agency does  
13 not elect to release information regarding any person registered with the  
14 local law enforcement agency to a person not residing within the local  
15 law enforcement agency's jurisdiction, the local law enforcement agency  
16 may submit a request from the person to the CBI.

18           (3.5) TO ASSIST MEMBERS OF THE PUBLIC IN PROTECTING  
19           THEMSELVES FROM PERSONS WHO COMMIT OFFENSES INVOLVING  
20           UNLAWFUL SEXUAL BEHAVIOR, A LOCAL LAW ENFORCEMENT AGENCY  
21           THAT CHOOSES TO POST SEX OFFENDER REGISTRATION INFORMATION ON  
22           ITS WEBSITE SHALL EITHER POST EDUCATIONAL INFORMATION  
23           CONCERNING PROTECTION FROM SEX OFFENDERS ON ITS WEBSITE OR  
24           PROVIDE A LINK TO THE EDUCATIONAL INFORMATION INCLUDED ON THE  
25           CBI WEBSITE MAINTAINED PURSUANT TO SECTION 16-22-111. A LOCAL  
26           LAW ENFORCEMENT AGENCY THAT POSTS THE EDUCATIONAL INFORMATION  
27           SHALL WORK WITH THE SEX OFFENDER MANAGEMENT BOARD CREATED

1 PURSUANT TO SECTION 16-11.7-103 AND SEXUAL ASSAULT VICTIMS'  
2 ADVOCACY GROUPS IN PREPARING THE EDUCATIONAL INFORMATION.

3 **SECTION 2. Safety clause.** The general assembly hereby finds,  
4 determines, and declares that this act is necessary for the immediate  
5 preservation of the public peace, health, and safety.
