After consideration on the merits, the Committee recommends the following:

HB07-1062 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend the Education Committee Report, dated February 8, 2007, page
- 2 1, strike lines 1 through 10 and substitute the following:
 - 3 "Amend printed bill, page 6, line 23, strike "COUNCILSORPARTNERSHIPS,"
 - 4 and substitute "COUNCILS,";
 - 5 line 24, strike "OF".
 - 6 Page 7, after line 11, insert the following:".
 - 7 Page 4 of the committee report, strike lines 7 through 9 and substitute the
 - 8 following:
 - 9 "Page 14, after line 8, insert the following:
 - 10 "(c) THE STATE DEPARTMENT IS AUTHORIZED TO ENTER INTO A
 - 11 SOLE-SOURCE CONTRACT WITH ANY COUNCIL TO INCREASE AND SUSTAIN
 - 12 THE QUALITY, ACCESSIBILITY, CAPACITY, AND AFFORDABILITY OF EARLY
 - 13 CHILDHOOD SERVICES FOR YOUNG CHILDREN AND THEIR PARENTS.";
 - 14 line 12, strike "CREATED" and substitute "ESTABLISHED, PURSUANT TO
 - 15 SECTION 24-44.5-101, IN THE OFFICE OF THE LIEUTENANT GOVERNOR";".
 - 16 Page 6 of the committee report, after line 18, insert the following:

1 "Page 22, strike lines 17 through 20."

2 Page 7 of the committee report, strike lines 15 and 16 and substitute the
3 following:

5 **SECTION 14. Appropriation - adjustments to the 2007 long**
6 **bill.** (1) In addition to any other appropriation, there is hereby
7 appropriated, out of any moneys in the general fund not otherwise
8 appropriated, to the early childhood cash fund created in section
9 26-6.5-109, Colorado Revised Statutes, for the fiscal year beginning July
10 1, 2007, the sum of one million twenty-six thousand one hundred
11 sixty-eight dollars (\$1,026,168), and such sum, or so much thereof as may
12 be necessary, is further appropriated to the department of human services,
13 division of child care for the implementation of this act.

14 (2) In addition to any other appropriation, there is hereby
15 appropriated, to the department of human services, division of child care,
16 for the fiscal year beginning, July 1, 2007, the sum of one million
17 twenty-six thousand one hundred sixty-nine dollars (\$1,026,169) federal
18 child care development funds and 1.0 FTE, or so much thereof as may be
19 necessary, for the implementation of this act.

20 (3) In addition to any other appropriation, there is hereby
21 appropriated to the department of education, for appropriated sponsored
22 programs, for the fiscal year beginning July 1, 2007, the sum of one
23 million nine hundred twenty thousand fifty-one dollars (\$1,920,051) and
24 1.0 FTE, or so much thereof as may be necessary, for the implementation
25 of this act. Said sum shall be from cash funds exempt received from the
26 department of human services out of the appropriations made in
27 subsections (1) and (2) of this section.

28 (4) In addition to any other appropriation, there is hereby
29 appropriated, to the governor-lieutenant governor-state planning and
30 budgeting, office of the lieutenant governor, for the fiscal year beginning
31 July 1, 2007, the sum of eighty thousand five hundred forty-three dollars
32 (\$80,543) and 1.0 FTE, or so much thereof as may be necessary, for the
33 implementation of this act. Said sum shall be from cash funds exempt
34 received from the department of human services out of the appropriation
35 made in subsection (2) of this section.

1 (5) For the implementation of this act, appropriations made in the
2 annual general appropriation act for the fiscal year beginning July 1,
3 2007, shall be adjusted as follows: The appropriation to the department
4 of human services, division of child care, for the child care assistance
5 program, is decreased by two million fifty-two thousand three hundred
6 thirty-seven dollars (\$2,052,337). Of said sum, one million twenty-six
7 thousand one hundred sixty-eight dollars (\$1,026,168) shall be from the
8 general fund and one million twenty-six thousand one hundred sixty-nine
9 dollars (\$1,026,169) shall be from federal child care development funds."

10 Renumber succeeding section accordingly.

11 Page 1, line 102, strike "COUNCILS." and substitute "COUNCILS AND
12 MAKING AN APPROPRIATION THEREFOR."."
