A BILL FOR AN ACT 101 CONCERNING THE CREATION OF A PILOT PROGRAM TO PROVIDE 102 MENTAL HEALTH SERVICES TO FAMILIES OF RECENTLY 103 DISCHARGED VETERANS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Creates a 3-year mental health services pilot program for spouses and dependent children ("families") of discharged veterans of operation enduring freedom and operation Iraqi freedom ("pilot program"). Authorizes the department of human services ("department") to purchase mental health services from community mental health centers in the Colorado Springs area for families of recently discharged veterans.

Requires participating community mental health centers to collect data on pilot program outcomes and submit a report to the department. Requires the department to make a report to the general assembly on the results of the pilot program prior to the repeal of the pilot program.

Creates a mental health services pilot program fund and a supplemental tobacco litigation settlement moneys account within the fund and, with limited and specified exceptions requires moneys in the fund and account to be used by the department to purchase mental health services for families of discharged veterans pursuant to the pilot program. Requires the lesser of a specified percentage or specified amount of the tobacco litigation settlement moneys to be allocated to a new short-term innovative health program grant fund under the provisions of Senate Bill 07-097, which is still pending approval by the General Assembly, to be credited to the account.
