#### A BILL FOR AN ACT

101 CONCERNING THE APPROPRIATION OF FUNDS TO THE CENTRAL FUND 102 FOR STATE NURSING HOMES.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Legislative Oversight Committee on State and Veterans Nursing Homes. Appropriates funds to the central fund for state nursing homes.

1 Be it enacted by the General Assembly of the State of Colorado:

1	SECTION 1. 26-12-108 (1), Colorado Revised Statutes, is
2	amended BY THE ADDITION OF A NEW PARAGRAPH to read:
3	26-12-108. Payments for care - funds - annual report -
4	collections for charges - central fund for state nursing homes created.
5	(1) (a.5) FOR THE FISCAL YEAR BEGINNING JULY 1, 2007, AND FOR EACH
6	FISCAL YEAR THEREAFTER, THE GENERAL ASSEMBLY SHALL APPROPRIATE
7	FROM THE GENERAL FUND TO THE CENTRAL FUND AN AMOUNT NOT
8	EXCEEDING TEN PERCENT OF THE TOTAL GROSS REVENUE ACCRUED BY THE
9	CENTRAL FUND DURING THE PRECEDING FISCAL YEAR AND NOT EXCEEDING
10	THE AMOUNT REQUESTED BY THE STATE DEPARTMENT IN COMPLIANCE
11	WITH THE STATE DEPARTMENT'S STANDARD BUDGET REQUEST PROCESS.
12	THE STATE DEPARTMENT SHALL USE THESE FUNDS TO PAY OPERATIONAL
13	EXPENSES OF, AND MAKE CAPITAL IMPROVEMENTS TO, THE STATE NURSING
14	HOMES.
15	SECTION 2. Effective date. This act shall take effect July 1,
16	2007.
17	SECTION 3. Safety clause. The general assembly hereby finds,
18	determines, and declares that this act is necessary for the immediate
19	preservation of the public peace, health, and safety.
