1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 2-5-126 (2), Colorado Revised Statutes, is amended  
3 BY THE ADDITION OF A NEW PARAGRAPH to read:

4 **2-5-126. Annual enactment of Colorado Revised Statutes -**  
5 **validation - effective date.** (2) The annual statutes, copies of which  
6 shall be delivered to each member of the general assembly, together with  
7 a listing of the revisor's changes, constitute the official report of the  
8 committee on legal services and are hereby enacted in accordance with  
9 this section as follows:

10 (k) **Colorado Revised Statutes 2007.** COLORADO REVISED  
11 STATUTES 2007, WHICH CONSISTS OF ALL OF THE LAWS OF THE STATE OF  
12 COLORADO OF A GENERAL AND PERMANENT NATURE ORIGINALLY  
13 ENACTED IN "COLORADO REVISED STATUTES 1973", INCLUDING  
14 SUBSEQUENT ENACTMENTS MADE PURSUANT TO SECTION 2-5-125, AND  
15 ALL OF THE LAWS OF THE STATE OF COLORADO OF A GENERAL AND  
16 PERMANENT NATURE ENACTED AT THE FIRST REGULAR SESSION OF THE  
17 SIXTY-SIXTH GENERAL ASSEMBLY. THE EFFECTIVE DATE FOR COLORADO  
18 REVISED STATUTES 2007 IS FIXED AS THE FIRST DAY THAT IS NOT A  
19 SATURDAY, SUNDAY, OR LEGAL HOLIDAY FOLLOWING THE EFFECTIVE  
20 DATE OF THIS PARAGRAPH (k).

21 **SECTION 2. Safety clause.** The general assembly hereby finds,  
22 determines, and declares that this act is necessary for the immediate  
23 preservation of the public peace, health, and safety.
