HB08-1115 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 3, strike lines 12 through 27 and substitute the

13 SECTION 17-1-116, C.R.S., THE SUM OF ONE HUNDRED TWENTY-FIVE
14 THOUSAND ONE HUNDRED SIXTY-FIVE DOLLARS (\$125,165).

15 (b) (I) FOR THE FISCAL YEAR BEGINNING JULY 1, 2009, IN
16 ADDITION TO ANY OTHER APPROPRIATION, THERE IS HEREBY
17 APPROPRIATED TO THE DEPARTMENT OF CORRECTIONS, OUT OF ANY
18 MONEYS IN THE GENERAL FUND NOT OTHERWISE APPROPRIATED, THE SUM
19 OF TWENTY-EIGHT THOUSAND SEVEN HUNDRED FIFTY-EIGHT DOLLARS
20 (\$28,758).

21 (c) (I) FOR THE FISCAL YEAR BEGINNING JULY 1, 2010, IN ADDITION
22 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED, FROM
23 THE CAPITAL CONSTRUCTION FUND CREATED IN SECTION 24-75-302,

1 C.R.S., TO THE CORRECTIONS EXPANSION RESERVE FUND CREATED IN
2 SECTION 17-1-116, C.R.S., THE SUM OF ONE HUNDRED TWELVE THOUSAND
3 SIX HUNDRED FORTY-NINE DOLLARS (\$112,649).

5 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE

7 FUND NOT OTHERWISE APPROPRIATED, THE SUM OF TWENTY-EIGHT
8 THOUSAND SEVEN HUNDRED FIFTY-EIGHT DOLLARS (\$28,758).

10 ADDITION TO ANY OTHER APPROPRIATION, THERE IS HEREBY
11 APPROPRIATED TO THE DEPARTMENT OF CORRECTIONS, OUT OF ANY
12 MONEYS IN THE GENERAL FUND NOT OTHERWISE APPROPRIATED, THE SUM
13 OF FIFTY-FOUR THOUSAND SIX HUNDRED FORTY DOLLARS (\$54,640).

14 (e) (I) FOR THE FISCAL YEAR BEGINNING JULY 1, 2012, IN ADDITION
15 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED, FROM
16 THE CAPITAL CONSTRUCTION FUND CREATED IN SECTION 24-75-302,
17 C.R.S., TO THE CORRECTIONS EXPANSION RESERVE FUND CREATED IN
18 SECTION 17-1-116, C.R.S., THE SUM OF ONE HUNDRED TWELVE THOUSAND
19 SIX HUNDRED FORTY-NINE DOLLARS (\$112,649).
