Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB08-1325 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the State, Veterans, and Military Affairs Committee Report, dated
2 March 18, 2008, page 6, line 18, after the period, add "A FAMILY MEMBER
3 OF AN EMPLOYEE MAY PARTICIPATE IN THE PROGRAM ONLY IF THE FAMILY
4 MEMBER ALSO QUALIFIES FOR AND IS ISSUED A CURRENT H-2A VISA.";

5 line 31, after the period, insert "MEMBERS OF THE ADVISORY COUNCIL ARE
6 ENTITLED TO REIMBURSEMENT FOR ACTUAL AND NECESSARY EXPENSES
7 INCURRED IN THE PERFORMANCE OF THEIR DUTIES.".

8 Page 11, after line 15, insert the following:

9 **"SECTION 3. Appropriation - adjustments to the 2008 long**
10 **bill.** (1) In addition to any other appropriation, there is hereby
11 appropriated, out of any moneys in the nonimmigrant agricultural
12 seasonal worker pilot program cash fund created in section 8-3.5-108,
13 Colorado Revised Statutes, not otherwise appropriated, to the department
14 of labor and employment, for allocation to the division of employment
15 and training, for state operations, for the fiscal year beginning July 1,
16 2008, the sum of seventy-seven thousand seven hundred twenty-five
17 dollars (\$77,725) and 1.0 FTE, or so much thereof as may be necessary,
18 for the implementation of this act.

19 (2) In addition to any other appropriation, there is hereby
20 appropriated, out of any moneys in the nonimmigrant agricultural

1 seasonal worker pilot program cash fund created in section 8-3.5-108,
2 Colorado Revised Statutes, not otherwise appropriated, to the department
3 of labor and employment, for allocation to the executive director's office,
4 for legal services, for the fiscal year beginning July 1, 2008, the sum of
5 four thousand three hundred twenty-two dollars (\$4,322), or so much
6 thereof as may be necessary, for the implementation of this act.

7 (3) In addition to any other appropriation, there is hereby
8 appropriated to the department of law, for the fiscal year beginning July
9 1, 2008, the sum of four thousand three hundred twenty-two dollars
10 (\$4,322), or so much thereof as may be necessary, for the provision of
11 legal services to the department of labor and employment related to the
12 implementation of this act. Said sum shall be from reappropriated funds
13 received from the department of labor and employment out of the
14 appropriation made in subsection (2) of this section.

15 (4) In addition to any other appropriation, there is hereby
16 appropriated, out of any moneys in the general fund not otherwise
17 appropriated, to the legislative department, for allocation to legislative
18 council, for the fiscal year beginning July 1, 2008, the sum of seven
19 thousand twenty dollars (\$7,020), or so much thereof as may be
20 necessary, for the implementation of this act.

21 (5) For the implementation of this act, the general fund
22 appropriation to the controlled maintenance trust fund made in section 20
23 of the annual general appropriation act, for the fiscal year beginning July
24 1, 2008, shall be decreased by seven thousand twenty dollars (\$7,020).".

25 Renumber succeeding section accordingly.

26 Page 11, after line 18, insert the following:

27 "Page 1, line 102, strike "**PROGRAM.**" and substitute "**PROGRAM, AND**
28 **MAKING AN APPROPRIATION THEREFOR.**".".
