Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB08-200 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Business, Labor and Technology Committee Report, dated  
2 March 19, 2008, page 3, after line 4, insert the following:

3           **"SECTION 34. Appropriation - adjustments to the 2008 long**  
4 **bill.** (1) In addition to any other appropriation, there is hereby  
5 appropriated, out of any moneys in the general fund not otherwise  
6 appropriated, to the department of regulatory agencies, for allocation to  
7 the executive director's office, for legal services, for the fiscal year  
8 beginning July 1, 2008, the sum of sixty thousand seventy-three dollars  
9 (\$60,073), or so much thereof as may be necessary, for the  
10 implementation of this act.

11           (2) In addition to any other appropriation, there is hereby  
12 appropriated, out of any moneys in the general fund not otherwise  
13 appropriated, to the department of regulatory agencies, for allocation to  
14 the civil rights division, for the enforcement of prohibitions against  
15 discrimination, for the fiscal year beginning July 1, 2008, the sum of  
16 twenty-one thousand seven hundred thirty-two dollars (\$21,732) and 0.4  
17 FTE, or so much thereof as may be necessary, for the implementation of  
18 this act.

19           (3) In addition to any other appropriation, there is hereby  
20 appropriated to the department of law, for the fiscal year beginning July  
21 1, 2008, the sum of sixty thousand seventy-three dollars (\$60,073) and 0.5

1 FTE, or so much thereof as may be necessary, for the provision of legal  
2 services to the department of regulatory agencies related to the  
3 implementation of this act. Said sum shall be from reappropriated funds  
4 received from the executive director's office out of the appropriation  
5 made in subsection (1) of this section.

6 (4) For the implementation of this act, the general fund  
7 appropriation to the controlled maintenance trust fund made in section 20  
8 of the annual general appropriation act, for the fiscal year beginning July  
9 1, 2008, shall be decreased by eighty-one thousand eight hundred five  
10 dollars (\$81,805).".

11 Renumber succeeding sections of the Committee Report accordingly.

12 Page 3 of the Committee Report, after line 12, insert the following:

13 "Page 1, line 102, strike "**DISCRIMINATION.**" and substitute  
14 "**DISCRIMINATION, AND MAKING AN APPROPRIATION THEREFOR.**".".
