**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)*

Reinstates the requirement that a registered installer of manufactured homes seeking renewal of registration provide a letter of credit, certificate of deposit, or surety bond at the time of applying for renewal. Allows the division of housing or its independent contractor to decide whether or not to inspect a manufactured home installation upon request filed by the owner, installer, manufacturer, or retailer of the manufactured home instead of requiring the division or its contractor to

2           **SECTION 1.** 24-32-3315 (6), Colorado Revised Statutes, is
