A BILL FOR AN ACT

101 **CONCERNING THE SEARCH PROCESS FOR LEADERSHIP POSITIONS**
102 **WITHIN STATE INSTITUTION OF HIGHER EDUCATION SYSTEMS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Requires the chair of the governing board (board) of an institution of higher education system or institution of higher education (institution) to appoint a search committee (committee) when there is an open president or chancellor position. Directs that the committee shall have 6 months, or as much time as necessary, to complete its search.

Directs the committee to:

! Advertise the search nationally, regionally, and statewide;

Shading denotes HOUSE amendment. Double underlining denotes SENATE amendment.
*Capital letters indicate new material to be added to existing statute.
Dashes through the words indicate deletions from existing statute.*

- ! Determine the qualifications for the position; and
- ! Direct all aspects of the search.

Requires the committee to keep the names of the applicants and nominees confidential. Directs the committee to review the applications and nominations and select at least 3 qualified candidates to interview with the committee. Instructs the committee to select at least 3, but no more than 5, nominees to send to the board. Requires the committee to provide the board a report with its nominations. Permits the board to require the committee to interview an applicant or nominee not interviewed by the committee and provide a recommendation on that individual.

Requires the board to select the finalists to be interviewed and to make those finalists' identities public. Directs the finalists to make a public presentation to the institution community before any vote is taken by the board. Permits the board to interview the finalists in executive session. Requires an affirmative two-thirds vote to select the new president or chancellor.

Makes conforming amendments.

5 **College and University President and Chancellor Search**

6 **23-5.5-101. Legislative declaration.** (1) THE GENERAL
7 ASSEMBLY HEREBY FINDS THAT:

8 (a) THE STATE INSTITUTIONS OF HIGHER EDUCATION ARE
9 ENTRUSTED WITH THE CRITICAL RESPONSIBILITIES OF PROVIDING THE
10 HIGHEST QUALITY POSTSECONDARY EDUCATION TO THE MEN AND WOMEN
11 OF THE STATE AND OF ENSURING, TO THE FULLEST EXTENT POSSIBLE, THAT
12 THEY ARE WELL PREPARED TO FULFILL THEIR ROLES AS PROFESSIONALS IN
13 THE WORKFORCE AND AS ACTIVE, CONTRIBUTING CITIZENS OF THE STATE;

14 (b) IN ADDITION TO ENSURING THAT STUDENTS RECEIVE A QUALITY
15 EDUCATION, THE STATE INSTITUTIONS OF HIGHER EDUCATION MUST ALSO

1 STRIVE TO PROVIDE THAT EDUCATION IN THE MOST EFFICIENT, MOST
2 COST-EFFECTIVE MANNER TO PROVIDE THE GREATEST POSSIBLE DEGREE OF
3 STUDENT ACCESS AND ENSURE THE UTMOST INTEGRITY AND EFFICIENCY
4 IN THE USE OF TAXPAYER AND TUITION DOLLARS;

5 (c) TO ACCOMPLISH THESE GOALS AND CONTINUOUSLY BUILD THE
6 CAPACITY AND REPUTATION OF AN INSTITUTION OF HIGHER EDUCATION, IT
7 IS IMPERATIVE THAT THE CHIEF EXECUTIVE OFFICER OF THE INSTITUTION
8 DEMONSTRATE OUTSTANDING QUALITIES OF LEADERSHIP, MANAGEMENT,
9 AND VISION;

10 (d) THE SELECTION PROCESS FOR LEADERS OF THE STATE
11 INSTITUTIONS OF HIGHER EDUCATION MUST BE CONSISTENT AMONG THE
12 STATE INSTITUTIONS, INCORPORATING THE BEST SEARCH PRACTICES OF
13 EACH INSTITUTION;

14 (e) THE SELECTION PROCESS MUST ALSO BE THOROUGH, INCLUSIVE,
15 AND AS TRANSPARENT AS POSSIBLE, WHILE STILL PRESERVING TO THE
16 EXTENT NECESSARY CANDIDATES' PRIVACY AND CONFIDENTIALITY;

17 (f) A SELECTION PROCESS THAT MEETS THESE REQUIREMENTS WILL
18 BE MOST LIKELY TO IDENTIFY THE MOST HIGHLY QUALIFIED AVAILABLE
19 LEADERSHIP TALENT AND TO ENSURE THAT THOSE CANDIDATES ARE
20 SELECTED AS STEWARDS FOR THE HIGHER EDUCATION INSTITUTIONS OF
21 COLORADO.

22 (2) THEREFORE, THE GENERAL ASSEMBLY CONCLUDES THAT IT IS
23 IN THE BEST INTERESTS OF THE STATE OF COLORADO TO ENACT A
24 CONSISTENT EMPLOYMENT SEARCH PROCESS, WHICH INCORPORATES THE
25 BEST EMPLOYMENT SEARCH PRACTICES, FOR GOVERNING BOARDS TO
26 APPLY IN SELECTING THE PRESIDENTS AND CHANCELLORS OF THE STATE
27 INSTITUTIONS OF HIGHER EDUCATION.

1 **23-5.5-102. Open leadership position - governing board -**
2 **search committee - timing.** (1) WHEN AN INSTITUTION OF HIGHER
3 EDUCATION SYSTEM OR AN INSTITUTION OF HIGHER EDUCATION HAS AN
4 OPENING FOR THE POSITION OF PRESIDENT OR CHANCELLOR, THE CHAIR OF
5 THE GOVERNING BOARD OF THAT SYSTEM OR INSTITUTION SHALL APPOINT
6 A SEARCH COMMITTEE, INCLUDING THE CHAIR OF THE COMMITTEE. THE
7 SEARCH COMMITTEE SHALL BE BROADLY REPRESENTATIVE OF THE
8 GOVERNING BOARD AND THE SYSTEM OR INSTITUTIONAL FACULTY AND
9 ADMINISTRATION. THE SEARCH COMMITTEE MAY ALSO INCLUDE ALUMNI
10 OF THE SYSTEM OR INSTITUTION, MEMBERS OF THE LOCAL OR STATE
11 COMMUNITY, AS APPROPRIATE TO THE INSTITUTION'S MISSION, MEMBERS
12 OF THE STUDENT BODY OF THE SYSTEM OR INSTITUTION, AND THE SYSTEM
13 OR INSTITUTIONAL STAFF.

14 (2) ONCE THE SEARCH COMMITTEE IS APPOINTED PURSUANT TO
15 SUBSECTION (1) OF THIS SECTION, THE SEARCH COMMITTEE SHALL HAVE
16 AT LEAST SIX MONTHS OR AS MUCH TIME AS MAY BE REASONABLY
17 NECESSARY TO COMPLETE THE SEARCH PROCESS. THE SEARCH COMMITTEE
18 SHALL PROVIDE SUFFICIENT TIME FOR ADVANCED ADVERTISING AND
19 SEARCH ACTIVITIES THAT WILL FACILITATE THE WIDEST POSSIBLE NOTICE
20 OF VACANCIES AND FOR EXTENSIVE ACTIVITIES TO ATTRACT
21 HIGH-QUALITY AND DIVERSE NOMINEES AND APPLICANTS.

22 **23-5.5-103. Search committee - duties - search confidentiality**
23 **- interviews - recommendations.** (1) THE SEARCH COMMITTEE
24 APPOINTED PURSUANT TO SECTION 23-5.5-102 (1) SHALL HAVE THE
25 FOLLOWING DUTIES:

26 (a) TO DETERMINE THE QUALIFICATIONS FOR THE OPEN POSITION
27 AND THE REQUIRED MATERIALS THAT AN APPLICANT MUST SUBMIT IN

1 SUPPORT OF HIS OR HER APPLICATION;

2 (b) TO ADVERTISE THE OPEN POSITION ON A NATIONWIDE,
3 REGIONAL, AND STATEWIDE BASIS AND INVITE INTERESTED, QUALIFIED
4 AND DIVERSE PERSONS TO APPLY FOR THE POSITION OR TO NOMINATE
5 OTHERS;

6 (c) TO ENCOURAGE THE SYSTEM'S OR INSTITUTION'S
7 STAKEHOLDERS TO NOMINATE QUALIFIED AND DIVERSE INDIVIDUALS FOR
8 THE OPEN POSITION; AND

9 (d) TO DIRECT ALL ASPECTS OF THE SEARCH AS NECESSARY.

10 (2) THE SEARCH COMMITTEE SHALL KEEP ALL INFORMATION
11 CONCERNING APPLICANTS AND NOMINEES STRICTLY CONFIDENTIAL.

12 (3) THE SEARCH COMMITTEE SHALL REVIEW THE APPLICATIONS
13 AND SUPPORTING MATERIALS ON APPLICANTS AND NOMINEES. AFTER THE
14 REVIEW, THE SEARCH COMMITTEE SHALL INTERVIEW THE QUALIFIED
15 APPLICANTS AND NOMINEES WHO DEMONSTRATE THE HIGHEST LIKELIHOOD
16 OF SERVING SUCCESSFULLY AND WITH DISTINCTION IN THE OPEN POSITION.
17 AT A MINIMUM, THE SEARCH COMMITTEE SHALL INTERVIEW THREE
18 QUALIFIED APPLICANTS OR NOMINEES. THE SEARCH COMMITTEE SHALL
19 RECOMMEND THE PERSON ONLY IF A MAJORITY OF THE SEARCH
20 COMMITTEE MEMBERS AGREE THAT THE PERSON IS FULLY QUALIFIED TO
21 SERVE IN THE OPEN POSITION. IN ALL INSTANCES, IT IS ANTICIPATED THAT
22 THE CANDIDATES MOST HIGHLY RECOMMENDED BY THE COMMITTEE WILL
23 BE THE ONLY CANDIDATES INTERVIEWED BY THE GOVERNING BOARD.

24 (4) AFTER COMPLETING THE INTERVIEW PROCESS, THE SEARCH
25 COMMITTEE SHALL TRANSMIT TO THE GOVERNING BOARD THE NAMES OF
26 AT LEAST THREE, BUT NO MORE THAN FIVE, PERSONS WHO THE SEARCH
27 COMMITTEE NOMINATES AS FULLY QUALIFIED TO SERVE IN THE OPEN

1 POSITION. THE SEARCH COMMITTEE SHALL ALSO PROVIDE TO THE
2 GOVERNING BOARD A REPORT DETAILING THE SEARCH COMMITTEE'S
3 PROCESS, IDENTIFYING THOSE PERSONS WHO APPLIED OR WERE
4 NOMINATED AND THOSE WHO WERE INTERVIEWED, AND EXPLAINING THE
5 SEARCH COMMITTEE'S RATIONALE FOR THE NOMINATIONS. IN MAKING ITS
6 NOMINATIONS, THE SEARCH COMMITTEE SHALL BASE ITS DECISIONS ON
7 ASSISTING THE GOVERNING BOARD IN SELECTING A HIGHLY QUALIFIED
8 PERSON TO SERVE IN THE OPEN POSITION.

9 (5) IF, AFTER RECEIVING THE REPORT PURSUANT TO SUBSECTION
10 (4) OF THIS SECTION, THE GOVERNING BOARD DETERMINES THAT AN
11 APPLICANT OR NOMINEE WHO WAS NOT INTERVIEWED BY THE SEARCH
12 COMMITTEE SHOULD BE INTERVIEWED BY THE SEARCH COMMITTEE, THE
13 SEARCH COMMITTEE SHALL INTERVIEW THE APPLICANT OR NOMINEE, VOTE
14 ON THE APPLICANT OR NOMINEE, AND ADVISE THE GOVERNING BOARD ON
15 THE OUTCOME OF THE VOTE.

16 **23-5.5-104. Governing board selection - process.** (1) AFTER
17 RECEIVING AND REVIEWING THE SEARCH COMMITTEE'S NOMINATIONS AND
18 REPORT PURSUANT TO SECTION 23-5.5-103 (4) AND THE OUTCOME OF ANY
19 INTERVIEWS CONDUCTED PURSUANT TO SECTION 23-5.5-103 (5), THE
20 GOVERNING BOARD SHALL SELECT THE FINALISTS TO INTERVIEW FROM
21 AMONG THE NOMINATIONS PROVIDED PURSUANT TO SECTION 23-5.5-103
22 (4) AND SECTION 23-5.5-103 (5) AND MAKE THE NAMES OF THE FINALISTS
23 PUBLIC. THE GOVERNING BOARD SHALL SELECT THE MOST HIGHLY
24 QUALIFIED NOMINEES TO INTERVIEW.

25 (2) EACH FINALIST SHALL MAKE A PUBLIC PRESENTATION TO THE
26 SYSTEM'S OR INSTITUTION'S COMMUNITY. THE PRESENTATION SHALL
27 OCCUR BEFORE ANY SELECTION VOTE IS TAKEN BY THE GOVERNING

1 BOARD.

2 (3) THE GOVERNING BOARD MAY INTERVIEW THE FINALISTS IN
3 EXECUTIVE SESSION.

4 (4) THE AFFIRMATIVE VOTE OF TWO-THIRDS OF THE MEMBERS OF
5 THE GOVERNING BOARD SHALL BE NECESSARY TO SELECT A QUALIFIED
6 FINALIST FOR THE OPEN POSITION.

7 **SECTION 2.** 23-20-106, Colorado Revised Statutes, is amended
8 to read:

9 **23-20-106. President - election.** The regents of the university,
10 PURSUANT TO THE PROCESS SPECIFIED IN ARTICLE 5.5 OF THIS TITLE, shall
11 elect a president of the university, who shall be an employee-at-will
12 pursuant to section 24-19-104, C.R.S., and whose employment shall be
13 subject to the restrictions imposed by article 19 of title 24, C.R.S. The
14 president shall be the principal executive officer of the university and a
15 member of the faculty thereof and shall carry out the policies and
16 programs established by the board of regents.

17 **SECTION 3.** 23-20-112, Colorado Revised Statutes, is amended
18 to read:

19 **23-20-112. General powers of the board.** The board of regents
20 shall enact laws for the government of the university; ELECT, PURSUANT
21 TO THE PROCESS SPECIFIED IN ARTICLE 5.5 OF THIS TITLE, A CHIEF
22 EXECUTIVE OFFICER FOR EACH CAMPUS OF THE UNIVERSITY; appoint the
23 requisite number of professors, tutors, and all other officers; and
24 determine the salaries of such officers and the amount to be paid for
25 tuition in accordance with the level of cash fund appropriations set by the
26 general assembly for the university pursuant to section 23-1-104 (1) (a)
