Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB09-1039 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the State, Veterans & Military Affairs Committee Report, dated
2 April 15, 2009, page 2, after line 7, insert the following:

3 "Page 2 of the reengrossed bill, line 4, strike "(1)" and substitute "(1) (a)";
4 strike lines 5 through 14 and substitute the following:

5 "CONTRARY, BEGINNING WITH THE FALL SEMESTER OF THE 2009-2010
6 ACADEMIC YEAR, THE GOVERNING BOARD OF EACH STATE INSTITUTION OF
7 HIGHER EDUCATION IN COLORADO SHALL ADOPT A POLICY THAT GRANTS
8 IN-STATE TUITION STATUS TO AN HONORABLY DISCHARGED MEMBER OF
9 THE ARMED FORCES OF THE UNITED STATES WHO ENROLLS IN SAID STATE
10 INSTITUTION OF HIGHER EDUCATION AND WHO MEETS, FOR ANY LENGTH OF
11 TIME, THE PRESUMPTIONS AND RULES FOR MAINTAINING A DOMICILE IN
12 COLORADO DESCRIBED IN SECTION 23-7-103.

13 (b) NOTWITHSTANDING ANY PROVISION OF THIS ARTICLE TO THE
14 CONTRARY, BEGINNING WITH THE FALL SEMESTER OF THE 2009-2010
15 ACADEMIC YEAR, THE GOVERNING BOARD OF EACH STATE INSTITUTION OF
16 HIGHER EDUCATION IN COLORADO MAY ADOPT A POLICY THAT GRANTS
17 IN-STATE TUITION STATUS TO A DEPENDENT OF AN HONORABLY
18 DISCHARGED MEMBER OF THE ARMED FORCES OF THE UNITED STATES WHO
19 ENROLLS IN SAID STATE INSTITUTION OF HIGHER EDUCATION IF THE SAID
20 HONORABLY DISCHARGED MEMBER OF THE ARMED FORCES MEETS, FOR

1 ANY LENGTH OF TIME, THE PRESUMPTIONS AND RULES FOR MAINTAINING
2 A DOMICILE IN COLORADO DESCRIBED IN SECTION 23-7-103.";

3 page 2 of the reengrossed bill, line 17, strike "CLASSIFICATION," and
4 substitute "CLASSIFICATION;"

5 strike line 18 and substitute "EXCEPT THAT, BEGINNING WITH THE FALL
6 SEMESTER OF THE 2011-2012 ACADEMIC YEAR, UPON SUCH
7 CLASSIFICATION AS AN IN-STATE STUDENT PURSUANT TO THIS SECTION,
8 THE STUDENT SHALL ALSO BE ELIGIBLE TO RECEIVE A STIPEND FROM".

9 Amend reengrossed bill, page 2, strike lines 21 through 27 and substitute
10 the following:

11 **"SECTION 2. Adjustment to the 2009 long bill.** For the
12 implementation of this act, cash fund appropriations made in the annual
13 general appropriation act for the fiscal year beginning July 1, 2009, from
14 the students' share of tuition, to the department of higher education,
15 governing boards, shall be reduced as follows:

16 (1) for the trustees of adams state college thirty-eight thousand
17 three hundred seventy dollars (\$38,370);

18 (2) for the trustees of mesa state college, seventy thousand one
19 hundred eighty-four dollars (\$70,184);

20 (3) for the trustees of metropolitan state college of Denver, sixty
21 thousand nine hundred fifty-six dollars (\$60,956);

22 (4) for the trustees of western state college, eight thousand nine
23 hundred seventy-six dollars (\$8,976);

24 (5) for the trustees of fort lewis college, one hundred ninety-seven
25 thousand fifty-six dollars (\$197,056);

26 (6) for the board of governors of the Colorado state university
27 system, seven hundred twenty-one thousand nine hundred ninety-three
28 dollars (\$721,993);

29 (7) for the board of regents of the university of Colorado, seven
30 hundred twenty-six thousand ninety-seven dollars (\$726,097);

1 (8) for the trustees of the Colorado school of mines, forty-two
2 thousand twenty-four dollars (\$42,024); and,

3 (9) for the state board of community colleges and occupational
4 education state system community colleges, ten thousand eight hundred
5 fifty-six dollars (\$10,856).".

6 Page 3, strike lines 1 through 9.
