A BILL FOR AN ACT

101 **CONCERNING CONTINUATION OF PET ANIMAL CARE REGULATION, AND**
102 **MAKING AN APPROPRIATION THEREFOR.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Sunset Process - Senate Agriculture and Natural Resources Committee. Implements the recommendations of the department of regulatory agencies in its sunset review of the "Pet Animal Care and Facilities Act" (PACFA) as follows:

- ! Continues PACFA and its functions through July 1, 2014.
- ! Directs the commissioner of the department of agriculture (commissioner) to set fees at sufficient levels for

- record-keeping and support technology upgrades.
- ! Continues the pet animal advisory committee indefinitely.
- ! Repeals the specific authorization of the commissioner's authority to consider the effect of a civil penalty on a person's ability to stay in business prior to imposing such penalty.
- ! Removes the statutory renewal date for licenses issued under the PACFA and authorizes the commissioner to set such date by rule.
- ! Changes the destination of civil fines collected pursuant to violations of the PACFA from the pet animal care and facility fund to the general fund.
- ! Allows persons breeding turtles to possess turtles with carapaces of less than 4 inches.
- ! Adds rats and gerbils to the definition of "pet animal".
- ! Requires licensees to display signage containing contact information for PACFA administrators.

15 (1) All fees ~~and civil fines~~ collected pursuant to this article shall be
16 transmitted to the state treasurer who shall credit the same to the pet
17 animal care and facility fund, which fund is hereby created. All moneys
18 credited to the fund shall be a part of the fund and shall not be transferred
19 or credited to the general fund or to any other fund except as directed by
20 the general assembly acting by bill. Notwithstanding the provisions of
21 this section to the contrary, all interest derived from the deposit and
22 investment of this fund shall be credited to the general fund, in
23 accordance with section 24-36-114, C.R.S. The general assembly shall
24 make annual appropriations from the fund to the department of
25 agriculture for direct and indirect expenses incurred in carrying out the
26 purposes of this section.

27 (2) ALL CIVIL FINES COLLECTED PURSUANT TO THIS ARTICLE SHALL

6 law, it is unlawful and a violation of this article for any person or entity:

7 (j) To sell, barter, exchange, or otherwise transfer, possess,
8 import, or cause to be imported into this state:

9 (I) Any type of turtle with a length in carapace of less than four
10 inches; EXCEPT THAT A PERSON MAY POSSESS A TURTLE THAT THE PERSON
11 HAS BRED WITH A LENGTH IN CARAPACE OF LESS THAN FOUR INCHES; or

12 (II) (B) Such prohibitions, with respect to nonhuman primates,
13 shall not apply to a ~~zoological park or a research institute~~ FACILITY OR
14 EXHIBITOR PROPERLY licensed or registered under the provisions of the
15 federal "Animal Welfare Act of 1970", 7 U.S.C. sec. 2131 et seq., as
16 amended, nor shall they apply to the keeping of a nonhuman primate as
17 a household pet by any person who owned such primate on or before July
18 1, 1973, or to the keeping by a disabled person of a nonhuman primate
19 specially trained to assist such person.

20 **SECTION 14.** 35-80-102 (10), Colorado Revised Statutes, is
21 amended to read:

22 **35-80-102. Definitions.** As used in this article, unless the context
23 otherwise requires:

24 (10) "Pet animal" means dogs, cats, rabbits, guinea pigs, hamsters,
25 mice, RATS, GERBILS, ferrets, birds, fish, reptiles, amphibians, and
26 invertebrates, or any other species of wild or domestic or hybrid animal
27 sold, transferred, or retained for the purpose of being kept as a household

1 pet, except livestock, as defined in subsection (9) of this section. "Pet
2 animal" does not include an animal that is used for working purposes on
3 a farm or ranch.

4 **SECTION 15.** 35-80-105, Colorado Revised Statutes, is amended
5 BY THE ADDITION OF A NEW SUBSECTION to read:

6 **35-80-105. Pet animal facility - licensure requirements -**
7 **application - fees.** (8) EACH PET ANIMAL FACILITY LICENSED PURSUANT
8 TO THIS ARTICLE SHALL DISPLAY IN A CONSPICUOUS PLACE SIGNAGE THAT
9 CONTAINS CONTACT INFORMATION FOR THE OFFICE OR OTHER
10 APPROPRIATE DEPARTMENT SUBDIVISION THAT ADMINISTERS THIS
11 ARTICLE.

12 **SECTION 16. Appropriation - adjustments to the 2009 long**
13 **bill.** (1) For the implementation of this act, appropriations made in the
14 general appropriation act for the fiscal year beginning July 1, 2009, shall
15 be adjusted as follows: The cash funds appropriation to the department
16 of agriculture, agricultural services division, from the pet animal care and
17 facility fund created in section 35-80-116, Colorado Revised Statutes, is
18 increased by the sum of forty-six thousand seventeen dollars (\$46,017)
19 and 1.0 FTE.

20 **SECTION 17. Effective date.** This act shall take effect July 1,
21 2009.

22 **SECTION 18. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, and safety.
