A BILL FOR AN ACT

101 **CONCERNING AN INCREASE IN THE MOTOR VEHICLE REGISTRATION FEE**
102 **TO FUND THE EMERGENCY MEDICAL SERVICES ACCOUNT WITHIN**
103 **THE HIGHWAY USERS TAX FUND, AND MAKING AN**
104 **APPROPRIATION IN CONNECTION THEREWITH.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Increases the motor vehicle registration fee from \$1.00 to \$2.00 to fund the emergency medical services account within the highway users tax fund.

Dashes through the words indicate deletions from existing statute.*

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 42-3-304 (21), Colorado Revised Statutes, is
3 amended to read:

4 **42-3-304. Registration fees - passenger and passenger-mile**
5 **taxes - clean screen fund.** (21) In order to promote an effective
6 emergency medical network and thus the maintenance and supervision of
7 the highways throughout the state, in addition to any other fees imposed
8 by this section, there shall be assessed an additional fee of ~~one dollar~~ TWO
9 DOLLARS at the time of registration of any motor vehicle. Such fee shall
10 be transmitted to the state treasurer, who shall credit the same to the
11 emergency medical services account created by section 25-3.5-603,
12 C.R.S., within the highway users tax fund.

13 **SECTION 2. Appropriation.** In addition to any other
14 appropriation, there is hereby appropriated, out of any moneys in the
15 emergency medical services account within the highway users tax fund
16 created in section 25-3.5-603 (1) (a), Colorado Revised Statutes, not
17 otherwise appropriated, to the department of public health and
18 environment, health facilities and emergency medical services division,
19 for the fiscal year beginning July 1, 2009, the sum of four million nine
20 hundred thirteen thousand nine hundred twenty-three dollars (\$4,913,923)
21 cash funds and 3.0 FTE, or so much thereof as may be necessary, for the
22 purposes set forth in section 25-3.5-603, Colorado Revised Statutes.

23 **SECTION 3. Safety clause.** The general assembly hereby finds,
24 determines, and declares that this act is necessary for the immediate
25 preservation of the public peace, health, and safety.
