After consideration on the merits, the Committee recommends the following:

SB09-051 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend reengrossed bill, page 4, line 10, strike "(3) and (4)," and
2 substitute "(2), (3), and (4),";

3 after line 12, insert the following:

4 "(2) "Certified contractor" means:

5 (a) A contractor, including but not limited to a general, heating,
6 air conditioning, or lighting contractor, certified by the program
7 administrator to market the program to potential qualified borrowers and
8 make clean energy improvements that may be financed by clean energy
9 loans; AND

10 (b) A MANUFACTURER OR DEALER OF MANUFACTURED HOMES, AS
11 DEFINED IN SECTION 24-32-3302, WHO IS CERTIFIED BY THE PROGRAM
12 ADMINISTRATOR TO MARKET THE PROGRAM TO POTENTIAL QUALIFIED
13 BORROWERS AND MAKE CLEAN ENERGY IMPROVEMENTS THAT MAY BE
14 FINANCED BY CLEAN ENERGY LOANS."

15 Page 6, strike lines 13 through 19 and substitute the following:

16 "(II) SUCH INVESTMENTS SHALL BE SUBJECT TO THE STATE
17 TREASURER'S DISCRETION AND SHALL COMPLY WITH THE QUALIFICATIONS
18 FOR STATE INVESTMENTS LISTED IN SECTION 24-36-113."

- 1 Page 11, line 5, strike "(1) (d)".
- 2 Page 12, strike lines 10 through 27.
- 3 Page 13, strike lines 1 through 7.
- 4 Page 14, line 23, after "(III)", insert "THE QUALIFYING RETAIL UTILITY
5 MAY ESTABLISH ONE OR MORE STANDARD OFFERS TO PURCHASE
6 RENEWABLE ENERGY CREDITS GENERATED FROM THE ELIGIBLE SOLAR
7 ELECTRIC GENERATION ON THE CUSTOMER'S PREMISES SO LONG AS THE
8 GENERATION MEETS THE SIZE AND LOCATION REQUIREMENTS SET FORTH
9 IN SUBPARAGRAPH (II) OF THIS PARAGRAPH (e) AND SO LONG AS THE
10 GENERATION IS FIVE HUNDRED KILOWATTS OR LESS IN SIZE. WHEN
11 ESTABLISHING THE STANDARD OFFERS, THE PRICES FOR RENEWABLE
12 ENERGY CREDITS SHOULD BE SET AT LEVELS SUFFICIENT TO ENCOURAGE
13 INCREASED CUSTOMER-SITED SOLAR GENERATION IN THE SIZE RANGES
14 COVERED BY EACH STANDARD OFFER, BUT AT LEVELS THAT WILL STILL
15 ALLOW THE QUALIFYING RETAIL UTILITY TO COMPLY WITH THE ELECTRIC
16 RESOURCE STANDARDS SET FORTH IN PARAGRAPH (c) OF THIS SUBSECTION
17 (1) WITHOUT EXCEEDING THE RETAIL RATE IMPACT LIMIT IN PARAGRAPH
18 (g) OF THIS SUBSECTION (1)".
- 19 Page 15, line 1, strike "REBATE".
