After consideration on the merits, the Committee recommends the following:

HB09-1326 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 5, after line 3, insert the following:
- 2       "(b) BEGINNING WITH THE 2010 GENERAL ELECTION:
- 3           (I) EACH PROPOSED CHANGE TO THE STATE CONSTITUTION,
- 4 WHETHER INITIATED BY THE PEOPLE OR REFERRED TO THE PEOPLE BY THE
- 5 GENERAL ASSEMBLY, SHALL BE IDENTIFIED ON THE BALLOT AS AN
- 6 "AMENDMENT"; AND
- 7           (II) EACH PROPOSED CHANGE TO THE COLORADO REVISED
- 8 STATUTES, WHETHER INITIATED BY THE PEOPLE OR REFERRED TO THE
- 9 PEOPLE BY THE GENERAL ASSEMBLY, SHALL BE IDENTIFIED ON THE BALLOT
- 10 AS A "PROPOSITION".
- 11 Page 6, line 8, strike "(B)" and substitute "(b)".
- 12 Page 7, strike lines 24 through 27.
- 13 Page 8, strike lines 1 through 5.
- 14 Page 10, line 6, strike "STATEWIDE BALLOTS IN ELECTIONS PRIOR TO AND";
- 15 line 7, strike "INCLUDING" and substitute "THE STATEWIDE BALLOT AT".

1 Page 17, strike lines 24 and 25.

2 Page 27, line 19, strike "LICENSE IF:" and substitute "LICENSE:";

3 strike lines 20 and 21 and substitute the following:

4 "(I) UNLESS THE PETITION ENTITY AGREES THAT IT SHALL NOT PAY  
5 A CIRCULATOR MORE THAN TWENTY PERCENT OF HIS OR HER  
6 COMPENSATION ON A PER SIGNATURE OR PER PETITION BASIS; OR";

7 line 22, strike "NO" and substitute "IF NO".

8 Page 30, after line 17, insert the following:

9 "SECTION 19. 32-9-119.3 (2), Colorado Revised Statutes, as  
10 enacted by Senate Bill 09-108, enacted in 2009, is amended to read:

11 **32-9-119.3. Elections for sales tax rate increase.** (2) A ballot  
12 question submitted pursuant to subsection (1) of this section shall be  
13 submitted at a general election or an election held on the first Tuesday of  
14 November in an odd-numbered year that is conducted in accordance with  
15 the "Uniform Election Code of 1992", articles 1 to 13 of title 1, C.R.S.  
16 The secretary of state shall determine the identifying numbering or  
17 lettering of such a ballot question, and the question shall be printed upon  
18 the ballot immediately following any statewide ~~issues and questions~~  
19 AMENDMENTS AND PROPOSITIONS."

20 Renumber succeeding sections accordingly.

21 Page 31, line 16, strike "11" and substitute "12".
