A BILL FOR AN ACT

101 **CONCERNING AN EXTENSION OF FEES ON CERTAIN IDENTIFICATION**
102 **DOCUMENTS ISSUED BY THE DEPARTMENT OF REVENUE TO FUND**
103 **IDENTIFICATION SECURITY, AND MAKING AN APPROPRIATION IN**
104 **CONNECTION THEREWITH.**

Bill Summary

Extends the 60-cent identification security fund surcharge for driver's licenses and identification cards until July 1, 2014.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 42-1-220 (3), Colorado Revised Statutes, is
3 amended to read:

4 **42-1-220. Identification security fund - repeal.** (3) This section
5 is repealed, effective July 1, ~~2009~~ 2014.

6 **SECTION 2.** 42-2-114 (2) (a) (I) (F), Colorado Revised Statutes,
7 is amended to read:

8 **42-2-114. License issued - fees - repeal.** (2) (a) (I) Except as
9 provided in subsection (3) of this section:

10 (F) In addition to the fees imposed in sub-subparagraphs (A) to
11 (D) of this subparagraph (I), the fee for the issuance of a minor driver's
12 or driver's license shall include a sixty-cent surcharge. The moneys
13 collected pursuant to the surcharge shall be forwarded to the department
14 for transmission to the state treasurer, who shall credit the same to the
15 identification security fund created in section 42-1-220. This
16 sub-subparagraph (F) is repealed, effective July 1, ~~2009~~ 2014.

17 **SECTION 3.** 42-2-306 (1) (a) (V), Colorado Revised Statutes, is
18 amended to read:

19 **42-2-306. Fees - disposition - repeal.** (1) The department shall
20 charge and collect the following fees:

21 (a) (V) (A) In addition to the fees imposed in subparagraphs (I) to
22 (III) of this paragraph (a), the fee for the issuance of an identification card
23 shall include a sixty-cent surcharge. Such surcharge shall be forwarded
24 to the department for transmission to the state treasurer, who shall credit
25 the same to the identification security fund created in section 42-1-220.

26 (B) This subparagraph (V) is repealed, effective July 1, ~~2009~~
27 2014.

1 **Section 4. Appropriation-adjustments in long bill.** (1) In
2 addition to any other appropriation, there is hereby appropriated, out of
3 any moneys in the identification security fund created in Section 42-1-220
4 (1), Colorado Revised Statutes, not otherwise appropriated, to the
5 department of revenue, division of motor vehicles, driver and vehicle
6 services, for the fiscal year beginning July 1, 2009, the sum of two
7 hundred ninety-two thousand eight hundred seven dollars (\$292,807), or
8 so much thereof as may be necessary, for the purpose of providing
9 identification security in driver's license and other identification
10 documents.

11 (2) For the purpose of adjusting appropriations to reflect the
12 extension of fees pursuant to this bill, the general fund appropriation
13 made in the annual appropriation act, for the fiscal year beginning July 1,
14 2009, to the department of revenue, division of motor vehicles, driver and
15 vehicle services shall be reduced by the sum of two hundred ninety-two
16 thousand eight hundred seven dollars (\$292,807).

17 **SECTION 5. Effective date.** This act shall take effect July 1,
18 2009.

19 **SECTION 6. Safety clause.** The general assembly hereby finds,
20 determines, and declares that this act is necessary for the immediate
21 preservation of the public peace, health, and safety.
