A BILL FOR AN ACT

101 **CONCERNING MEASURES TO RAISE THE GRADUATION RATE IN PUBLIC**
102 **HIGH SCHOOLS IN COLORADO.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Creates the office of dropout prevention and student re-engagement (office) in the department of education (department) to collaborate with local education providers (LEPs) to reduce the student dropout rate and increase the student graduation and completion rates. Specifies the office's duties. Directs the office to identify high priority and priority LEPs to receive technical assistance and support from the office.

Shading denotes HOUSE amendment. Double underlining denotes SENATE amendment.
Capital letters indicate new material to be added to existing statute.
Dashes through the words indicate deletions from existing statute.

Requires the office to compile a report of effective dropout prevention and student engagement and re-engagement policies based on research and data. Specifies the uses for the report, and directs the office to publish the report on the internet.

Requires the office annually to analyze attendance data and assess the incidence, causes, and effects of student dropout, engagement, and re-engagement. Directs the office annually to report the assessment and any recommended strategies to address student dropout, engagement, and re-engagement to LEPS, the state board of education (state board), the governor, and the education committees of the general assembly.

Requires each high priority and priority LEP to conduct a practices assessment and to adopt a student graduation and completion plan (plan). Sets deadlines for completing the practices assessment and plan, and specifies the items the practices assessment must address and the plan must include. Directs the department to provide technical assistance to high priority and priority LEPS and to provide each high priority and priority LEP a template for the practices assessment, which template includes available student data. Directs each high priority and priority LEP to submit its practices assessment and its plan to the department for publication on the internet. Directs the office to evaluate each high priority and priority LEP's plan as part of the accreditation review process.

Requires each LEP to adopt a policy to provide notice to a student's parent if the student drops out of school. Specifies that the notice shall include information concerning educational alternatives that are available to the student.

Creates the student re-engagement grant program (program) to provide moneys to LEPS to use in providing educational services and supports to students to maintain student engagement and support student re-engagement. Directs the state board to adopt rules to implement the program, including the information to be included in grant applications. Creates the student re-engagement grant program fund, and allows the department to use up to 3% of the amount annually appropriated from the fund to offset the costs of implementing the program. Requires the department to evaluate the services provided by grant recipients and to report the evaluation results to the education committees of the general assembly.

Requires the office to submit an annual report to the state board, the governor, and the education committees of the general assembly making state policy findings and recommendations to reduce the student dropout rate and increase the student graduation and completion rates. Specifies the minimum contents of the report. Specifies that the reporting requirement shall not expire within 3 years.

Repeals the mandate to expel an habitually disruptive student, and allows a school district to suspend the student. Repeals the requirement

that a suspension or expulsion count as an unexcused absence under a school district's attendance policy.

Makes conforming amendments.

5 **Dropout Prevention and Student Re-engagement**

6 **22-14-101. Legislative declaration.** (1) THE GENERAL
7 ASSEMBLY HEREBY FINDS THAT:

8 (a) THE STATE OF COLORADO HAS PLACED A HIGH PRIORITY ON
9 REDUCING THE NUMBER OF STUDENT DROPOUTS IN COLORADO, INCLUDING
10 ESTABLISHING THE GOAL OF DECREASING THE HIGH SCHOOL DROPOUT
11 RATE BY HALF BY THE 2017-18 ACADEMIC YEAR;

12 (b) THE COLORADO DEPARTMENT OF EDUCATION REPORTS THAT
13 THE STATEWIDE GRADUATION RATE FOR COLORADO HIGH SCHOOLS FOR
14 THE 2006-07 SCHOOL YEAR WAS SEVENTY-FIVE PERCENT, AN
15 IMPROVEMENT OF NINE-TENTHS OF A PERCENTAGE POINT OVER THE
16 PREVIOUS SCHOOL YEAR;

17 (c) ALTHOUGH THE OVERALL GRADUATION RATE MAY HAVE
18 IMPROVED, SERIOUS GAPS CONTINUE TO EXIST IN THE GRADUATION RATES
19 AMONG ETHNIC AND ECONOMIC GROUPS AND, OVERALL, TWENTY-FIVE
20 PERCENT OF THE HIGH SCHOOL STUDENTS IN COLORADO ARE NOT
21 GRADUATING FROM HIGH SCHOOL WITHIN FOUR YEARS;

22 (d) STUDENTS WITH DISABILITIES ALSO CONTINUE TO ACHIEVE A
23 SIGNIFICANTLY LOWER GRADUATION RATE THAN OTHER STUDENT GROUPS.

24 **THE GRADUATION RATE FOR COLORADO STUDENTS WITH DISABILITIES IS**

1 SIXTY-THREE AND SEVEN-TENTHS PERCENT, COMPARED WITH A
2 STATEWIDE GRADUATION RATE OF SEVENTY-FIVE PERCENT.

3 (e) ACCORDING TO THE 2007 COLORADO YOUTH RISK BEHAVIOR
4 SURVEY, APPROXIMATELY ONE OUT OF TEN STUDENTS DID NOT GO TO
5 SCHOOL ONE OR MORE DAYS IN A THIRTY-DAY PERIOD BECAUSE THEY FELT
6 UNSAFE AT SCHOOL OR IN TRAVELING TO OR FROM SCHOOL. THIS
7 STATISTIC INDICATES THAT, TO IMPROVE STUDENT ATTENDANCE AND
8 GRADUATION RATES, SCHOOLS AND SCHOOL DISTRICTS MUST ADDRESS
9 SCHOOL SAFETY ISSUES AS WELL AS STUDENT LEARNING AND
10 ENGAGEMENT ISSUES.

11 (f) STUDIES CLEARLY SHOW THAT A STUDENT'S LEVEL OF
12 EDUCATION ATTAINMENT WILL DIRECTLY INFLUENCE THE STUDENT'S
13 LEVEL OF ACHIEVEMENT AND SUCCESS THROUGHOUT THE REST OF HIS OR
14 HER LIFE;

15 (g) THE NATIONAL CENTER FOR EDUCATION STATISTICS REPORTS
16 THAT, IN COMPARING EMPLOYMENT RATES AND LEVELS OF EDUCATION
17 ATTAINMENT ACROSS THE COUNTRY, IN 2005, THE UNEMPLOYMENT RATE
18 FOR PERSONS WHO DROPPED OUT OF HIGH SCHOOL WAS SEVEN AND
19 SIX-TENTHS PERCENT, COMPARED TO AN OVERALL AVERAGE
20 UNEMPLOYMENT RATE FOR ALL EDUCATION LEVELS OF FOUR PERCENT;
21 AND

22 (h) STUDIES FURTHER SHOW THAT STUDENTS WHO DROP OUT OF
23 SCHOOL ARE MORE LIKELY TO BE INVOLVED IN CRIME OR DELINQUENCY
24 AND TO LOSE LIFELONG OPPORTUNITIES FOR PERSONAL ACHIEVEMENT,
25 RESULTING IN ECONOMIC AND SOCIAL COSTS TO THE STATE.

26 (2) THE GENERAL ASSEMBLY THEREFORE CONCLUDES THAT:

27 (a) IT IS IMPERATIVE THAT THE DEPARTMENT OF EDUCATION

1 CREATE AN OFFICE OF DROPOUT PREVENTION AND STUDENT
2 RE-ENGAGEMENT TO PROVIDE FOCUS, COORDINATION, RESEARCH, AND
3 LEADERSHIP TO ASSIST LOCAL EDUCATION PROVIDERS IN IMPLEMENTING
4 COORDINATED EFFORTS TO REDUCE THE HIGH SCHOOL DROPOUT RATE AND
5 INCREASE THE HIGH SCHOOL GRADUATION AND COMPLETION RATES AND
6 THE LEVELS OF STUDENT ENGAGEMENT AND RE-ENGAGEMENT;

7 (b) TO SIGNIFICANTLY REDUCE THE STATEWIDE DROPOUT RATE
8 AND INCREASE THE RATES OF STUDENT ENGAGEMENT AND
9 RE-ENGAGEMENT, THE OFFICE OF DROPOUT PREVENTION AND STUDENT
10 RE-ENGAGEMENT MUST ALSO PROVIDE LEADERSHIP IN CREATING AND
11 FACILITATING SYSTEMIC APPROACHES THAT INVOLVE INTERSYSTEM
12 COLLABORATION BETWEEN LOCAL EDUCATION PROVIDERS AND THE
13 FOSTER CARE AND CHILD WELFARE SYSTEMS, THE JUVENILE JUSTICE
14 SYSTEM, THE DIVISION OF YOUTH SERVICES IN THE DEPARTMENT OF
15 HUMAN SERVICES, INSTITUTIONS OF HIGHER EDUCATION, CAREER AND
16 TECHNICAL EDUCATION PROVIDERS, ADULT BASIC EDUCATION, GENERAL
17 EDUCATIONAL DEVELOPMENT CERTIFICATE, AND
18 ENGLISH-AS-A-SECOND-LANGUAGE PROGRAMS, OFFICES OF WORKFORCE
19 DEVELOPMENT, SCHOOL-BASED STUDENT SUPPORT PERSONNEL, EXTENDED
20 LEARNING OPPORTUNITY AND FAMILY EDUCATION PROGRAMS, GENERAL
21 EDUCATIONAL DEVELOPMENT PROGRAMS, AND FACILITY SCHOOLS.

22 **22-14-102. Definitions.** AS USED IN THIS ARTICLE, UNLESS THE
23 CONTEXT OTHERWISE REQUIRES:

24 (1) "COMPLETION" MEANS A STUDENT GRADUATES FROM HIGH
25 SCHOOL OR RECEIVES A CERTIFICATE OR OTHER DESIGNATION OF HIGH
26 SCHOOL COMPLETION SUCH AS A GENERAL EDUCATIONAL DEVELOPMENT
27 CERTIFICATE.

1 (2) "DEPARTMENT" MEANS THE DEPARTMENT OF EDUCATION
2 CREATED AND EXISTING PURSUANT TO SECTION 24-1-115, C.R.S.

3 (3) "DROPOUT PREVENTION" MEANS SCHOOL AND
4 COMMUNITY-BASED INITIATIVES TO PROMOTE POSITIVE SOCIAL,
5 EMOTIONAL, FAMILIAL, AND EDUCATIONAL FACTORS THAT MAINTAIN AND
6 STRENGTHEN STUDENT ENGAGEMENT AND ADDRESS BARRIERS AND
7 CONDITIONS THAT MAY LEAD A STUDENT TO DROP OUT OF SCHOOL.

8 (4) "EXTENDED LEARNING OPPORTUNITY PROGRAMS" MEANS
9 PROGRAMS THAT PROVIDE KINDERGARTEN-THROUGH-TWELFTH-GRADE
10 SUPERVISED LEARNING ACTIVITIES THAT MAY INCLUDE, BUT NEED NOT BE
11 LIMITED TO, AFTER-SCHOOL PROGRAMS, BEFORE-SCHOOL PROGRAMS,
12 SUMMER SCHOOL PROGRAMS, WEEKEND PROGRAMS, AND EXTENDED-DAY
13 AND EXTENDED-YEAR PROGRAMS.

14 (5) "GRADUATION" MEANS A STUDENT MEETS THE LOCALLY
15 DEFINED REQUIREMENTS FOR A HIGH SCHOOL DIPLOMA.

16 (6) "GRANT PROGRAM" MEANS THE STUDENT RE-ENGAGEMENT
17 GRANT PROGRAM ESTABLISHED IN SECTION 22-14-109.

18 (7) "HIGH PRIORITY LOCAL EDUCATION PROVIDER" MEANS A LOCAL
19 EDUCATION PROVIDER THAT THE OFFICE IDENTIFIES PURSUANT TO SECTION
20 22-14-103 (4) AS BEING MOST IN NEED OF TECHNICAL ASSISTANCE AND
21 SUPPORT.

22 (8) "LOCAL EDUCATION PROVIDER" MEANS A SCHOOL DISTRICT, A
23 BOARD OF COOPERATIVE SERVICES CREATED PURSUANT TO ARTICLE 5 OF
24 THIS TITLE, OR THE STATE CHARTER SCHOOL INSTITUTE CREATED
25 PURSUANT TO SECTION 22-30.5-503.

26 (9) "OFFICE" MEANS THE OFFICE OF DROPOUT PREVENTION AND
27 STUDENT RE-ENGAGEMENT CREATED WITHIN THE DEPARTMENT OF

1 EDUCATION PURSUANT TO SECTION 22-14-103.

2 (10) "PARENT" MEANS A STUDENT'S BIOLOGICAL OR ADOPTIVE
3 PARENT OR THE STUDENT'S LEGAL GUARDIAN OR LEGAL CUSTODIAN.

4 (11) "PRIORITY LOCAL EDUCATION PROVIDER" MEANS A LOCAL
5 EDUCATION PROVIDER THAT THE OFFICE IDENTIFIES PURSUANT TO SECTION
6 22-14-103 (4) AS BEING IN SIGNIFICANT NEED OF TECHNICAL ASSISTANCE
7 AND SUPPORT.

8 (12) "STATE BOARD" MEANS THE STATE BOARD OF EDUCATION
9 CREATED AND EXISTING PURSUANT TO SECTION 1 OF ARTICLE IX OF THE
10 STATE CONSTITUTION.

11 (13) "STUDENT ENGAGEMENT" MEANS A STUDENT'S SENSE OF
12 BELONGING, SAFETY, AND INVOLVEMENT IN SCHOOL THAT LEADS TO
13 ACADEMIC ACHIEVEMENT, REGULAR SCHOOL ATTENDANCE, AND
14 GRADUATION. ELEMENTS OF PROMOTING STUDENT ENGAGEMENT INCLUDE
15 PROVIDING RIGOROUS AND RELEVANT INSTRUCTION, CREATING POSITIVE
16 RELATIONSHIPS WITH TEACHERS AND COUNSELORS, PROVIDING SOCIAL
17 AND EMOTIONAL SUPPORT SERVICES FOR STUDENTS AND THEIR FAMILIES,
18 CREATING PARTNERSHIPS WITH COMMUNITY ORGANIZATIONS AND
19 FAMILIES THAT FOSTER LEARNING OUTSIDE OF THE CLASSROOM, AND
20 CULTIVATING REGULAR SCHOOL ATTENDANCE.

21 (14) "STUDENT GRADUATION AND COMPLETION PLAN" MEANS A
22 LOCAL EDUCATION PROVIDER'S PLAN, CREATED PURSUANT TO SECTION
23 22-14-107, FOR REDUCING THE STUDENT DROPOUT RATE AND INCREASING
24 THE RATES OF STUDENT ENGAGEMENT, RE-ENGAGEMENT, GRADUATION,
25 AND COMPLETION.

26 (15) "STUDENT RE-ENGAGEMENT" MEANS THAT A STUDENT
27 REENROLLS IN HIGH SCHOOL AFTER DROPPING OUT PRIOR TO COMPLETION.

1 STUDENT RE-ENGAGEMENT USUALLY RESULTS FROM A LOCAL EDUCATION
2 PROVIDER'S USE OF EVIDENCE- OR RESEARCH-BASED STRATEGIES TO
3 REACH OUT TO STUDENTS WHO HAVE DROPPED OUT OF SCHOOL AND TO
4 ASSIST THEM IN TRANSITIONING BACK INTO SCHOOL AND OBTAINING THEIR
5 HIGH SCHOOL DIPLOMAS OR OTHERWISE COMPLETING HIGH SCHOOL.

6 (16) "STUDENT SUPPORT PERSONNEL" MEANS A STATE-LICENSED
7 OR STATE-CERTIFIED SCHOOL COUNSELOR, SCHOOL PSYCHOLOGIST,
8 SCHOOL SOCIAL WORKER, OR SCHOOL NURSE, OR OTHER STATE-LICENSED
9 OR STATE-CERTIFIED MENTAL HEALTH PROFESSIONAL QUALIFIED UNDER
10 STATE LAW TO PROVIDE SUPPORT SERVICES TO CHILDREN AND
11 ADOLESCENTS.

12 **22-14-103. Office of dropout prevention and student**
13 **re-engagement - created - purpose - duties.** (1) (a) THERE IS HEREBY
14 CREATED WITHIN THE DEPARTMENT OF EDUCATION THE OFFICE OF
15 DROPOUT PREVENTION AND STUDENT RE-ENGAGEMENT. THE HEAD OF THE
16 OFFICE SHALL BE THE DIRECTOR OF THE OFFICE OF DROPOUT PREVENTION
17 AND STUDENT RE-ENGAGEMENT AND SHALL BE APPOINTED BY THE
18 COMMISSIONER OF EDUCATION IN ACCORDANCE WITH SECTION 13 OF
19 ARTICLE XII OF THE STATE CONSTITUTION. THE OFFICE OF DROPOUT
20 PREVENTION AND STUDENT RE-ENGAGEMENT SHALL CONSIST OF THE
21 DIRECTOR AND AN ASSISTANT DIRECTOR WHO SHALL BE APPOINTED BY THE
22 DIRECTOR. THE COMMISSIONER MAY ASSIGN OR OTHERWISE DIRECT
23 OTHER PERSONNEL WITHIN THE DEPARTMENT TO ASSIST THE DIRECTOR
24 AND ASSISTANT DIRECTOR IN MEETING THE RESPONSIBILITIES OF THE
25 OFFICE.

26 (b) THE OFFICE OF DROPOUT PREVENTION AND STUDENT
27 RE-ENGAGEMENT AND THE DIRECTOR OF THE OFFICE SHALL EXERCISE

1 THEIR POWERS AND PERFORM THEIR DUTIES AND FUNCTIONS UNDER THE
2 DEPARTMENT OF EDUCATION, THE COMMISSIONER OF EDUCATION, AND THE
3 STATE BOARD OF EDUCATION AS IF THE SAME WERE TRANSFERRED TO THE
4 DEPARTMENT OF EDUCATION BY A **TYPE 2** TRANSFER AS DEFINED IN THE
5 "ADMINISTRATIVE ORGANIZATION ACT OF 1968", ARTICLE 1 OF TITLE 24,
6 C.R.S.

7 (c) THE DEPARTMENT IS STRONGLY ENCOURAGED TO DIRECT, TO
8 THE EXTENT POSSIBLE, ANY INCREASES IN THE AMOUNT OF FEDERAL
9 MONEYS RECEIVED BY THE DEPARTMENT FOR PROGRAMS UNDER TITLE I,
10 PART A OF THE "ELEMENTARY AND SECONDARY EDUCATION ACT OF
11 1965", 20 U.S.C. SEC. 6301 ET SEQ., PROGRAMS UNDER THE "INDIVIDUALS
12 WITH DISABILITIES EDUCATION ACT", 20 U.S.C., SEC. 1400, ET SEQ., OR
13 OTHER FEDERAL PROGRAMS TO ASSIST IN FUNDING THE ACTIVITIES OF THE
14 OFFICE AS SPECIFIED IN THIS ARTICLE.

15 (d) THE DEPARTMENT SHALL SEEK AND MAY ACCEPT AND EXPEND
16 GIFTS, GRANTS, AND DONATIONS FROM PUBLIC OR PRIVATE ENTITIES TO
17 FUND THE OPERATIONS OF THE OFFICE, INCLUDING THE PERSONNEL FOR
18 THE OFFICE AND EXECUTION OF THE DUTIES AND RESPONSIBILITIES
19 SPECIFIED IN THIS ARTICLE. NOTWITHSTANDING ANY PROVISION OF THIS
20 ARTICLE TO THE CONTRARY, THE DEPARTMENT IS NOT REQUIRED TO
21 IMPLEMENT THE PROVISIONS OF THIS ARTICLE UNTIL SUCH TIME AS THE
22 DEPARTMENT HAS RECEIVED AN AMOUNT IN GIFTS, GRANTS, AND
23 DONATIONS FROM PUBLIC OR PRIVATE ENTITIES THAT THE DEPARTMENT
24 DEEMS SUFFICIENT TO ADEQUATELY FUND THE OPERATIONS OF THE OFFICE.

25 (2) THE OFFICE SHALL COLLABORATE WITH LOCAL EDUCATION
26 PROVIDERS TO REDUCE THE STATEWIDE AND LOCAL STUDENT DROPOUT
27 RATES AND TO INCREASE THE STATEWIDE AND LOCAL GRADUATION AND

1 COMPLETION RATES IN ACCORDANCE WITH THE GOALS SPECIFIED IN
2 SECTION 22-14-101. TO ACCOMPLISH THIS PURPOSE, THE OFFICE SHALL
3 ASSIST LOCAL EDUCATION PROVIDERS IN:

4 (a) ANALYZING STUDENT DATA PERTAINING TO STUDENT DROPOUT
5 RATES, GRADUATION RATES, COMPLETION RATES, MOBILITY RATES,
6 TRUANCY RATES, SUSPENSION AND EXPULSION RATES, SAFETY OR
7 DISCIPLINE INCIDENCES, AND STUDENT ACADEMIC GROWTH DATA AT THE
8 STATE AND LOCAL LEVELS; AND

9 (b) CREATING AND EVALUATING STUDENT GRADUATION AND
10 COMPLETION PLANS.

11 (3) TO ACCOMPLISH THE PURPOSES SPECIFIED IN SUBSECTION (2)
12 OF THIS SECTION, THE OFFICE SHALL ALSO:

13 (a) REVIEW STATE POLICIES AND ASSIST LOCAL EDUCATION
14 PROVIDERS IN REVIEWING THEIR POLICIES PERTAINING TO ATTENDANCE,
15 TRUANCY, DISCIPLINARY ACTIONS UNDER THE LOCAL EDUCATION
16 PROVIDER'S CODE OF CONDUCT, BEHAVIORAL EXPECTATIONS, DROPOUT
17 PREVENTION, AND STUDENT ENGAGEMENT AND RE-ENGAGEMENT TO
18 IDENTIFY EFFECTIVE STRATEGIES FOR AND BARRIERS TO REDUCING THE
19 STUDENT DROPOUT RATES AND INCREASING STUDENT ENGAGEMENT AND
20 RE-ENGAGEMENT WITHIN THE STATE;

21 (b) IDENTIFY AND RECOMMEND, AS PROVIDED IN SECTION
22 22-14-104, BEST PRACTICES AND EFFECTIVE STRATEGIES TO REDUCE
23 STUDENT DROPOUT RATES AND INCREASE STUDENT ENGAGEMENT AND
24 RE-ENGAGEMENT;

25 (c) DEVELOP INTERAGENCY AGREEMENTS AND OTHERWISE
26 COOPERATE WITH OTHER STATE AND FEDERAL AGENCIES AND WITH
27 PRIVATE, NONPROFIT AGENCIES TO COLLECT AND REVIEW STUDENT DATA

1 AND DEVELOP AND RECOMMEND METHODS FOR REDUCING STUDENT
2 DROPOUT RATES AND INCREASING STUDENT ENGAGEMENT AND
3 RE-ENGAGEMENT. THE OFFICE SHALL, TO THE EXTENT POSSIBLE,
4 COLLABORATE WITH, AT A MINIMUM:

5 (I) CAREER AND TECHNICAL EDUCATION PROVIDERS;

6 (II) GENERAL EDUCATIONAL DEVELOPMENT SERVICE PROVIDERS;

7 (III) THE PREVENTION SERVICES DIVISION IN THE DEPARTMENT OF
8 PUBLIC HEALTH AND ENVIRONMENT;

9 (IV) THE DIVISION OF YOUTH CORRECTIONS AND OTHER AGENCIES
10 WITHIN THE JUVENILE JUSTICE SYSTEM;

11 (V) THE DEPARTMENT OF CORRECTIONS;

12 (VI) THE JUDICIAL DEPARTMENT;

13 (VII) INSTITUTIONS OF HIGHER EDUCATION;

14 (VIII) OFFICES OF WORKFORCE DEVELOPMENT;

15 (IX) EXTENDED LEARNING OPPORTUNITY AND FAMILY EDUCATION
16 PROGRAMS;

17 (X) ADULT BASIC EDUCATION AND


