After consideration on the merits, the Committee recommends the following:

HB10-1330 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, strike line 17 and substitute "DATABASE."
- 2 Page 3, strike lines 3 and 4 and substitute:
 - 3 "(II) A REPRESENTATIVE OF A STATEWIDE ASSOCIATION OF
 - 4 HOSPITALS;"
- 5 Page 4, line 21, strike "2016." and substitute "2013."
- 6 Page 5, line 2, after "PAYERS," insert "PROVIDERS,"
- 7 Page 5, line 22, strike "PROVIDER" and substitute "OTHER PUBLICLY
- 8 AVAILABLE".
- 9 Page 5, line 25, strike "THE INCLUSION OF" and substitute "WHETHER TO
- 10 INCLUDE".
- 11 Page 6, after line 12 insert:
 - 12 "(3) THE ADVISORY COMMITTEE SHALL MAKE RECOMMENDATIONS
 - 13 TO THE EXECUTIVE DIRECTOR TO DETERMINE HOW THE ONGOING
 - 14 OVERSIGHT OF THE OPERATIONS OF THE ALL-PAYER HEALTH CLAIMS
 - 15 DATABASE SHOULD FUNCTION."

1 Renumber succeeding subsections accordingly.

2 Page 6, strike lines 22 and 23 and substitute:

3 "(5) IF SUFFICIENT FUNDING IS RECEIVED, THE EXECUTIVE
4 DIRECTOR SHALL DIRECT THE ADMINISTRATOR TO CREATE THE DATABASE
5 AND THE ADMINISTRATOR SHALL:".

6 Page 6, line 24, after "COLLECTED" insert "FROM PAYERS".

7 Page 7, line 17, after "PUBLIC" insert "WITH RECOMMENDATIONS FROM
8 THE ADVISORY COMMITTEE".

9 Page 8, line 5, strike "CHANGES" and substitute "CHANGES, WITH INPUT
10 FROM THE ADVISORY COMMITTEE OR ITS SUCCESSOR GOVERNANCE
11 ENTITY,".

12 Page 8, line 11, strike "ADMINISTRATOR:" and substitute
13 "ADMINISTRATOR, WITH INPUT FROM THE ADVISORY COMMITTEE:".

14 Page 8, line 12, after "UTILIZE" insert "PUBLICLY".

15 Page 8, line 17, strike "A DATA SOURCE" and substitute "PAYER DATA
16 SOURCES".

17 Page 8, line 22, strike "NATIONAL" and substitute "NATIONAL, REGIONAL,
18 AND OTHER UNIFORM ALL-PAYER CLAIMS DATABASES".

19 Page 9, line 27, strike "AN ENTITY" and substitute "A PAYER".

20 Page 10, after line 1 insert:

21 "(10) THIS SECTION IS REPEALED, JANUARY 1, 2012, UNLESS THE
22 EXECUTIVE DIRECTOR NOTIFIES THE REVISOR OF STATUTES ON OR BEFORE
23 SUCH DATE THAT SUFFICIENT FUNDING TO CREATE THE DATABASE, AS
24 DETERMINED BY THE EXECUTIVE DIRECTOR, ADVISORY COMMITTEE, AND
25 ADMINISTRATOR, HAS BEEN RECEIVED THROUGH GIFTS, GRANTS, AND
26 DONATIONS.

27 (11) IF AT ANY TIME, THERE IS NOT SUFFICIENT FUNDING TO
28 FINANCE THE ONGOING OPERATIONS OF THE DATABASE, THE DATABASE

1 SHALL CEASE OPERATING AND THE ADVISORY COMMITTEE AND
2 ADMINISTRATOR SHALL NO LONGER HAVE THE DUTY TO CARRY OUT THE
3 FUNCTIONS REQUIRED PURSUANT TO THIS SECTION. IF THE DATABASE
4 CEASES TO OPERATE, THE DATA SUBMITTED SHALL BE DESTROYED OR
5 RETURNED TO ITS ORIGINAL SOURCE."

6 Page 10, line 2, strike "(cc)," and substitute "(z),".

7 Page 10, strike line 7 and substitute:

8 "(z) July 1, 2013:".

9 Page 10, line 8, strike "(III)" and substitute "(VI)".
