Amend printed bill, strike everything below the enacting clause and
 substitute:

3 "SECTION 1. 24-75-201.1 (1), Colorado Revised Statutes, is
4 amended BY THE ADDITION OF A NEW PARAGRAPH to read:

5 24-75-201.1. Restriction on state appropriations - legislative 6 declaration - definitions. (1) (f) (I) ON JUNE 30, 2010, AND EACH JUNE 7 30 THEREAFTER, AT THE GOVERNOR'S DISCRETION THE STATE CONTROLLER 8 SHALL CALCULATE AN AMOUNT EQUAL TO THE EQUIVALENT OF THE TOTAL 9 GENERAL FUND MONEYS APPROPRIATED IN ALL BILLS PASSED BY THE 10 GENERAL ASSEMBLY DURING THE PREVIOUS LEGISLATIVE SESSION, OR ANY 11 PREVIOUS SPECIAL LEGISLATIVE SESSION DURING THAT STATE FISCAL 12 YEAR, THAT WERE VETOED BY THE GOVERNOR, INCLUDING AT THE GOVERNOR'S DISCRETION AN AMOUNT THAT THE CONTROLLER 13 14 CALCULATES TO BE THE EOUIVALENT OF ANY LINE ITEM APPROPRIATING 15 GENERAL FUND MONEYS IN THE ANNUAL GENERAL APPROPRIATION ACT 16 THAT IS LINE-ITEM VETOED BY THE GOVERNOR.

(II) ON JUNE 30, 2010, AND EACH JUNE 30 THEREAFTER, AT THE
GOVERNOR'S DISCRETION THE STATE CONTROLLER SHALL CALCULATE AN
AMOUNT EQUAL TO ANY GENERAL FUND SURPLUS IN EXCESS OF THE
AMOUNT OF THE UNRESTRICTED GENERAL FUND YEAR-END BALANCES
REQUIRED TO BE RETAINED AS A RESERVE AS SPECIFIED IN PARAGRAPH (d)
OF THIS SUBSECTION (1).

(III) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, 1 2 FOR THE STATE FISCAL YEAR COMMENCING JULY 1, 2012, AND EACH STATE 3 FISCAL YEAR THEREAFTER, THE AMOUNTS CALCULATED BY THE STATE 4 CONTROLLER AT THE GOVERNOR'S DISCRETION FOR THE PRIOR STATE 5 FISCAL YEAR AS SPECIFIED IN SUBPARAGRAPHS (I) AND (II) OF THIS 6 PARAGRAPH (f) SHALL BE ADDED TO THE AMOUNT OF THE UNRESTRICTED 7 GENERAL FUND YEAR-END BALANCES REQUIRED TO BE RETAINED AS A 8 RESERVE AS SPECIFIED IN PARAGRAPH (d) OF THIS SUBSECTION (1) FOR SUCH STATE FISCAL YEAR AND ALL FUTURE STATE FISCAL YEARS. 9
