After consideration on the merits, the Committee recommends the following:

HB10-1332 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, strike lines 5 through 8.
- 2 Renumber succeeding subsections accordingly.
- 3 Page 6, line 6, strike "(10)," and substitute "(9),".
- 4 Page 6, after line 17 insert:
 - 5 "(11) "NATIONAL INITIATIVE" MEANS A NATIONAL INITIATIVE BY
 - 6 THE AMERICAN SOCIETY FOR QUALITY OR ANOTHER NEUTRAL PARTY IN
 - 7 THE INDUSTRY THAT BRINGS TOGETHER DIVERSE STAKEHOLDERS TO
 - 8 CREATE A LEVEL OF UNDERSTANDING OF THE IMPACT OF CODING EDITS ON
 - 9 THE INDUSTRY AND A UNIFORM, STANDARDIZED SET OF CLAIMED EDITS THAT
 - 10 MEETS THE NEEDS OF THE STAKEHOLDERS IN THE INDUSTRY."
- 11 Renumber succeeding subsection accordingly.
- 12 Page 11, line 25, strike "ASQ" and substitute "NATIONAL".
- 13 Page 12, line 23, strike "ASQ" and substitute "NATIONAL".
- 14 Page 14, line 7, strike "ASQ" and substitute "NATIONAL".
- 15 Page 14, line 15, strike "NO LATER THAN".

1 Page 14, strike line 16 and substitute "ACCORDING TO A SCHEDULE
2 OUTLINED UNDER THE NATIONAL INITIATIVE OR BY JANUARY 1, 2014,
3 WHICHEVER OCCURS FIRST; AND".

4 Page 14, line 19, strike "DECEMBER".

5 Page 14, strike line 20 and substitute "JANUARY 1, 2015.".

6 Page 14, line 22, strike "ASQ" and substitute "NATIONAL".

7 Page 15, line 21, strike "NO LATER THAN DECEMBER".

8 Page 15, strike line 22 and substitute "ACCORDING TO A SCHEDULE
9 OUTLINED IN THE TASK FORCE RECOMMENDATIONS OR BY JANUARY 1,
10 2015, WHICHEVER OCCURS FIRST; AND".

11 Page 15, line 25, strike "DECEMBER".

12 Page 15, strike line 26 and substitute "JANUARY 1, 2016.".

13 Page 16, line 4, strike "SERVICES." and substitute "SERVICES; EXCEPT
14 THAT, IF NATIONAL STANDARDS ARE LATER IDENTIFIED FOR
15 STANDARDIZED PAYMENT RULES AND CLAIM EDITS, COLORADO PAYERS
16 SHALL COMPLY WITH THE NATIONAL STANDARDS WITHIN TWENTY-FOUR
17 MONTHS AFTER THOSE STANDARDS ARE PUBLISHED.".

18 Page 16, after line 22 insert:

19 "(5) THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING
20 IS AUTHORIZED TO SEEK AND ACCEPT GIFTS, GRANTS, OR DONATIONS FROM
21 PRIVATE OR PUBLIC SOURCES FOR THE PURPOSES OF THIS SECTION; EXCEPT
22 THAT THE DEPARTMENT SHALL NOT ACCEPT A GIFT, GRANT, OR DONATION
23 IF IT IS SUBJECT TO CONDITIONS THAT ARE INCONSISTENT WITH THIS
24 SECTION OR ANY OTHER LAW OF THE STATE. THE DEPARTMENT SHALL
25 TRANSMIT ALL PRIVATE AND PUBLIC MONEYS RECEIVED THROUGH GIFTS,
26 GRANTS, OR DONATIONS TO THE STATE TREASURER, WHO SHALL CREDIT
27 THE SAME TO THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING
28 CASH FUND CREATED PURSUANT TO SECTION 25.5-1-109, C.R.S.

29 (6) UNLESS THE DEPARTMENT OF HEALTH CARE POLICY AND

1 FINANCING RECEIVES SUFFICIENT MONEYS FROM GIFTS, GRANTS, AND
2 DONATIONS MADE PURSUANT TO SUBSECTION (5) OF THIS SECTION, THE
3 DEPARTMENT SHALL NOT BE REQUIRED TO IMPLEMENT THE REQUIREMENTS
4 OF THIS SECTION."
