Summary of Legislation

If a minor, under age 18, qualifies for his or her permit by taking the 30 hour driver's education course, he or she must complete the additional behind-the-wheel requirements to qualify for a driver's license. In certain cases, this behind-the-wheel requirement will be more stringent than is required of the person's peers (who received their permits under less rigorous requirements).

This bill, recommended by the Transportation Legislation Review Committee, eliminates any differences by making the age cut-off for the additional behind the wheel training 16 1/2. In all cases, a person receiving his or her license before age 18 must drive with a permit for 1 year and must have 50 hours of supervised driving under the permit. Table 1 summarizes current driver's permit and license requirements addressed by this bill.

State Expenditures

Reprogramming the current computer processes that make age calculations for driver's license personnel will increase state expenditures by **\$10,984 in FY 2010-11 only**. Costs are for 280 hours of programming (at \$39.23 per hour) to incorporate the bill's behind-the-wheel age requirements. No appropriation is necessary because of ongoing appropriations to the department for computer programming provided in the Long Bill for new legislation.

State Appropriations

Due to the ongoing appropriation in the Long Bill for new legislation computer programming costs in new legislation, this bill does not require an appropriation.
