After consideration on the merits, the Committee recommends the following:

HB10-1205 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 3, line 17, after "ACRES." add
2 "NOTWITHSTANDING ANY OTHER PROVISION OF THIS SUBSECTION (9.5),
3 "MILITARY INSTALLATION" INCLUDES BUCKLEY AIR FORCE BASE,
4 CHEYENNE MOUNTAIN AIR FORCE STATION, FORT CARSON ARMY POST,
5 GREELEY AIR NATIONAL GUARD STATION, PETERSON AIR FORCE BASE,
6 SCHRIEVER AIR FORCE BASE, AND THE UNITED STATES AIR FORCE
7 ACADEMY."

8 Page 4, line 13, after "~~projects~~:" add "NOTWITHSTANDING ANY OTHER
9 PROVISION OF THIS PARAGRAPH (b), "MILITARY INSTALLATION" INCLUDES
10 BUCKLEY AIR FORCE BASE, CHEYENNE MOUNTAIN AIR FORCE STATION,
11 FORT CARSON ARMY POST, GREELEY AIR NATIONAL GUARD STATION,
12 PETERSON AIR FORCE BASE, SCHRIEVER AIR FORCE BASE, AND THE
13 UNITED STATES AIR FORCE ACADEMY."

14 Page 4, strike lines 14 through 22 and substitute:

15 "(3) EACH COUNTY OR MUNICIPAL MASTER PLAN REQUIRED BY
16 SECTION 30-28-106 OR 31-23-206, C.R.S., RESPECTIVELY, SHALL PROVIDE
17 THE RECOMMENDATIONS OF THE COUNTY OR MUNICIPALITY, AS
18 APPLICABLE, FOR DEVELOPMENT THAT IT DEEMS COMPATIBLE WITH ANY
19 OFF-SITE NOISE IMPACTS OF MILITARY INSTALLATIONS. IN MAKING ITS
20 RECOMMENDATIONS, THE COUNTY OR MUNICIPALITY SHALL CONSIDER,
21 AMONG OTHER DATA, ANY OFF-SITE NOISE IDENTIFIED IN ANY

1 ENVIRONMENTAL ASSESSMENTS OR ENVIRONMENTAL IMPACT STATEMENTS
2 PREPARED FOR AND ACCEPTED BY THE UNITED STATES DEPARTMENT OF
3 DEFENSE CONTEMPORANEOUS WITH THE PLACEMENT OF MILITARY
4 ACTIVITIES ON THE STATE'S MILITARY INSTALLATIONS. FOR GUIDANCE ON
5 LAND USES COMPATIBLE WITH NOISE GENERATED BY OVERFLIGHT OF
6 MILITARY AIRCRAFT, THE COUNTY OR MUNICIPALITY MAY REFER TO
7 UNITED STATES DEPARTMENT OF DEFENSE INSTRUCTION 4165.57."

8 Page 5, strike lines 5 through 8 and substitute "~~within~~ two miles of the
9 military installation. Nothing in this subsection (~~3~~) (4) is intended to
10 require submission of any information in connection with a site-specific
11 development application under consideration by the local government."

12 Page 5, line 12, strike "SIXTY" and substitute "FOURTEEN BUSINESS"
