"(c) WRITTEN MINUTES SHALL BE MADE OF ALL MEETINGS OF THE BOARD OF DIRECTORS AND SHALL BE POSTED ON THE WEB SITE OF THE ASSOCIATION AS SOON AS THEY HAVE BEEN APPROVED. UPON REQUEST BY A MEMBER OF THE BOARD, THAT MEMBER'S OWN VOTE ON ANY ISSUE SHALL BE NOTED IN THE MINUTES.".
Page 3, strike lines 17 and 18 and substitute "ASSOCIATION'S WEB SITE. THE ELECTION POLICY SHALL".
Page 4, line 2, strike "AND MAILING".
Page 4, line 6, strike "SIX MONTHS BEFORE THE ELECTION AND AGAIN".
Page 4, line 12, after "ANY" insert "MANAGEMENT-LEVEL".
Page 4, line 13, strike "IS HIRED BY" and substitute "REPORTS DIRECTLY TO".
Page 5, line 7, strike "ELECTRONIC FILES OF".
Page 5, line 10, after the period add "CANDIDATES SHALL USE SUCH LISTS

THEM IMMEDIATELY AFTER THE ELECTION.".

- 16 TABULATION.".

- Page 7, line 7, strike "(a)" and strike "AND LOCATION" and substitute
- 19 "LOCATION, AND AGENDA".
- Page 7, line 9, strike "FOURTEEN" and substitute "TEN".
- 21 Page 7, strike lines 14 through 23.
