HB10-1220 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

3 Page 4, strike line 5 and substitute "**repeal of functions.**
4 (6) (b) (I) (A) The functions of the division of insurance related to the
5 licensing of bail bonding agents are repealed, effective July 1, ~~2013~~ 2012,
6 pursuant to the provisions of this section and section 12-7-112, C.R.S.

7 (B.5) ~~The functions of the division of~~.

8 Page 5, after line 1 insert:

9 "SECTION 2. 12-7-112, Colorado Revised Statutes, is amended
10 to read:

11 **12-7-112. Repeal - review of functions.** This article is repealed,
12 effective July 1, ~~2013~~ 2012. Prior to such repeal, the licensing functions
13 of the commissioner and the division shall be reviewed as provided for in
14 section 24-34-104, C.R.S.

15 **SECTION 3.** 24-34-104 (43), Colorado Revised Statutes, is
16 amended BY THE ADDITION OF A NEW PARAGRAPH to read:

17 **24-34-104. General assembly review of regulatory agencies**
18 **and functions for termination, continuation, or reestablishment.**

1 (43) The following agencies, functions, or both, shall terminate on July
2 1, 2012:

3 (f) THE LICENSING OF BAIL BONDING AGENTS THROUGH THE
4 DIVISION OF INSURANCE IN ACCORDANCE WITH ARTICLE 7 OF TITLE 12,
5 C.R.S."
