After consideration on the merits, the Committee recommends the following:
HB10-1238 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:
Amend printed bill, page 3, line 1, strike "zones - report" and substitute "zones - cash fund - report - repeal.".
Page 4, line 13, strike "THE FOLLOWING FACTORS:" and substitute "FACTORS INCLUDING, BUT NOT LIMITED TO, THE FOLLOWING:".
Page 4, after line 21 insert:
"(6) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE REQUIRES, "WILDLIFE" SHALL HAVE THE SAME MEANING AS "BIG GAME" AS SET FORTH IN SECTION 33-1-102 (2), C.R.S.".
(7) (a) There is hereby created in the state treasury the wildlife crossing zones cash fund, referred to in this section as the "fund". The fund shall consist of moneys transferred to the fund pursuant to section 42-4-1701 (4) (d) (II). The moneys in the fund shall be continuously appropriated by the general assembly to the department of transportation for the direct and indirect costs associated with:
(I) PLACEMENT OF SIGNS IDENTIFYING WILDLIFE CROSSING ZONES AND ESTABLISHING A LOWER SPEED LIMIT FOR THE PORTION OF THE HIGHWAY THAT LIES WITHIN EACH ZONE;

- 1 (II) CONSTRUCTION, RECONSTRUCTION, REPAIRS, IMPROVEMENT,
- 2 PLANNING, SUPERVISION, AND MAINTENANCE OF THE PORTIONS OF THE
- 3 PUBLIC HIGHWAYS OF THE STATE THAT HAVE BEEN ESTABLISHED AS
- 4 WILDLIFE CROSSING ZONES PURSUANT TO SUBSECTION (1) OF THIS

- 10 SUBPARAGRAPHS (I) OR (II) OF THIS PARAGRAPH (a).
- 11 (b) THE DEPARTMENT OF TRANSPORTATION IS AUTHORIZED TO
- 12 EXPEND MONEYS IN THE FUND FOR THE PURPOSES DESCRIBED IN
- 13 PARAGRAPH (a) OF THIS SUBSECTION (7).
- 14 (c) ANY MONEYS IN THE FUND NOT EXPENDED FOR THE PURPOSES
- 15 DESCRIBED IN PARAGRAPH (a) OF THIS SUBSECTION (7) MAY BE INVESTED
- 16 BY THE STATE TREASURER AS PROVIDED BY LAW. ALL INTEREST AND
- 17 INCOME DERIVED FROM THE INVESTMENT AND DEPOSIT OF MONEYS IN THE
- 18 FUND SHALL BE CREDITED TO THE FUND. ANY UNEXPENDED AND
- 19 UNENCUMBERED MONEYS REMAINING IN THE FUND AT THE END OF A
- 20 FISCAL YEAR SHALL REMAIN IN THE FUND AND SHALL NOT BE CREDITED OR
- 21 TRANSFERRED TO THE GENERAL FUND OR ANOTHER FUND.".

- 20 "(II) FOR EACH PENALTY AND SURCHARGE THAT THE DEPARTMENT
- 21 OF TRANSPORTATION IMPOSES FOR A MOVING TRAFFIC VIOLATION THAT
- 22 OCCURS WITHIN A WILDLIFE CROSSING ZONE PURSUANT TO SECTION
- 42-4-616, THE DEPARTMENT SHALL TRANSMIT ONE HALF OF THE AMOUNT
- 24 COLLECTED TO THE STATE TREASURER, WHO SHALL CREDIT THE SAME TO
- 25 THE WILDLIFE CROSSING ZONES CASH FUND CREATED IN SECTION
- 26 42-4-118.".
