After consideration on the merits, the Committee recommends the following:

HB10-1106 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, strike line 3 and substitute "is amended, and
2 the said 26-6-107 (1) (a) (I) is further amended BY THE ADDITION OF
3 A NEW SUB-SUBPARAGRAPH, to read:".

4 Page 3, strike lines 3 through 10 and substitute "identified in
5 sub-subparagraph (B) OR (C.5) of this subparagraph (I), to include a
6 fingerprint-based criminal history records check through the Colorado
7 bureau of investigation. ~~except for persons residing in this state less than~~
8 ~~two years, who shall be required to have a federal bureau of investigation~~
9 ~~fingerprint-based criminal history records check through the Colorado~~
10 ~~bureau of investigation.~~ As part of said investigation, the records and
11 reports of".

12 Page 3, after line 20 insert:

13 "(C.5) FOR PERSONS RESIDING IN THIS STATE LESS THAN TWO
14 YEARS, SPECIALIZED GROUP HOME PARENTS, OR ANY PERSON WORKING IN
15 A TWENTY-FOUR-HOUR CHILD CARE FACILITY, THE RULES PROMULGATED
16 BY THE STATE BOARD PURSUANT TO THIS SUBPARAGRAPH (I) SHALL
17 REQUIRE, IN ADDITION TO THE FINGERPRINT-BASED CRIMINAL HISTORY
18 RECORDS CHECK THROUGH THE COLORADO BUREAU OF INVESTIGATION
19 DESCRIBED IN SUB-SUBPARAGRAPH (C) OF THIS SUBPARAGRAPH (I), A
20 FEDERAL BUREAU OF INVESTIGATION FINGERPRINT-BASED CRIMINAL
21 HISTORY RECORDS CHECK THROUGH THE COLORADO BUREAU OF

1 INVESTIGATION."

2 Page 4, strike lines 17 through 23 and substitute "~~of the child~~".

3 Page 5, line 4, after "SHALL" insert "USE GOOD FAITH EFFORTS AND DUE
4 DILIGENCE TO".

5 Page 6, strike line 14 and substitute:

6 "SECTION 3. The introductory portion to 19-5-104 (1) and
7 19-5-104 (1) (d), Colorado Revised Statutes, are".

8 Page 6, line 18, strike "court, after taking into account the racial,
9 cultural,".

10 Page 6, line 19, strike "and religious background of the child," and
11 substitute "court ~~after taking into account the racial, cultural, and~~
12 ~~religious background of the child,~~".
