After consideration on the merits, the Committee recommends the following:

HB10-1030 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, line 2, after "SHALL" insert "COLLABORATE
- 2 WITH THE DEPARTMENT OF HUMAN SERVICES, THE COLORADO COMMUNITY
- 3 COLLEGE SYSTEM, AND THE OFFICE OF INFORMATION TECHNOLOGY, TO".
  
- 4 Page 3, line 24, strike "HIGH-QUALITY" and substitute "REGIONALLY
- 5 ACCREDITED".
  
- 6 Page 4, line 17, strike "SEEK AND ACCEPT" and substitute "SEEK, ACCEPT,
- 7 AND EXPEND".
  
- 8 Page 5, line 7, strike "ONE" and substitute "EIGHT".
  
- 9 Page 5, line 8, strike "ANNUALLY" and substitute "CONTINUOUSLY".
  
- 10 Page 5, after line 9 insert:
  
- 11 **"22-9.7-104. Repeal of part.** (1) (a) ON OR BEFORE JULY 1, 2011,
- 12 OR JULY 1 OF ANY YEAR THEREAFTER, THE EXECUTIVE DIRECTOR OF THE
- 13 DEPARTMENT SHALL NOTIFY THE REVISOR OF STATUTES IN WRITING IF
- 14 FEDERAL MONEYS ARE NOT RECEIVED AND ALLOCATED TO THE
- 15 DEPARTMENT OR IF GIFTS, GRANTS, AND DONATIONS ARE NOT RECEIVED BY
- 16 THE DEPARTMENT TO PROVIDE FOR THE AWARD OF GRANTS PURSUANT TO
- 17 THIS ARTICLE.

1           (b) IF THE REVISOR OF STATUTES DOES NOT RECEIVE NOTICE  
2 PURSUANT TO PARAGRAPH (a) OF THIS SUBSECTION (1), ON JULY 1, 2011,  
3 OR ON JULY 1 OF ANY YEAR THEREAFTER, THE EXECUTIVE DIRECTOR OF  
4 THE DEPARTMENT SHALL NOTIFY THE REVISOR OF STATUTES IN WRITING  
5 IF FEDERAL MONEYS OR GIFTS, GRANTS, OR DONATIONS ARE NOT  
6 AVAILABLE TO CONTINUE TO PROVIDE FOR THE AWARD OF GRANTS  
7 PURSUANT TO THIS ARTICLE.

8           (2) THIS ARTICLE IS REPEALED, EFFECTIVE THE JULY 1 FOLLOWING  
9 THE RECEIPT OF THE NOTICE BY THE REVISOR OF STATUTES PURSUANT TO  
10 PARAGRAPH (a) OR (b) OF SUBSECTION (1) OF THIS SECTION."
