Amend printed bill, page 2, line 5, strike "penalty." and substitute
 "penalty - definitions.".

- 3 Page 2, strike lines 7 through 24 and substitute:



TRANSACTION" INCLUDES, BUT IS NOT LIMITED TO, INITIATING,
CONCLUDING, OR PARTICIPATING IN THE INITIATION OR CONCLUSION OF A
TRANSACTION.

29 (b) "FINANCIAL TRANSACTION" MEANS A TRANSACTION

- 7 (c) "MONETARY INSTRUMENT" MEANS:

8 (I) COIN OR CURRENCY OF THE UNITED STATES OR ANY OTHER
9 COUNTRY; A TRAVELER'S CHECK; A PERSONAL CHECK; A BANK CHECK; A
10 CASHIER'S CHECK; A MONEY ORDER; A BANK DRAFT OF ANY COUNTRY; OR
11 GOLD, SILVER, OR PLATINUM BULLION OR COINS;

(II) AN INVESTMENT SECURITY OR NEGOTIABLE INSTRUMENT IN
BEARER FORM OR IN OTHER FORM SUCH THAT TITLE PASSES UPON
DELIVERY; OR

(III) A GIFT CARD OR OTHER DEVICE THAT IS THE EQUIVALENT OF
 MONEY AND CAN BE USED TO OBTAIN CASH, PROPERTY, OR SERVICES.

17 (d) "REPRESENT" INCLUDES, BUT IS NOT LIMITED TO, THE MAKING
18 OF A REPRESENTATION BY A PEACE OFFICER, A FEDERAL OFFICER, OR
19 ANOTHER PERSON ACTING AT THE DIRECTION OF, OR WITH THE APPROVAL
20 OF, A PEACE OFFICER OR FEDERAL OFFICER.

21 (e) "TRANSACTION" INCLUDES A PURCHASE, SALE, LOAN, PLEDGE, 22 GIFT, TRANSFER, DELIVERY, OR OTHER DISPOSITION AND, WITH RESPECT TO 23 A FINANCIAL INSTITUTIONS, INCLUDES A DEPOSIT; A WITHDRAWAL; A 24 TRANSFER BETWEEN ACCOUNTS; AN EXCHANGE OF CURRENCY; A LOAN; AN 25 EXTENSION OF CREDIT; A PURCHASE OR SALE OF ANY STOCK, BOND, 26 CERTIFICATE OF DEPOSIT, OR OTHER MONETARY INSTRUMENT; THE USE OF 27 A SAFE DEPOSIT BOX; OR ANY OTHER PAYMENT, TRANSFER, OR DELIVERY 28 BY, THROUGH, OR TO A FINANCIAL INSTITUTION BY WHATEVER MEANS.".
