A BILL FOR AN ACT

101 **CONCERNING AUTHORIZATION TO PLACE VOLUNTARILY AN IDENTIFIER**
102 **OF A BRANCH OF THE UNITED STATES ARMED FORCES ON**
103 **CERTAIN IDENTIFICATION DOCUMENTS ISSUED BY THE**
104 **DEPARTMENT OF REVENUE, AND MAKING AN APPROPRIATION**
105 **THEREFOR.**

The fee for voluntarily having an armed service identifier on a driver's license or identification card is \$15, a portion of which is used to offset the cost of including armed service identifiers on driver's licenses and identification cards, and the remainder is transmitted to the highway users tax fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 42-2-114, Colorado Revised Statutes, is amended
3 **BY THE ADDITION OF A NEW SUBSECTION** to read:

4 **42-2-114. License issued - fees - repeal.** (10) (a) AT THE
5 APPLICANT'S VOLUNTARY REQUEST, THE DEPARTMENT SHALL ISSUE A
6 DRIVER'S LICENSE BEARING AN IDENTIFIER OF A BRANCH OF THE UNITED
7 STATES ARMED FORCES, SUCH AS "MARINE CORPS", "NAVY", "ARMY",
8 "AIR FORCE", OR "COAST GUARD", IF THE APPLICANT POSSESSES A
9 CURRENTLY VALID MILITARY IDENTIFICATION DOCUMENT, A DD214 FORM
10 ISSUED BY THE UNITED STATES GOVERNMENT, OR ANY OTHER DOCUMENT
11 ACCEPTED BY THE DEPARTMENT THAT DEMONSTRATES THAT THE
12 APPLICANT IS AN ACTIVE MEMBER OR A VETERAN OF THE BRANCH OF
13 SERVICE THAT THE APPLICANT HAS REQUESTED BE PLACED ON THE
14 DRIVER'S LICENSE. THE APPLICANT SHALL NOT BE REQUIRED TO PROVIDE
15 DOCUMENTATION THAT THE APPLICANT IS AN ACTIVE MEMBER OR A
16 VETERAN OF A BRANCH OF THE UNITED STATES ARMED FORCES TO RENEW
17 OR BE REISSUED A DRIVER'S LICENSE BEARING AN IDENTIFIER ISSUED
18 PURSUANT TO THIS SUBSECTION (10). THE DEPARTMENT SHALL NOT PLACE
19 MORE THAN ONE BRANCH OF THE UNITED STATES ARMED FORCES
20 IDENTIFIER ON AN APPLICANT'S DRIVER'S LICENSE.

21 (b) (I) TO BE ISSUED A DRIVER'S LICENSE BEARING A BRANCH OF
22 SERVICE IDENTIFIER, OR TO HAVE SUCH LICENSE RENEWED, THE APPLICANT

1 SHALL PAY A FEE OF FIFTEEN DOLLARS TO THE DEPARTMENT, WHICH SHALL
2 BE IN ADDITION TO ANY OTHER FEE FOR A DRIVER'S LICENSE. THE
3 DEPARTMENT SHALL TRANSFER THE FEE TO THE STATE TREASURER, WHO
4 SHALL CREDIT THE FEE TO THE HIGHWAY USERS TAX FUND, EXCEPT AS
5 PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH (b).

6 (II) (A) THE DEPARTMENT MAY RETAIN UP TO NINETY-EIGHT
7 THOUSAND FIVE HUNDRED THIRTY-EIGHT DOLLARS OF THE FEES
8 COLLECTED PURSUANT TO SUBPARAGRAPH (I) OF THIS PARAGRAPH (b) AS
9 NECESSARY TO OFFSET THE DIRECT AND INDIRECT COST OF IMPLEMENTING
10 THIS SUBSECTION (10).

11 (B) THIS SUBPARAGRAPH (II) IS REPEALED EFFECTIVE JULY 1,
12 2012.

13 (c) (I) THIS SUBSECTION (10) IS EFFECTIVE JANUARY 1, 2011.

14 (II) THIS PARAGRAPH (c) IS REPEALED, EFFECTIVE JULY 1, 2011.

15 **SECTION 2.** 42-2-303, Colorado Revised Statutes, is amended
16 BY THE ADDITION OF A NEW SUBSECTION to read:

17 **42-2-303. Contents of identification card.** (4) (a) AT THE
18 APPLICANT'S VOLUNTARY REQUEST, THE DEPARTMENT SHALL ISSUE AN
19 IDENTIFICATION CARD BEARING AN IDENTIFIER OF A BRANCH OF THE
20 UNITED STATES ARMED FORCES, SUCH AS "MARINE CORPS", "NAVY",
21 "ARMY", "AIR FORCE", OR "COAST GUARD", IF THE APPLICANT POSSESSES
22 A CURRENTLY VALID MILITARY IDENTIFICATION DOCUMENT, A DD214
23 FORM ISSUED BY THE UNITED STATES GOVERNMENT, OR ANY OTHER
24 DOCUMENT ACCEPTED BY THE DEPARTMENT THAT DEMONSTRATES THAT
25 THE APPLICANT IS AN ACTIVE MEMBER OR A VETERAN OF THE BRANCH OF
26 SERVICE THAT THE APPLICANT HAS REQUESTED BE PLACED ON THE
27 IDENTIFICATION CARD. THE APPLICANT SHALL NOT BE REQUIRED TO

1 PROVIDE DOCUMENTATION THAT THE APPLICANT IS AN ACTIVE MEMBER OR
2 A VETERAN OF A BRANCH OF THE UNITED STATES ARMED FORCES TO
3 RENEW OR BE REISSUED AN IDENTIFICATION CARD BEARING AN IDENTIFIER
4 ISSUED PURSUANT TO THIS SUBSECTION (4). THE DEPARTMENT SHALL NOT
5 PLACE MORE THAN ONE BRANCH OF THE UNITED STATES ARMED FORCES
6 IDENTIFIER ON AN APPLICANT'S IDENTIFICATION CARD.

7 (b) TO BE ISSUED AN IDENTIFICATION CARD BEARING A BRANCH OF
8 SERVICE IDENTIFIER, OR TO HAVE SUCH LICENSE RENEWED, THE APPLICANT
9 SHALL PAY A FEE OF FIFTEEN DOLLARS TO THE DEPARTMENT, WHICH SHALL
10 BE IN ADDITION TO ANY OTHER FEE FOR AN IDENTIFICATION CARD. THE
11 DEPARTMENT SHALL TRANSFER THE FEE TO THE STATE TREASURER, WHO
12 SHALL CREDIT THE FEE TO THE HIGHWAY USERS TAX FUND.

13 (c) (I) THIS SUBSECTION (4) IS EFFECTIVE JANUARY 1, 2011.

14 (II) THIS PARAGRAPH (c) IS REPEALED, EFFECTIVE JULY 1, 2011.

15 **SECTION 3. Appropriation.** In addition to any other
16 appropriation, there is hereby appropriated, out of any moneys in the
17 highway user tax fund created in section 43-4-201 (1) (a), Colorado
18 Revised Statutes, not otherwise appropriated, to the department of
19 revenue, for allocation to the division of motor vehicles, driver and
20 vehicle services, for the fiscal year beginning July 1, 2010, the sum of
21 eighty-three thousand eighty-eight dollars (\$83,088) cash funds, or so
22 much thereof as may be necessary, for the implementation of this act.

23 **SECTION 4. Specified effective date - applicability.** This act
24 shall take effect July 1, 2010, and shall apply to driver's licenses and
25 identification cards issued on or after said date.

26 **SECTION 5. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
