Interim Committee on the Developmental Disability Waiting List. The bill directs the department of health care policy and financing to negotiate agreements with suppliers of high-quality durable medical equipment and medical supplies so that persons receiving public medical benefits or who are on a waiting list for the benefits can purchase high-quality equipment and supplies at the lowest cost.

5 **25.5-1-126.** Discounted prices for durable medical equipment 6 and supplies. (1) THE STATE DEPARTMENT SHALL WORK WITH ONE OR 7 MORE NONPROFIT ORGANIZATIONS TO DEVELOP A LINK OF APPROVED 8 VENDORS WHO ARE WILLING TO SELL DURABLE MEDICAL EQUIPMENT AND 9 MEDICAL SUPPLIES AT DISCOUNTED PRICES TO PERSONS WHO HAVE 10 APPLIED FOR, BUT ARE NOT YET RECEIVING, BENEFITS UNDER THE 11 "COLORADO MEDICAL ASSISTANCE ACT". THE STATE DEPARTMENT 12 SHALL PROVIDE THE EXCLUSIVE CRITERIA FOR A NONPROFIT 13 ORGANIZATION TO USE TO APPROVE A VENDOR FOR PLACEMENT ON THE 14 APPROVED VENDOR LIST. BY SUBMITTING A LIST TO THE STATE 15 DEPARTMENT, A NONPROFIT ORGANIZATION SHALL CERTIFY THAT IT HAS 16 NOT ADDED ADDITIONAL CRITERIA FOR INCLUSION ON THE LIST AND HAS 17 NOT DISCRIMINATED AGAINST ANY VENDOR.
