A BILL FOR AN ACT

101 **CONCERNING THE REQUIREMENT THAT A HEALTH CARE FACILITY**
102 **REPORT INFORMATION IDENTIFYING ANY INDIVIDUAL**
103 **RESPONSIBLE FOR THE DIVERSION OF INJECTABLE DRUGS THAT**
104 **WERE INTENDED FOR USE BY PATIENTS OF THE FACILITY.**

occurrences at the facility in which drugs that are intended for use by patients or residents of the facility are diverted to use by other persons. The bill would further require a facility, when reporting such occurrences involving injectable drugs, to also report the name and date of birth of the individual responsible for the diversion of the injectable drugs.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** The introductory portion to 25-1-124 (2) and
3 25-1-124 (2) (g), Colorado Revised Statutes, are amended to read:

4 **25-1-124. Health care facilities - consumer information -**
5 **reporting - release.** (2) Each health care facility licensed pursuant to
6 section 25-3-101 or certified pursuant to section 25-1.5-103 (1) (a) (II)
7 shall report to the department ALL OF the following occurrences:

8 (g) Any occurrence in which drugs intended for use by patients or
9 residents are diverted to use by other persons. ~~and~~ IF THE DIVERTED
10 DRUGS ARE INJECTABLE, THE HEALTHCARE FACILITY SHALL ALSO REPORT
11 THE FULL NAME AND DATE OF BIRTH OF ANY INDIVIDUAL [REDACTED] WHO
12 [REDACTED] THE INJECTABLE DRUGS, IF KNOWN.

13 **SECTION 2. Safety clause.** The general assembly hereby finds,
14 determines, and declares that this act is necessary for the immediate
15 preservation of the public peace, health, and safety.
