**Bill Summary**

The bill clarifies that the central registry of protection orders shall contain information on the amount of bail and conditions of bond in any case in which the court has entered a protection order and the highest classified crime charged in the case, if any.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** 18-6-803.7 (3) (a), Colorado Revised Statutes, is  
3 amended **BY THE ADDITION OF A NEW SUBPARAGRAPH** to read:

4           **18-6-803.7. Central registry of protection orders - creation.**

5 (3) (a) In addition to any information, notice, or warning required by law,  
6 a protection order or subsequent order entered into the registry shall  
7 contain the following information, if such information is available:

8           **(VIII) AN INDICATION WHETHER THE CONDITIONS OF THE**  
9 **PROTECTION ORDER ARE ALSO CONDITIONS OF A BAIL BOND FOR A FELONY**  
10 **CHARGE.**

11           **SECTION 2. Safety clause.** The general assembly hereby finds,  
12 determines, and declares that this act is necessary for the immediate  
13 preservation of the public peace, health, and safety.
