1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Repeal.** 27-10.5-102 (26), Colorado Revised  
3 Statutes, is repealed as follows:

4 **27-10.5-102. Definitions.** As used in this article, unless the  
5 context otherwise requires:

6 (26) ~~"Referral and placement committee" means an~~  
7 ~~interdisciplinary or interagency committee authorized by a community~~  
8 ~~centered board or the department to make referral and placement~~  
9 ~~recommendations for persons receiving services.~~

10 **SECTION 2.** 27-10.5-103 (2) (e), Colorado Revised Statutes, is  
11 amended to read:

12 **27-10.5-103. Duties of the executive director - rules.** (2) The  
13 department shall adopt such rules, in accordance with section 24-4-103,  
14 C.R.S., as are necessary to carry out the provisions and purposes of this  
15 article, including but not limited to the following subjects:

16 (e) Eligibility determination, ~~and the criteria for determination,~~  
17 ~~AND admission to programs, and the functions of the referral and~~  
18 ~~placement committees~~ THE PROGRAM;

19 **SECTION 3. Repeal.** 27-10.5-105 (2) (f), Colorado Revised  
20 Statutes, is repealed as follows:

23 (2) Once a community centered board has been designated pursuant to
