**A BILL FOR AN ACT**

101 **CONCERNING THE CREATION OF THE RANGE WORKER ADVISORY**  
102 **COUNCIL, AND MAKING AN APPROPRIATION THEREFOR.**

**Bill Summary**

The bill creates the range worker advisory council, which is required to meet at least 4 times to study and discuss issues concerning range workers in Colorado who are working under the federal H-2A visa program, including the employment and living conditions of the range workers. The bill requires the advisory council to report

recommendations, including any legislation deemed necessary, to committees of reference of the general assembly. The bill also creates a cash fund for gifts, grants, and donations to cover the costs associated with the advisory council.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** Title 8, Colorado Revised Statutes, is amended BY  
3 THE ADDITION OF A NEW ARTICLE to read:

4                           **ARTICLE 3.7**

5                           **Range Workers**

6           **8-3.7-101. Range worker advisory council established -**  
7 **members - cash fund - report to general assembly - repeal.** (1) THERE  
8 IS HEREBY ESTABLISHED THE RANGE WORKER ADVISORY COUNCIL. THE  
9 ADVISORY COUNCIL SHALL CONSIST OF ELEVEN MEMBERS AS FOLLOWS:

10           (a) THE COMMISSIONER OF THE DEPARTMENT OF AGRICULTURE OR  
11 HIS OR HER DESIGNEE;

12           (b) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF LABOR AND  
13 EMPLOYMENT OR HIS OR HER DESIGNEE;

14           (c) THE CHAIRS OF THE HOUSE BUSINESS AFFAIRS AND LABOR  
15 COMMITTEE AND THE SENATE BUSINESS, LABOR, AND TECHNOLOGY  
16 COMMITTEE, OR THEIR SUCCESSOR COMMITTEES;

17           (d) THE CHAIRS OF THE HOUSE AGRICULTURE, LIVESTOCK, AND  
18 NATURAL RESOURCES COMMITTEE AND THE SENATE AGRICULTURE AND  
19 NATURAL RESOURCES COMMITTEE, OR THEIR SUCCESSOR COMMITTEES;

20 AND

21           (e) FOUR APPOINTEES OF THE GOVERNOR, AS FOLLOWS:

22           (I) A PERSON WHO HAS EXPERIENCE IN IMMIGRATION SERVICES;

23           (II) A PERSON OF FAITH;

1 (III) TWO REPRESENTATIVES OF THE AGRICULTURE INDUSTRY WHO  
2 EMPLOY OR HAVE EMPLOYED A RANGE WORKER IN COLORADO WHO  
3 WORKS OR WORKED UNDER THE FEDERAL H-2A VISA PROGRAM; AND

4 (IV) A REPRESENTATIVE OF A MIGRANT WORKER ADVOCACY  
5 GROUP.

6 (2) IF THREE THOUSAND EIGHT HUNDRED SEVENTY-TWO DOLLARS  
7 IS RECEIVED THROUGH GIFTS, GRANTS, AND DONATIONS TO PAY FOR THE  
8 COSTS ASSOCIATED WITH THE ADVISORY COUNCIL ON OR BEFORE AUGUST  
9 1, 2010, THE RANGE WORKER ADVISORY COUNCIL SHALL MEET AT LEAST  
10 TWO AND UP TO FOUR TIMES TO STUDY AND DISCUSS ISSUES CONCERNING  
11 RANGE WORKERS IN COLORADO WHO ARE WORKING UNDER THE FEDERAL  
12 H-2A VISA PROGRAM. AT LEAST HALF OF THE MEETINGS SHALL BE ON THE  
13 WESTERN SLOPE IN A LOCATION THAT IS CONVENIENT TO THE  
14 REPRESENTATIVES OF THE AGRICULTURE INDUSTRY WHO EMPLOY OR HAVE  
15 EMPLOYED RANGE WORKERS. IF ENOUGH MONEYS ARE NOT RECEIVED, THE  
16 RANGE WORKER ADVISORY COUNCIL SHALL BE DISSOLVED AND RELIEVED  
17 OF ITS DUTIES PURSUANT TO THIS SECTION. IF THE ADVISORY COUNCIL  
18 DETERMINES THAT ENOUGH GIFTS, GRANTS, AND DONATIONS ARE  
19 RECEIVED, THE ADVISORY COMMITTEE MAY CONTRACT WITH A PRIVATE  
20 ENTITY TO FACILITATE THE MEETINGS.

21 (3) MEMBERS OF THE ADVISORY COUNCIL ARE ENTITLED TO  
22 REIMBURSEMENT FOR ACTUAL AND NECESSARY EXPENSES INCURRED IN  
23 THE PERFORMANCE OF THEIR DUTIES TO THE EXTENT THAT MONEYS ARE  
24 AVAILABLE THROUGH GIFTS, GRANTS, AND DONATIONS TRANSFERRED TO  
25 THE RANGE WORKER ADVISORY COUNCIL CASH FUND ESTABLISHED IN  
26 SUBSECTION (5) OF THIS SECTION.

27 (4) ON OR BEFORE FEBRUARY 1, 2011, THE RANGE WORKER

1 ADVISORY COUNCIL SHALL SUBMIT A REPORT TO THE SENATE BUSINESS,  
2 LABOR, AND TECHNOLOGY COMMITTEE; THE SENATE AGRICULTURE AND  
3 NATURAL RESOURCES COMMITTEE; THE HOUSE BUSINESS AFFAIRS AND  
4 LABOR COMMITTEE; AND THE HOUSE AGRICULTURE, LIVESTOCK, AND  
5 NATURAL RESOURCES COMMITTEE OF THE GENERAL ASSEMBLY, OR THEIR  
6 SUCCESSOR COMMITTEES, REGARDING THE FINDINGS OF THE RANGE  
7 WORKER ADVISORY COUNCIL AND ANY PROPOSED LEGISLATION DEEMED  
8 NECESSARY BY THE ADVISORY COUNCIL.

9 (5) THERE IS HEREBY ESTABLISHED THE RANGE WORKER ADVISORY  
10 COUNCIL CASH FUND IN THE STATE TREASURY, REFERRED TO IN THIS  
11 SECTION AS THE "FUND". MONEYS IN THE FUND SHALL CONSIST OF ANY  
12 GIFTS, GRANTS, OR DONATIONS COLLECTED PURSUANT TO THIS SECTION.  
13 THE MONEYS IN THE FUND SHALL BE CONTINUOUSLY APPROPRIATED TO  
14 THE DEPARTMENT OF LABOR AND EMPLOYMENT FOR THE ADMINISTRATIVE  
15 COSTS ASSOCIATED WITH THE RANGE WORKER ADVISORY COUNCIL. ANY  
16 MONEYS REMAINING IN THE FUND AT THE END OF ANY FISCAL YEAR SHALL  
17 REMAIN IN THE FUND AND SHALL NOT REVERT TO THE GENERAL FUND OR  
18 ANY OTHER FUND.

19 (6) THIS ARTICLE IS REPEALED, EFFECTIVE UPON WRITTEN  
20 NOTIFICATION TO THE REVISOR OF STATUTES BY THE ADVISORY  
21 COMMITTEE THAT THE REPORT REQUIRED PURSUANT TO SUBSECTION (4)  
22 OF THIS SECTION HAS BEEN SUBMITTED TO THE GENERAL ASSEMBLY.

23 **SECTION 2. Appropriation.** In addition to any other  
24 appropriation, there is hereby appropriated, out of any moneys in the  
25 range worker advisory council cash fund created in section 8-3.7-101 (5),  
26 Colorado Revised Statutes, not otherwise appropriated, to the department  
27 of labor and employment, for the fiscal year beginning July 1, 2010, the

1 sum of three thousand eight hundred seventy-two dollars (\$3,872) cash  
2 funds, or so much thereof as may be necessary, for the implementation of  
3 this act.

4 **SECTION 3. Safety clause.** The general assembly hereby finds,  
5 determines, and declares that this act is necessary for the immediate  
6 preservation of the public peace, health, and safety.
